Harold, Jr., declare as follows: 15 1. I am a Respondent in this action and a beneficiary of the Sharon M. 16 Harold Irrevocable Trust dated November 12, 2004 (the "Trust"). I am Grantor's son 17 and hold a durable power of attorney, including attorney-in-fact with power to litigate 18 for her. 19 2. In order to prevent David A. Paice ("Paice"), the acting trustee of the 20 Trust from using my mother's trust fund to pay for his attorney fees, I filed a petition for 21 a protection order on March 3, 2023 in a case entitled, Harold v. Paice, Case No. 23-2-22 03980-7 ("protection order matter"). A temporary restraining order was granted at the 23 March 20, 2023 hearing which froze several accounts belonging to my mother as well 24

as accounts belonging to Paice, among other remedies.

The continuation of the protection order was denied at the further hearing

held on April 20, 2023. Paice's attorney, who was instructed to prepare the order, and

I disagreed with respect to the proposed order. I then requested a presentation of the

denial order, and we were instructed to agree on a hearing date and time for the presentation. Despite explaining to Paice's counsel and the court that neither my mother and I were available on the scheduled hearing date, the court went ahead with the presentation hearing without us.

- 4. In my investigation of the incident between my mother and my sister, Jenifer Sawyer, I obtained a copy of an audio tape of the Reedsport Police Department radio call made by the witness. I discovered that there was an error between the dispatcher's log and the actual recording of the witness phone call. What was actually said by my sister Jenifer Sawyer, Grantor's daughter was, "I hate you. I'm going to kill you." Grantor responded by saying, "You want me dead?"
- 5. I also learned from my sister Josette Harold Ramirez that during this same visit by Jenifer to my mother's home, Jenifer told Josette through phone calls and texts that Jenifer was taking and photographing my mother's personal documents relating to the Trust. Attached hereto as Exhibit A is a true and correct copy of the Declaration of Josette Harold Ramirez filed in the protection order matter.
- 6. During the course of my monthly conversations with my sister Harmony Harold, she informed me of an incident involving Brieana Paice in which Brieana said, "I will tie up every penny of that trust and no one will get anything." Attached hereto as Exhibit B is a true and correct copy of the Declaration of Harmony R. Harold filed in the protection order matter.
- 7. In April, I was reviewing the online information relating to this case on the Superior Court of Washington for King County website. When I selected the "Participants" tab, I noticed that my mother was listed as deceased on this page. I have emailed the clerks in both this case and the protection order case notifying them of this error. I have also notified Paice's counsel of this mistake. It is unclear to me how this designation occurred since my mother was originally listed as a respondent. My mother has told me that she does not believe this is a mistake, and she finds this very disturbing.

- 8. My mother has been actively involved in both this proceeding and the protection order case. She contributes to her defense by providing evidence and pertinent records. In addition, she has attended every hearing, excluding the denial of the protection order presentation. Respondents serve at the direction of and for the benefit of my mother.
- 9. On April 18, 2023, my mother called me to let me know she was at the emergency room because her head "felt full." This was her third visit to the emergency room this year.
- 10. On April 27, 2023, my mother called me to tell me that she was going to see her personal doctor, Robert Jacques, as a follow-up to her emergency room visit and because she was not feeling better. Based on her symptoms and her medical history, Dr. Jacques wrote a letter requesting a 90-day reprieve from litigation in order to allow low level medical intervention. On April 28, 2023, my mother told me that she was going to pick up the letter from Dr. Jacques' office and send me a copy. A true and correct copy of Dr. Jacques' letter is attached hereto as Exhibit C.
- 11. On May 4, 2023, my mother told me that she was having trouble breathing and that my brother was driving her to the emergency room. I spoke with the emergency room doctor treating her. He informed me that my mother's cardiac enzymes were elevated and would have to be monitored to ensure that they did not continue rising. If they did, that would constitute a heart attack. After treatment, the cardiac enzymes decreased; she was diagnosed with a near heart attack and was discharged. His recommendations were for my mother to take it easy and reduce her stress levels and to follow-up with a cardiologist.
- 12. There is no urgent matter before this Court that would prove detrimental to my mother by waiting a maximum of 90 days for her health to recover. Her living expenses are fully funded for the year, and she has the additional financial support of

- 4. I then asked Jeni, "Why are you doing that? Isn't that illegal or something?"
- 5. Jeni then told me that she was taking pictures of some documents and removing copies of others just in case the "Evil Siblings" (referring to my brothers and sisters Charlie Harold, John Harold, Amy (Harold) Small and Angel Harold) decided to change or hide something."
- 6. I said, "I don't think that's a good idea, Jeni, and it's also an invasion of Mom's privacy. I'm pretty sure it's also a felony to read someone else's mail or legal papers." Jeni then said that she would call me later because John (our brother) was there at Mom's house.





To whom it may concern:

Sharon Harold Was seen in the emergency room setting at Lower Umpqua Hospital on March 24, 2023 complaining of severe global headache described as if her head was about to explode. She very rarely experiences headaches their being absence of any significant neurologic symptoms or sequelae, work up in the emergency room setting failed to demonstrate any evidence of significant pathology. These headaches have persisted on a much severe level. In conjunction with this she's had some issues with memory, anxiety, and difficulty sleeping.

It would appear she has been under significant stress as to how her personal Trust has been managed. As her position is contested it would appear that legal aspects will necessitate several months of involvement and continued stress. Her response given her age at 85 and History of moderately severe hypertension has left her perceiving a high level degree of vulnerability regarding her health. She is requesting a brief reprieve of perhaps 90 days to allow the benefit of a low grade level of medical intervention.

The courts sensitivity to her needs and health at this time in granting her this time is much appreciated.
