

**AN ORDINANCE TO APPOINT AND VEST DUTIES IN A ZONING COMMISSION FOR THE VILLAGE OF CENTERTOWN, MISSOURI.**

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CENTERTOWN, MISSOURI AS FOLLOWS:

**Section 1:** Chapter 6 of the Village Code of the Village of Centertown, Missouri, shall be amended to include the following:

**6.02. Appointment and Structure of Zoning Commission**

Original Members. The Board of Trustees of the Village of Centertown hereby appoints the following members to a Zoning Commission upon their consent:

Officers. The Zoning Commission shall elect its chairman and secretary from among its members.

Vacancies. Any vacancy in a membership may be filled for the remainder of the term by appointment by the Board of Trustees.

**6.04. Duties vested in members of the Zoning Commission**

Recommendations Pertaining to Districts. The Zoning Commission shall meet and recommend the boundaries for various zoning districts and appropriate regulations to be enforced therein as prescribed by statute.

Report to Board of Trustees. The Zoning Commission shall make a preliminary report and hold a public hearing thereon, after which a final report shall be submitted to the Board of Trustees.

Hearings, notice. The public hearing on the preliminary report of the Zoning Commission shall afford an opportunity for parties in interest and citizens of the Village of Centertown to be heard. At least fifteen (15) days' notice of the time and place of such hearing shall be published in the Jefferson City News Tribune.

Term of the Zoning Commission shall begin at final passage of this Ordinance and end at the final passage of the Village of Centertown Zoning Ordinance.

**Section 2:** This ordinance shall be in full force and effect from and after its passage and upon being duly signed.
