ORDINANCE NO. 147

AN ORDINANCE OF THE VILLAGE OF CENTERTOWN, MISSOURI AUTHORIZING THE CHAIRMAN OF THE BOARD OF TRUSTEES EXECITE A WARRANTY DEED FOR THE CONVEYANCE AND TRANSFER OF REAL PROPERTY TO CLAD RENTAL LLC.

**Section 2.** The Chairman is further authorized to execute such additional documents and take such further actions as may reasonably be required to carry out the provisions and intent of the Contract.

**Section 3**. This ordinance shall be in force and take effect after its passage and approval by the Chairman.

successors and assigns **FOREVER**, against the lawful claims and demands of all persons whomsoever.
