ORDINANCE NO. 88

AN ORDINANCE DECLARING THE LOCATION OF STOP SIGNS
WITHIN THE VILLAGE LIMITS OF THE VILLAGE OF
CENTERTOWN, MISSOURI.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CENTERTOWN,
MISSOURI, AS FOLLOWS:

Section 1: Stop Signs. When signs are erected giving notice thereof, drivers of vehicles shall stop at every intersection entering any of the following streets or parts of streets:

- The intersection of Main Street and Route NN.
- The intersection of Main Street and Monroe Street.

Section 2: Penalty. Any person violating this ordinance may be fined an amount not to exceed \$50.00.

Section 3: This ordinance shall be in full force and effect upon final passage and approval.
