## AN ORDINANCE AMENDING ORDINANCE 189, AN ORDINANCE ADOPTING A VILLAGE OF CENTERTOWN ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING JUNE 1, 2019, AND APPROPRIATING FUNDS PURSUANT THERETO

WHEREAS, The Village Clerk has presented to the Board of Trustees an amended annual budget for the Fiscal Year beginning on June 1, 2019,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CENTERTOWN, MISSOURI, AS FOLLOWS:

Section 1. The amended annual budget for the Village of Centertown, Missouri, for the Fiscal Year beginning June 1, 2019, a copy of which is attached hereto and made a part hereof as if fully set forth herein, having been heretofore submitted by the Village Clerk, is hereby adopted.

Section 2. No changes were made to budgeted income for the Fiscal Year beginning June 1, 2019.

Section 3. Budget expenditures were changed as follows: Continuing Education/Convention reduced from \$500 to \$200, Insurance – Liability/Property increased from \$7,100 to 7,600, Furniture & Equipment Purchased increased from \$5,000 to \$5,200, Postage reduced from \$500 to \$200, Snow/Salt increased from \$1,000 to \$1,300, Telelphone Expense increased from \$1,500 to \$2,500, Maintenance & Repairs – Equipment reduced from \$2,000 to \$1,500, Maintenance & Repairs – Building reduced from \$1,000 to \$200, Maintenance & Repairs – Other increased from \$1,000 to \$1,500, Maintenance & Repairs – Supplies increased from \$200 to \$300, Surplus Fund reduce from \$2,300 to \$1,100.

Section 4. This ordinance shall be in full force and effect from and after its passage by the Board of Trustees.
