## AN ORDINANCE AMENDING ORDINANCE 226, AN ORDINANCE ADOPTING A WATERWORKS ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING JUNE 1, 2021, AND APPROPRIATING FUNDS PURSUANT THERETO

WHEREAS, The Village Clerk has presented to the Board of Trustees an amended annual budget for the Fiscal Year beginning on June 1, 2021,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CENTERTOWN, MISSOURI, AS FOLLOWS:

Section 1. The amended annual budget for Centertown Waterworks, Centertown, Missouri, for the Fiscal Year beginning June 1, 2021, a copy of which is attached hereto and made a part hereof as if fully set forth herein, having been heretofore submitted by the Village Clerk, is hereby adopted.

Section 2. Budget expenditures were changed as follows: Chief Water Operator was reduced to \$3,400, a new line item of Labor-Contract Water Operator was added and budgeted at \$9,000, Labor Water-Maintenance was decreased to \$1,000, Labor-Maintenance Supervisor was increased to \$400, Office supplies were increased to \$2,300, Postage was decreased to \$550, Taxes-Payroll was decreased to \$1,150, Water Tower Loan Payment was added as a line item in the budget in the amount of \$1,000, and the Surplus fund was decreased to \$3,775.

Section 3. This ordinance shall be in full force and effect from and after its passage by the Board of Trustees.AT
