## VILLAGE OF CENTERTOWN BOARD OF TRUSTEES SPECIAL MEETING MAY 7, 2024

The special meeting of the Board of Trustees of Centertown, Missouri, was called to order at 6:00 p.m. on Tuesday, May 7, 2024, by Chairman Brown, in the Village Hall at 1227 Broadway. On roll call, the following members were present:

Trustee Hunger made a motion to accept the tentative agenda as presented Chairman Pro Tem Baker seconded. Passed on voice vote.

<u>REVIEW OF PAY SCHEDULE & JOB DUTES</u>: The Board reviewed the current payscales and proposed the following changes:

- 1) Increase the Chairman's Honorarium to \$100 per month;
- 2) Increase the Village Clerk's pay rate to \$16.50 per hour;
- 3) Increase the Water Clerk's pay rate to \$16.50 per hour;
- 4) Inactivate the Chief Water Operator \$500.00 per month position;
- 5) Inactivate the Labor-Meter Reader at \$15.00 per hour position;
- 6) Inactivate the Supervisor-Maintenance \$20.00 per hour position;
- 7) Add "Locate" to the Labor-water maintenance (CWO) \$25.00 per hour position;
- 8) Remove the Labor Water Works \$10.00 per event from the pay schedule;
- 9) Add "Contracted" to the Snow Plow/Salting Of Roads position and remove "\$45.00 per hour" from that position;
- 10) Add Labor Maintenance Seasonal Lawn Care Contracted position to the schedule.

Trustee Hinshaw moved to approve the revised payscales effective May 1, 2024; seconded by Trustee Hunger. Motion passed on a voice vote with Chairman Brown abstaining.
