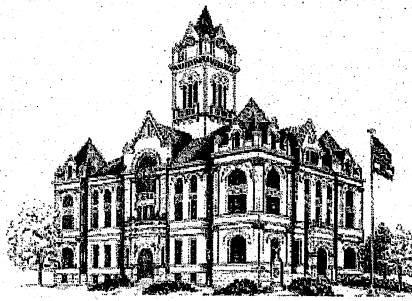
Section 1. The election returns, attached hereto, are hereby accepted by the Village of Centertown and made an official part of the records of the Village of Centertown.



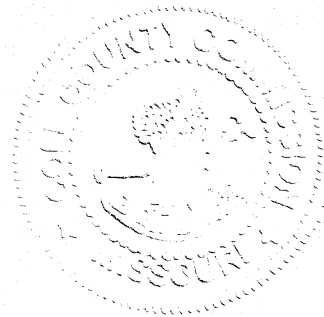
