Re: Recent Lead and Copper Test in Centertown Drinking Water

During the normal monitoring period of June to September 2019, Missouri Department of Natural Resources (DNR) and Centertown conducted testing for lead and copper in our drinking water. Five homes were tested and one home had elevated levels of lead.

I have spoken with DNR and was informed in the five samples that were taken in Centertown **three of the sites had no detection of lead in the water. One site was slightly over 1 ppb or, 0.010 milligrams of lead per liter of water (mg/L) One site that was at 38 ppb or .038 milligrams of lead per liter of water (mg/l).** The acceptable level is 1.5 ppb, or 0.015 milligrams of lead per liter of water (mg/L).

At this time, DNR requires more frequent testing with a larger sample size. Centertown will have ten homes tested every six months. If during the additional testing the levels are found to be in excess of the EPA acceptable level, the Village will work with DNR on a mandated treatment plan.

The homes that are part of the testing are provided with a collection bottle and given instructions on how to gather the water for the test. The U.S. Environmental Protection Agency, Missouri Department of Natural Resources and Centertown (Water Supply ID # MO3010149) are concerned about lead in your drinking water. One sample collected in the June to September 2019 monitoring period tested higher than allowed for lead. EPA and the department have set an action level of 15 ppb, or 0.015 milligrams of lead per liter of water (mg/L). Important Information about Lead in Your Drinking Water

The City of Centertown found elevated levels of lead in drinking water in one of five homes tested. Lead can cause serious health problems, especially for pregnant women and young children. Please read this information closely to see what you can do to reduce lead in your drinking water.

Health Effects of Lead

Lead can cause serious health problems if too much enters your body from drinking water or other sources. It can cause damage to the brain and kidneys and can interfere with the production of red blood cells that carry oxygen to all parts of the body. The greatest risk of lead exposure is to infants, young children, and pregnant women. Scientists have linked the effects of lead on the brain with lowered IQ in children. Adults with kidney problems and high blood pressure can be affected by low levels of lead more than healthy adults. Lead is stored in the bones and can be released later in life. During pregnancy, the child receives lead from the mother's bones, which may affect brain development.

Lead is a common metal found throughout the environment in lead-based paint, air, household dust, food, and certain types of pottery, porcelain, pewter, crystal, and water. Lead can pose a significant risk to your health if too much enters your body. Lead builds up in the body over many years and can cause damage to the brain, red blood cells, and kidneys. The greatest risk is to young children (especially under age 6), pregnant women, and their fetuses. Amounts of lead that do not appear to hurt adults can slow down the normal mental and physical development of growing bodies. In addition, a child at play often comes into contact with sources of lead contamination, like dirt and dust, which rarely affect an adult. If children put dirty fingers in their mouths (as most children do), some lead may be absorbed into the children's systems. It is important to wash children's hands and toys often and try to make sure they only put food in their mouths.

Lead in Drinking Water

Lead in drinking water, although rarely a sole cause of lead poisoning can significantly increase a person's total lead exposure, particularly the exposure to infants who drink baby formulas and concentrates that are mixed with water. EPA estimates that drinking water can make up 20 percent or more of a person's total exposure to lead. Boiling water does not reduce lead levels.

How Lead Enters Our Water

Lead is unusual among drinking water contaminants in that it seldom occurs naturally in water supply wells. In most systems, lead enters drinking water as a result of corrosion of materials containing lead in the water distribution system and plumbing. These materials include lead-based solder used to join copper pipe, brass and in some cases, pipes made of lead that connect your house to the water main (service lines). In 1986, Congress banned the use of lead solder containing greater than 0.2 percent lead and restricted the lead content of faucets, pipes and other plumbing materials to 8.0 percent. Because of this, faucets are sometimes the main source of lead in the type of samples we take. In 2011, Congress further reduced the lead content of faucets, pipes and other plumbing materials to 0.25 percent. The effective date for the new requirement was January 4, 2014.

When water stands in lead pipes or plumbing systems containing lead for several hours or more, the lead in the pipes or solder may dissolve into your drinking water. This means the first water drawn from the tap in the morning, or after a period of absence, can contain fairly high levels of lead. Flushing the tap after a sitting time as explained above can significantly reduce the lead content in drinking water.

What You Can Do

- 1) Purchase bottled water for cooking and drinking.**
- 2) Flush the tap for one to two minutes before using the water for drinking or cooking.** Doing this reduces the level of lead and copper because it flushes away the water that has been sitting in pipes or against the fittings. **If you have a lead service line flush the water for several minutes after feeling a significant change in the temperature of the water.** Doing this will flush water from the tap that has been sitting in the lead service line during periods of low usage such as overnight or after returning from work.
- 3) Purchase or lease a home treatment device.** Treatment devices are limited in that each unit treats only the water that flows from the faucet to which it is connected. All these devices require maintenance and replacement. Devices such as reverse osmosis systems or distillers can effectively remove lead from your drinking water. Some activated carbon filters may reduce lead levels at the tap; however, all lead reduction claims should be investigated. Be sure to check the actual performance of a specific treatment device before and after installing a unit.

What We Have Done to Reduce Lead

One of five homes tested had elevated lead levels. We are working with the Missouri Department of Natural Resources to resolve this problem.
