**Basic Guidelines and Rules - Please read before signing**

1. A bow must be presented to join the Club.
2. All members while on the range are to own and shoot archery equipment (wooden bows, recurve or compound bows). Neither crossbows nor the use of any firearms is permitted; this includes pellet, airsoft, and paintball guns as well.
3. Entry onto the range by vehicle is restricted exclusively to archery and no other purpose whatsoever, including beach access.
4. No alcohol, smoking, nor open flames are permitted on the range.
5. Parking is only permitted in the parking lot near the practice area, not along the road nor at the top.
6. The range road is closed the day of and after it rains to protect the road.
7. Club shoots are every fourth Sunday at 9:00 a.m., the third Sunday in December.
8. Club meetings are every 4<sup>th</sup> Sunday after the monthly shoot approximately 12:00 pm, unless the shoot is canceled.

9. New membership fee to join is \$200, which includes a one-time registration of \$15. All new members receive **ONE (1)** gate key to access range. Should new members join after the month of February, the annual membership fee will be prorated per a monthly schedule based on the joining month, through the fourth Sunday in February of the following year.
10. Renewing memberships annual fee is \$185. All renewing members receive **one (1) new** gate key to access range. Annual club renewals take place during the month of February, on the fourth Sunday of the month. Renewing Memberships are NOT prorated.  
COST TO REPLACE LOST KEY STARTS AT \$25.00.
11. Work Parties: If a member has contributed a club documented log with a minimum of six (6) three hours at a work party or parties during the previous year, a credit of \$100 will be applied to their annual membership fee for the following year.
12. All members will abide by the Club's By-Laws and Constitution, and all local laws and rules as set forth by the City of Rancho Palos Verdes, our Conditional Use Permit, the Palos Verdes Peninsula Land Conservancy, the Coastal Commission and the local Fire Department. Failure to comply may result with expulsion from the Club.
13. Local flora and fauna are to remain unharmed. This includes but is not limited to rabbits and other rodents, lizards, snakes, hawks, owls, and pelicans.
14. The Club, its Board, and members are not responsible for archery-related accidents nor any damages as a result of and movement or other acts of nature. Everyone who enters the range does so at his/her own risk.
15. Members must have a signed insurance waiver on file. All guests must also sign a waiver.
16. Members must have a signed photo release on file.
17. Members are responsible for their guests and children.
18. Announcements appear on our website (southbayarchery.com) and Facebook page, and direct emails as necessary.
19. In order to be eligible to participate for a Club Trophy Award, club members must have completed at least four (4) shoots out of 10 (ten) shoots that are held from January to December. Awards are handed out at the Annual Club Banquet
