

SNOW REMOVAL BID PROPOSAL

SPECIFICATIONS and REQUIREMENTS:

1. Bidder must submit 4 snow removal bids
 - a. Per Inch
 - i. 0" to 3"
 - ii. 4" to 6"
 - iii. 7" to 12"
 - iv. 13" and over
 - b. Per Storm
 - c. Salt Only
 - d. Shoveling (\$ per hour)
2. Snow removal must be done when the Town of Oxford plows or at the request of the Bar Manager, President, or Grounds Chairman.
3. In the event of a breakdown of the contractor's equipment, it is the sole responsibility of the contractor to facilitate using a subcontractor to complete the snow removal process. Singletary Rod and Gun Club, Inc. shall assume 'No Cost' for the sub-contracting action.
4. Any damage to Singletary Rod and Gun Club, Inc.'s property during snow removal and/or salting shall be repaired at the expense of the contractor.
5. All designated areas will be plowed/salted/shoveled at the direction of the Bar Manager or his/her designee. Designated areas shall include the rental property (parking area/driveway).
6. Re-plowing shall be required when new storm accumulation exceeds 2 inches.
7. Snow removal and salting (if required) shall be completed before 10:00 AM to allow Singletary Rod and Gun Club, Inc. to be safely accessible/open seven days a week.
8. Plowed snow shall be placed at the designated area(s) to not interfere with Singletary Rod and Gun Club, Inc.'s access (front and rear), standard and handicapped parking, and trash dumpster access.

9. Sealed bids will be accepted from Tuesday, July 25, 2023, through Monday, October 23, 2023. Bids will be reviewed during the Board Meeting on Thursday, October 26, 2023. All bidders shall be notified of the outcome of the selection results.
10. The Grounds Committee has the right to reject any/all bids.
11. For the proposal to be considered, please include the following:
 - a. Complete Bid Sheet (Attached – Next Page)
 - b. Certificate of Insurance including Auto, Liability, and Worker’s Compensation.
 - c. W-9
