The incumbent has membership forms available at all functions, collects completed forms and dues and records the information. New members' names are communicated to Gloria for name tags. Dues and membership forms are forwarded to the treasurer. The membership chair also makes and distributes membership cards, maintains a current roster of members' information and makes the roster available to new and current members."

The updated position description for secretary is as follows, "The secretary shall take notes at the business meetings and the board meetings to prepare minutes of both meetings, to then email or present each board member with copies of the minutes. The secretary shall also read the previous month's minutes at each guild business meeting."

Travel south on Cleveland (cross over the RR tracks) until it intersects with Highway 90. Turn left and travel 1/2 mile to Gulf Park Campus. Enter the campus from HWY 90 to the side street “ Beach Park Place ”, there is traffic light (turn left) and follow entry signs from there. A full page map is included at the end of this newsletter.
