

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 50 West 34th Street, and Darrell Perry/NXT Funding and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Darrell Perry/NXT Funding include 50 West 34th Street and NXT/1st Funding. The NXT/1st Funding website is a Financial services. site. By using the NXT/1st Funding website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, NXT/1st Funding may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us.
