Dear AFGE Members,

We need your support more than ever! We urge you to take action by writing emails (emails for staffers that we that we have have been provided) and making phone calls to the offices of the DOGE Co-Chairmen and Subcommittee Members both in Washington, D.C., and in their respective district offices.

**Instructions for Writing Emails and Making Calls:** 

**Identify Your local Representatives** 

Determine the DOGE Co-Chairmen and Subcommittee Members representing your district but be sure to contact all doge members regardless of local.



Find their contact information, including email addresses and phone numbers, on the official congressional website and the list provided.

**Compose a Persuasive Email:** 

Begin with a respectful introduction

Introduce yourself and mention that you are a member of the American Federation of Government Employees (AFGE).

Clearly state the purpose of your email: to request their support for the People of the United States, our veterans, and our federal workforce.

Emphasize that the boots on the ground employees and average workers do not create policy or make decisions; rather, the issues facing abuse and waste are attributed to higher-level staff.

Highlight that our bargaining unit employees are not responsible for the issues the nation is facing, and eroding the baseline workforce only worsens the issue of our top-heavy government.

Conclude with a courteous request for their support and a thank you for their time and consideration.

Sign off with your name, and contact information.

Make a Phone Call:



Dial the office number of the representative.

Introduce yourself as an AFGE member and briefly mention the issue you are calling about.

Clearly state your request for their support for the People of the United States, our veterans, and our federal workforce.

Be respectful and concise in your communication.

Thank the representative or their staff for their time and consideration.
