From Madison/Milwaukee: From Madison:

Take I-94E towards Milwaukee; From Milwaukee - Take I-94W towards Madison; Take exit 267 towards Johnson Creek/Hwy 26; Stay straight to go onto the frontage road; Turn Right on Hwy 26 South heading toward Jefferson/Ft. Atkinson; Follow Hwy 26 South until you come to Hwy 26BR (Business Route); Merge onto Hwy 26BR heading South into Jefferson; Turn Right onto Puerner Street; Follow Puerner Street into the fairpark.

From Beloit:

Take I-39N/I-90W towards Janesville/Madison; Take exit 171A towards Hwy 26N - Janesville/Milton/Ft. Atkinson; Continue following Hwy 26 North; Merge onto US -18 East towards Jefferson; Turn Left onto N Jackson Street. Fair Park will be located 1/2 mile on the left.

Opportunity Class Specifications: These classes are not rated and are open to ALL BREEDS. Show Clothes or Academy attire are required. No Training Tack Allowed. Horses may cross enter rated Division if Arabian or Half Arabian.



Entries

Please include items listed below

If entries are not completed in full, a \$25 fee will be applied.

1. Online entries can be made at noteworthyshows.com.
2. Copies of **AHA Competition membership cards** of each owner, trainer, driver, rider, handler and agent or trainer or pay \$35 per person AHA Single Event Membership (SEM) fee. Walk Trot entries, Opportunity entries, and Lead line riders are exempt.
3. Western Dressage riders are required to be WDAA members or pay a non-members fee to WDAA.
4. Dressage riders: Dressage/SHIH classes may not run in class number order or by day due to scheduling. Management has the right to limit Dressage Rides and SHIH Go's. Both are offered on a first come/first served basis.
 - a) Note: Post entries will not be accepted for sport horse in hand, dressage, or western dressage. Exception: Scratched times may be filled on a first come, first served basis.
1. Exhibitors are not required to be USEF or breed/discipline affiliate members, unless signing the entry blank as Trainer/Coach, nor pay show pass fees.
 - a) Exception: Membership is required for those seeking HOTY points.
2. **Entry Form** must be complete with Owner/Trainer/Rider information and must contain **3 signatures** on the back. An adult signature is required for all Youth exhibitors. Waiver & Release Liability Form MUST be signed and included.
3. A **signed check** made payable to WAHA covering all fees. No postdated checks & No BLANK CHECKS. Entries received without **full** payment of all fees will be considered **post-entries**.

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows:

I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, leasee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. **I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.**

I AGREE as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and _____ ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

C. - Rules:** This horse show is conducted in accordance with the Rules of the USEF and Arabian Horse Association. The official rulebook of each organization will prevail for this show. Each participant in this show is responsible for knowledge of these rules and is subject to these rules. Any changes or corrections of the rules will automatically become part of this prize list. Questions that may arise that are not covered by either AHA or USEF rulebooks will be decided by the Show Committee and their decisions will be final.
- Physical Inspection:** Any horse who exhibits questionable symptoms must be immediately removed from the show grounds. Examination or treatment not requested by show officials shall be on a private practice basis.
- Liability:** All entries are accepted with the understanding that the Wisconsin Arabian Horse Association, Region 10, and/or the Jefferson County Fair Park will not be held responsible for any loss, damage, or injury to any horse exhibited or any kind of article. All horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage, or injury to any person, animal, or property occasioned by him, his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the WAHA Board against any and all loss, including damages and liability thus occasioned, including but not limited to any and all legal costs, including attorney fees, which may be incurred as a result thereof. The submitting of an entry form to the Show Secretary shall constitute an acceptance by each person signing same of the provisions herein set forth.
- Attendants/Grooms/Headers:** No person will be permitted to enter the ring except participants in the class, judges, their assistants, and show officials. Attendants, grooms, and/or headers may enter the ring only when summoned by order of the judge. Headers will be permitted in all driving classes.
- Halter Classes:** Horses in breeding and in-hand classes will use the In The Ring procedure. Products may not be applied to hoof or hide to conceal a conformation defect. Clear or transparent products may be used on hooves for Breeding or In-Hand classes. Each horse must be present at the in-gate and ready to enter the ring when its number is called. Any horse not present and ready to enter the ring will not be admitted to the class.
- Warm-Up Facilities & Competition Arenas:** On Friday, Saturday, and Sunday the two indoor arenas will be available for warm up. Arenas: Indoor 80' x 150'; North ring 115' x 225'; West ring 150' x 250' with sand footing.
- Stallions:** PB and HA stallions may be shown by ladies or junior exhibitors in any class except Walk-Trot, Showmanship and Leadline classes. Half-Arabian/Anglo-Arabian stallions two years or over may compete in performance classes.
- Class Size:** The show committee reserves the right to split or combine any class with duplicate awards presented.
- Call for Classes: The two-minute rule will be strictly enforced.** If time is needed for a tack change, the gate must be notified. All tack changes must be made at the ring entrance.
- PA System:** Due to possible unforeseen problems with any mechanical device, the PA system and class calls over that system are considered a courtesy. It is the exhibitor's responsibility to have his or her horse at the gate at the prescribed time. While

every effort will be made to maintain a working PA system, no protest will be upheld nor will any section be changed on the basis of a PA system problem.

12. **Pets:** Pets will be allowed on the grounds but must be on a leash. Pet owners are required to supply an official rabies vaccination certificate showing date of vaccination and serum used.
13. **Overnight Camping:** Overnight camping facilities are available with electric and water hookup priced per night depending on the service required. Payment of the camping fee is made to WAHA at the time of check in, and the Fair Park office will issue a camping permit that must be displayed in the window
14. **Stalls:** Permanent stalls with stall fronts will be available at the show. Tack stalls may be limited at the discretion of show management. Each horse must be assigned a separate stall (except mares with suckling foals). Stalls will be available by eight am on Friday. Early arrival is available on Thursday for \$30/stall; please contact Nyssa at (608) 213-4594 so she can make sure your stalls are ready in advance. Showing from a trailer is not permitted. **No smoking in the barns will be strictly enforced.**
15. **Bedding and Hay:** Bedding will be available for pre-order at \$10/bag. All bedding requests must be submitted via the stall request form by 07/16/2024. All bedding requests must be pre-ordered, and no bedding will be for sale at the show. No grain, pellets, or hay will be for sale.
16. **Stall Assignments:** Stalls are limited. Therefore, stall assignments will be made on a first come, first served basis based on the following:
 - a) Members of the WAHA Show Committee.
 - b) Class sponsors paid/US government postmarked before entry closing date.
 - c) Stalls paid in order of US government postmark date. Paid stall orders with the same postmark date will be assigned in inverse order to the number of PAID stalls per order whenever possible. Show Management may exercise discretion in regard to stabling placement. Metered postmarks are not acceptable.
17. **No Shows:** There will be a \$5 penalty assessed for “no shows.” If you have entered a class and are not going to show in that class, you must notify the Show Office and gate before that class enters the ring or pay a \$5 penalty/class. There will be NO REFUND for No Shows.
18. **Open Checks:** No “open” checks will be accepted for pre-entry fees or stall reservations. All pre-entries and stall reservations must be accompanied by fully completed, negotiable checks dated on or before the close of entries date. Entries received without such checks will be returned.
19. **NSF Check Policy:** There is a \$50 penalty for each check returned due to non-sufficient funds. In addition, either of the following may result in termination of personal and/or business check privileges in payment for any charges to WAHA shows or to WAHA for any other charges (including but not limited to dues and/or fees for WAHA programs).
20. **Hoof Length, Shoes and Pads:** Management reserves the right to request measurement of toe length, shoe dimensions, and remove shoes and/or pads for hoof inspection of any and all horses in any class. Shoes may be pulled and inspected at random.
21. **Printing Errors:** The Show Committee is not responsible for errors in printing. Corrections of any error will be posted in the Show Office.
22. **Refunds:** Stall fees and office fees will not be refunded under any circumstance. Entry fees for entries cancelled before the official closing date for pre-entries will be returned. Refunds of entry fees will be made after the closing date for pre-entries upon presentation of a Veterinarian’s Certificate to the Show Secretary by the end of the last of the class of the show. No refunds will be made thereafter.
23. **Discipline:** Exhibitors are warned that any act of discourtesy or disobedience to the officials of this show on the part of the owner, lessee, trainer, groom, rider, driver or handler will disqualify the horse from adjudication. Show Management reserves the right to remove any of the above listed from the show without being liable for compensation or damages (GR 702). Any action(s) against a horse by an exhibitor which are deemed excessive by a judge, federation steward, technical delegate or

show veterinarian, in the competition ring or anywhere on the competition grounds may be punished by official warning, elimination, or other sanctions which may be deemed appropriate by the Show Committee (GR702 & GR703).

24. **Health Papers/Coggins Test:** An official health certificate issued within 30 days of the show by a licensed veterinarian must accompany all horses not residing in the State of Wisconsin. A negative Coggins certificate issued within the current calendar year must accompany all horses. The health and original Coggins certificates must be available for inspection at the time of check in.
25. **Motorized Vehicle Statement:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
26. **Sharps Containers:** Refer to USEF GR1210. As per USEF rule GR1210.4, all used needles and other disposable sharp instruments must be placed in sharps containers. Per rule GR 1210.4, competition management will fine any individual including trainers, owners, exhibitors, and their agents \$100.00 for improper disposal of needles or other sharp disposable instruments.
27. **Safe Sport Statement:** Effective immediately, any competition with the start date of September 1, 2020 and later will be required to include the following Safe Sport statement in the Rules and Regulation section of the prize list: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at <http://www.usef.org>.
28. **Health Papers/Coggins Test:** An official health certificate issued within 30 days of the show by a licensed veterinarian must accompany all horses not residing in the State of Wisconsin. A negative Coggins certificate issued within the current calendar year must accompany all horses. The health and original Coggins certificates must be available for inspection at the time of check in.
29. **Judges:** The Show Committee reserves the right to substitute a Judge for the one who is officially designated in the Prize List, according to USEF Rules. No contact shall be made with the Judges during the period of the show unless accompanied by a member of the Show Committee. Further, no exhibitor shall approach a Judge regarding a decision unless he/she first obtains permission from the Steward, who shall arrange an appointment with the Judge at a proper time and place.
30. **Dressage Helmet Rules:** When cross-entry by rider or horse/rider combination is permitted between Dressage and other Arabian classes at a competition, DR 120 and DR 121 apply only to the designated Dressage warm-up and competition arenas, or when an exhibitor is actually warming-up for Dressage class(es).
31. **Protective Headgear:** Any rider may wear protective headgear in any division or class without penalty from the judge. Dressage attire requires the use of an ASTM certified helmet. USEF strongly encourages all riders to wear protective headgear. It is the responsibility of the rider, parent, guardian, or trainer of the junior exhibitor to see that the headgear worn complies with safety standards and is properly fitted and in good condition. Refer to current USEF Rule Book.

USEF GR845 Equine Vaccination Rule

At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.

In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations, name of the vaccines and date of vaccine administration.

In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration.

In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee. BOD 1/17/15 Effective 12/1/15.

- Youth competing without a trainer or coach will have a parent sign as trainer or coach and the parent must be a competing member and have completed the SafeSport training
- Competition Manager(s), Secretary, and any person acting in the role of a licensed official are bound by all requirements of the USEF Safe Sport Policy.
- Any Competing Federation Member eighteen (18) years of age or older must have completed the SafeSport Training prior to the first day of competition.

It is \$50 for the first year or \$40 for each following year to nominate a horse into this program. If choosing the WAHA Points program flat rate program, the LOM program is included.

SUPREME LEGION OF MERIT

The Supreme Legion of Merit is open to Purebreds, Half-Arabians and Anglo Arabians. Horses that have earned the WAHA Legion of Merit may continue in the WAHA Point System. Starting in 2004, horses earning 1,000 additional points in the WAHA system will receive an award for WAHA Supreme Legion of Merit Award.
