HOW MANY CLIENTS

- MAXIMUM of ONE (1) per position each draft class.
 - NO EXCEPTIONS
- We reach out to the TOP 5 at each position across the country, set up meetings and once one of them becomes an OSA Client we inform the others that we cannot take them on.
- Allows us to put all of our time and effort into marketing ONE QB,
 ONE Safety, Etc.

Fees

LOWEST IN THE GAME

- If someone comes in lower, I will beat their commissions.
- More Players are choosing to go Self-Rep because of high-fees. We will get you more money than if you go self-rep, but also don't have ridiculously high fees.

Contract Negotiations

- Drafted Players
 - 0.5% of Signing Bonus
 - 1.0% of Rookie Salary
 - 1.5% of all future contracts
 - 3.0% of Practice Squad Elevations
- Undrafted Players
 - 1.5% of NFL Salary
 - 3.0% of Practice Squad Elevations

Fees (Continued)

- Endorsements
 - 8.0% of the Value of All endorsement Contracts

Draft Preparation

- Training
 - You need to test well. We will work with your school's trainers and nutritionists to set up a program that not only allows you to test well, but that develops habits you will need to crack an NFL starting lineup.
- YOUR story is the most important part of your draft.
 - We help you tell your story in a way that will stick with scouts, general managers and coaches.
 - There are a lot of really good football players eligible for the draft. THIS is your chance to stand out, so they think of YOU on draft day.

- Contract Negotiations
 - CBA
 - Knowing what you can get is a starting point. We know the CBA inside and out, which means you can rest assured you get the maximum benefits possible from the CBA.
 - Negotiations are 90% Work, 10% Skill
 - The easier we make it for your General Manager to see why we are asking for a certain amount, the more likely we are to get it.
 - Any negotiation takes A LOT of work. We need:
 - Comparables
 - Film
 - Traditional Stats
 - Advanced Metrics
 - Fitness Testing
 - YOUR story (Again)

- Endorsements
 - CBA
 - Same as Contracts. There are limits on what you can do.
 - Endorsements are 99% Work, 1% Skill
 - The only skill element is understanding how you can help a business and coming up with ideas that would be appealing to businesses.
 - Any endorsement deal takes A TON of work. 99% of it is making calls and connections to find companies that are interested and then finding a model and value that works for both YOU and the business.

- Professional Services
 - OSA does not have Accountants, Lawyer or Financial Advisors that work for us.
 - When you need a professional service, OSA will help you find someone that you are comfortable with AND we will help you negotiate a fee structure that makes sense for YOU!
 - Most agencies get referral fees paid to them when they get you to sign up with a particular professional.

Timeline

- October 2024
 - You receive your OSA Letter!
 - NCAA Rules allow you to have discussions with us about our services over the course of the remainder of the season.
 - YOU CANNOT COMMIT TO A PROFESSIONAL AGENCY UNTIL YOU HAVE DECLARED FOR THE DRAFT!
- November 17, 2024 Deadline to Schedule In-Person Meeting
 - You must text/call/email to advise that you would like to meet on the date indicated on the letter.
- December 1 − 20, 2024
 - In-Person meetings with OSA Prospects.

Timeline

- December 21,2024
 - OSA offers formal NFLPA Approved Athlete Agency Contracts
 - You will have a 3 hour exclusive window to sign, otherwise we will contact the next athlete at your position.
 - Once we have signed an athlete at a specific position we will notify all others that we are unable to work on their behalf.
 - EX) Once a Safety signs, we will notify all other safeties that we are full for the 2025 NFL draft.
