Camping Rules

1. You may park your camping vehicles at fair grounds and walk over to Post where your camp spots will be assigned to you at American Legion Post 977 registration table. Pathway will be marked.
2. All campers must use outdoor lead cords, size 12-3 or bigger. Cords must not be frayed.
3. **No** fireworks or open fires, no generator usage after 11pm, unless the exhaust is through a chimney. Post 977 reserves the right to request generators be turned off.
4. Stay in designated spot. Campers facing the tree line must be staggered in order to have 5-foot clearance. Awnings and Canopies cannot extend beyond your space.
5. All vehicles, campers and trailers must be removed by Sunday, July 30th by 4pm.
6. All pets must be on an leash & contained, all pet owners must clean up after their pets.
7. Please follow NYS Sanitary Code #3 and 4 of Subpart 7-5:
8. *You should have* adequate fire extinguishers and should be readily available in your camping area.
9. You will be charged \$25 a day if you plug in your camper prior to July 27th, 2023.
10. You are responsible for any theft or damage to your camper or tent.
11. Please keep your camp area clean and free of hazards.
