Anyone remember Brisco? A cruelty seizure pulled by A chance to bloom/Barbara in 2018! A tripod pittie who had lived a life of nothing but neglect and abuse.

Fast forward to 2019, a chance to bloom gets “exposed” and eventually shut down. Jessica Russell fled the state and Barbara took on all the a chance to bloom dogs, including Brisco. Brisco stayed with Barbara for most of his time with a chance to bloom, except for a few months that he stayed in solitary confinement at Dogtown.

February 17, 2021 (The big freeze) Brisco lost his life. The circumstances surrounding his death are still unclear. Kidney failure or toxicity? I’m sure we’ll never really know unfortunately. What I do know is that Brisco is yet ANOTHER VICTIM of a scam rescue/rescuer.

Brisco wasn’t an easy flip dog. He was 3-legged Pit Bull with a past. He would have needed a home with patience and structure. His adoption would have taken a little more work than the average puppy or small designer breed dog, but that shouldn’t mean that he didn’t deserve to ever get a chance.

Brisco was NEVER EVEN NETWORKED! 3 years in rescue and never given a chance! Do I need to say it again? THIS IS NOT RESCUE! Dogs should not be hoarded and hidden away for years without any effort of finding them a home.



Brisco is another dog who basically died in boarding under Doggedly Dog Rescue’s care. When will enough be enough? When will people who claim to care about animals stop turning a blind eye to this neglect? Even as recent as yesterday (9/4/21) Doggedly is still intaking puppies to flip. All while dogs like Brisco and the 60 +/- dogs who have been in Barbara’s care for years still sit in boarding or in crates in her home. Not networked, hidden away.

Please do your research! Please stop supporting this madness. Not all rescues are bad but ones like this are ruining it for all rescues!

I’m so sorry that you were dealt the hand you were.

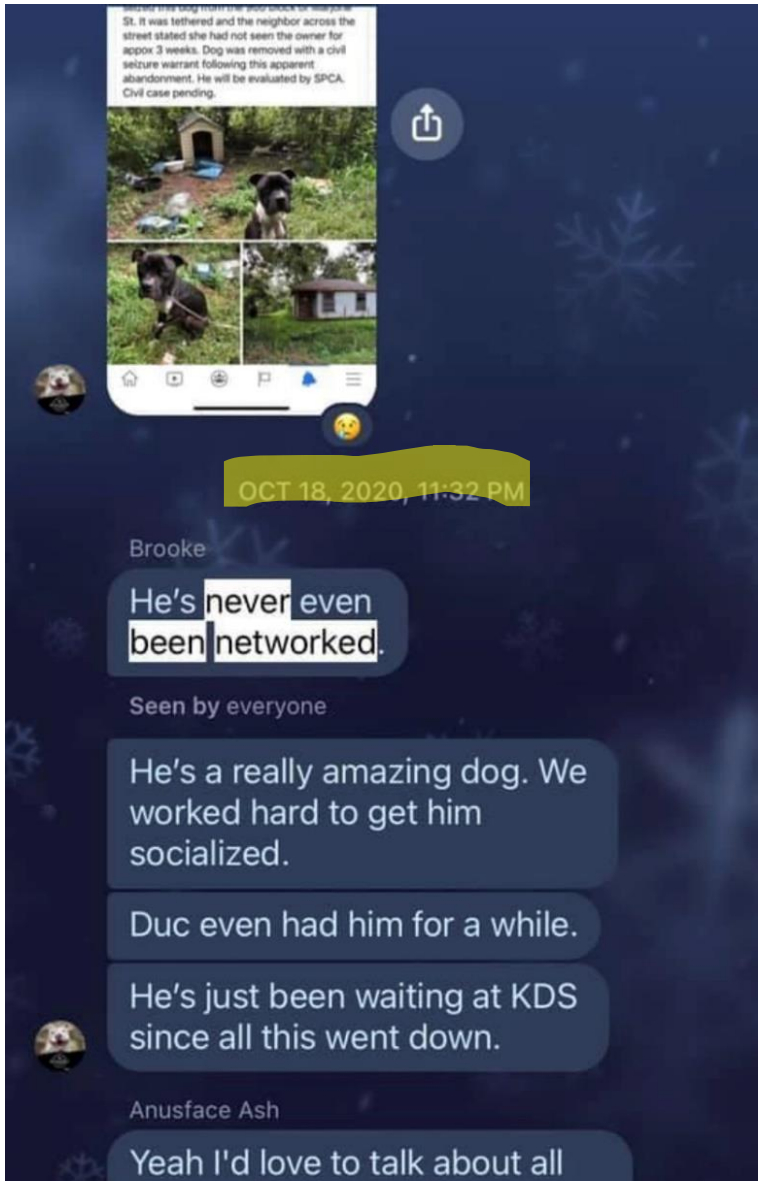
