DERBY DIOCESAN BOARD OF EDUCATION - INSTRUMENT OF GOVERNMENT

SALE & DAVYS CHURCH OF ENGLAND CONTROLLED PRIMARY SCHOOL

1. The name of the school is Sale & Davys Church of England Controlled Primary School.
2. The school is a voluntary controlled school.
3. The name of the governing body is "The Governing Body of Sale & Davys Church of England Controlled Primary School".
4. The Governing body shall consist of:-
 - 4.1 Four parent governors
 - 4.2 One LA governor
 - 4.3 Two staff governors
 - 4.4 Two co-opted governor
 - 4.5 Two foundation governors
5. Total number of governors is 11.
6. The term of office of each category of Governor is four years.
7. The following are entitled to appoint foundation governors:-
 - 7.1 The Derby Diocesan Board of Education appoints one foundation governor on the nomination of St. Wilfrid's Parochial Church Council, Barrow upon Trent.
8.
 - 8.1 The holder of the following office shall be a foundation governor ex-officio:
The vicar of St. Wilfrid's, Barrow on Trent (or his/her successor in Title).
 - 8.2 The Archdeacon of Derby shall be entitled to appoint a foundation governor to act in the place of the ex-officio foundation governor whose governorship derives from the office named in 8.1 above, in the event that the ex-officio governor is unable or unwilling to act as a foundation governor, or has been removed from office under regulation 23 (2) of the Regulations.
9. The Archdeacon of Derby may request the removal of any ex-officio foundation governor and to appoint a substitute governor.
10. The Trustees of the school are Derby Diocesan Board of Education.
11. Religious Ethos Statement:

"Recognising its historic foundation, the school will preserve its religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level. It aims to:-

 - provide opportunities for all pupils to reach their full potential intellectually;
 - promote pupils' spiritual, moral, physical, social and cultural development and prepare all pupils for the opportunities, responsibilities and experiences of life;
 - foster a strong sense of Christian values including honesty, caring, sharing and self-discipline;
 - encourage pupils to value themselves and others as individual and as part of a world-wide family;
 - promote respect for the environment, both natural and man-made".
12. The Instrument of Government came into effect upon approval by the governing body on 25th March 2015 as required by the Department for Education. (The Constitution of Governing bodies of maintained schools May 2014).
13. This Instrument was made by order of Derbyshire County Council Local Authority on 25th March 2015.
14. A copy of this Instrument will be given to every member of the governing body, the Headteacher, the trustees of the school and the Diocesan Board of Education.
