New government legislation requires us to publish a new report called the SEN Information Report (clause 65 of the SEN Code of Practice 2014). An initial version has been drafted and will be amended as further guidance is received from the Local Authority.

Our school and SEND provision	Sale and Davys Primary School is a small mainstream Primary School. The majority of children come from the surrounding villages which include: Barrow, Chellaston, Stanton, Melbourne and Stenson Fields. At Sale and Davys Primary School we are committed to the equality of opportunity and the provision of the highest standard of education for all our pupils, including those with Special Educational Needs and disabilities.

Identificat ion and assessme nt of pupils with Special Education al Needs and Disabilitie s	15 % of the pupils on roll are on the SEND register. The majority of these children are supported at the SEN support level and 2 child have an Education and Health Care Plan (EHC). Pupils who may have Special Educational Needs and Disabilities can be identified in a number of ways. The use of school's data tracking identifies pupils who are not making expected progress or are not on track to achieve their end of year target. Concerns voiced by parent / member of staff external professional. Pupils may come to us with outside agencies already involved. Sale and Davy Primary School has excellent links with outside agencies including but not limited to Paediatricians, Educational Psychology, Behaviour Support, Physiotherapy, Occupational Therapy, Speech Therapy, Autism Outreach, Support Service for Special Educational Needs and Support Service for children with physical, visual and sensory impairments.

The SENCo makes referrals to these outside agencies as needed. Progress of children with SEND is carefully monitored by scrutiny of data tracking grids and intervention monitoring. Children tracking below expected levels or making less than expected progress are identified and intervention put in place. Provision for Sale and Davys Primary School has a robust system of reviewing provision each pupils with term. This includes scrutiny of-Special 1. Teaching and Learning Educational 2. Achievement/tracking Needs and 3. individual observations Disabilities Governors are involved in this process and receive regular reports. a)The All pupils who access an intervention are tracked closely using the school's effectiveness of tracking system. The increase in attainment is analysed to ascertain whether the provision for progress made on these intervention programmes is below expected, expected or pupils with better than expected. SEND b) Teachers assess pupils continuously through teacher assessment and through Arrangements formal assessments. Termly Pupil Progress Review meetings look in detail at the for assessing progress made in all areas by pupils with and without SEND. Parents are involved in the review process at least 3 times a year at IEP review and reviewing meetings and also have the opportunity to discuss progress at parents' evening. the progress of pupils with At IEP meetings a number of targets are set and ways parents can help at home **SEND** are discussed. At the end of each academic year a written report is sent to parents detailing progress. The SENCo and class teacher are available for appointments to discuss progress at any other time during the year. c)Approach to All pupils on the SEND register have an Individual Education Plan which details teaching pupils their next steps and strategies to address these next steps. with Special All pupils with SEND receive high quality first teaching (carefully differentiated work within the classroom). Carefully matched interventions may also enhance Educational Needs and this teaching. Pupils may be taught as part of a class, in a small group or Disabilities individually depending on the activity. School staff may also be supported by outside agencies regarding strategies best matched to teach specific pupils. Pupils with intervention funding or an Education and Health care plan are also supported by a SSSEN (Support Service Special Educational Needs) teacher on a 1:1 basis. d)Adaptation of The curriculum has been reviewed in line with the new regulations. the curriculum Our curriculum is broad, balanced and relevant to a changing society. Our pupils and learning are actively engaged in their learning. We aim to ensure all pupils, including those environment for with special educational needs and disabilities, have full curriculum entitlement pupils with and access. Special The school aims to provide work that is matched and therefore accessible to the Educational broad range of pupils we teach.

Needs and Disabilities	The in class support provided by teaching assistants, SSSEN and other agencies is carefully considered by each class teacher when planning in order to ensure all pupils with Special Educational Needs and Disabilities continue to receive a broad and balanced curriculum. When pupils are withdrawn in order to meet their Special Educational Needs, the class teacher will ensure that this does not affect the pupil's access to the full range of curriculum activities. Adapted teaching will be provided in a range of ways, depending upon which is most appropriate, and will include but is not limited to; task, by ability grouping, by the level of teacher support, by the level of expectation and by the allocation of appropriate resources. The buildings, access and facilities are of a very high standard. The Accessibility Plan details improvements to be made and standards to be maintained to ensure quality of access.
e)Additional support for learning	The school receives funding for pupils with Special Educational Needs and Disabilities through the Local Authority. This funding is to support work with pupils with a statement or EHCP. The school allocates money to school support pupils. This money is used to purchase classroom support and resources. The school will request an Education, Health and Care Plan from the local authority when, despite an individualised programme of sustained intervention SEN support the pupil remains a significant cause for concern. An Education, Health and Care Plan might also be requested by a parent or outside agency. An Education, Health and Care Plan will normally be provided where, after an assessment, the LA considers the pupil requires provision beyond what the school
	can offer. However, the school recognises that a request for Assessment does not inevitably lead to an EHCP.
f) Activities available to pupils with Special Educational Needs and Disabilities	All extra-curricular activities are available to all children and will be suitably adapted and supported to ensure access for all. All educational visits (including residential trips) are open to all pupils. Adult support and resources are made available to ensure that all pupils can access these activities. The SENCo works closely with parents before trips to discuss specific needs of each pupil with SEND. No pupil is removed from activities at Sale and Davys Primary School unless there is a safety concern or a request is made from parents or carers and, even then, we would seek to adjust the activity or level of support so that the pupils could access it.
g) Support available for improving the emotional and social development of pupils with	We have a robust safeguarding policy and protocol in place. Pupil's health and well-being is paramount. Pupils work on a one to one basis with an adult to address needs specific to that pupil. Activities to improve self-esteem are also carried out on a 1:1 basis.

Concerns about the provision for pupils with SEND	In the first instance we encourage parents to contact their child's class teacher. If concerns remain we ask parents to contact the SENCo and Headteacher. In the unlikely event that a concern is not resolved parents are asked to contact the Chair of Governors.
