The project supported about 100 women and 120 children to come out of isolation and loneliness and improve mental health through our activities, Last year, we completed three major projects: physical exercise, social activities, and educational programmes for women and children from the BAME community. Participation in the activities has allowed them to gain confidence, learn new skills, reduce screen time, and improve their negotiating and communication skills. The children's programmes, in particular, became a catalyst for bringing together adults from various ethnic groups in our community. The most satisfying aspect of the past year is that the project assisted in integrating many people from various backgrounds, such as Eritreans, Italians, Polish, Ghanaians, Nigerians, Angolans, Algerians, and Ugandans; this has positively impacted the diversity of our adult programmes. Overall, stronger bonds were formed between different ethnic groups, formed long-lasting friendships, participants felt included, improved community cohesion, and promoted the holistic wellbeing of families.

We consult our stakeholders on an ongoing basis through surveys and feedback to ensure that the sessions suit the community's needs. We also have complaint, complimentary, and suggestion books available for participants to share their thoughts and concerns during activities.
