Graduated in law since 2005, I have always aimed academic and professional improvement. In the academic field, I was a professor in several undergraduate Law courses since 2006, having coordinated some teams of teachers, as well as the opening of new law courses in Distrito Federal (Brasil). Among the various subjects I've taught, the emphasis was on Administrative Law.

As for academic development, I have been able to improve my knowledge by attending four postgraduate courses, three of them lato-sensu (Public Law, Criminal Law, and Medical Law) and one stricto-sensu (Human Rights and Political Sciences), this last one with a deeper study of the stability institute for public agents¹.

Throughout my profession I had the opportunity to develop practical knowledge in advising authorities and also in private law (OAB/DF 24711). At the beginning of my career I was a parliamentary advisor in the Chamber of Deputies, having later advised the presidency of the Federal Council of Physiotherapy and Occupational Therapy, including internal disciplinary and ethical processes².

In private law practice, I have worked in many areas, where the two major areas were Real Estate Law, having been a lawyer for several building administrations and a chain of hotels, besides de Public Law, regarding mainly to the rights of federal agents³, ruled by the Federal Law No. 8112/90, including administrative disciplinary proceedings⁴.

There was also the opportunity to deepen knowledge and practice in the areas of data protection (LGPD) and also in conflict resolution methods⁵, having taught courses in several states in Brazil, participated in numerous mediations and helped in the construction of the mediation center of the Federal District Education Department.

More recently I was admitted as a lawyer regularly registered with the Portuguese Bar Association (OA 68717P), where I intend to develop and improve knowledge in International Law, with an emphasis on migration law and foreign nationality⁶.

With this, I hope to meet the expectations regarding the skills and competencies making myself available to create new professional ties, whether in an employment relationship or even in a partnership.
