Food Truck Applications & Payments Due by **February 1st, 2026.**

Prior to the Event:

- Food Truck Event Packets will be available April 2nd, 2026 at the event location.
- Food Trucks will receive a packet containing a grounds map with their food truck spot marked, food truck bracelets for entry and a parking tag for expedited entry on event days — **no bracelets or parking tags will be replaced.**
- Provide proof of current permit from Guilford County Department of Health and a list of the items being sold from the truck no later than February 1st, 2026.

At the Event:

- Food Trucks must be in place with set up completed by Friday, April 3rd at 12 noon.
- All food trucks must remain in place each day. Under no circumstance may a vehicle move within the show grounds during the event.
- Food Trucks must collect their own waste at their location; a dumpster will be available on site and event staff will make multiple pick-ups through out each show day.
- Cardboard boxes must be broken down and trash must be bagged.
- Potable water is NOT available on site. Any vendor serving food must supply their own water for food preparation activities.
- Generators are provided!
- **Bracelets MUST be worn & parking tags in vehicles for admission. No Bracelet or parking pass = NO Entry.**
