- The agreement shall be subject to prior Russo Fuel and Propane, Inc. inspection and approval of customers heating equipment as suitable under this plan.
- All fuel oil MUST be supplied by Russo Fuel and Propane, Inc. and account must be on AUTOMATIC DELIVERY.
- This agreement shall automatically renew itself and the unused portion will not be refunded.
- Buyer agrees not to hold Russo Fuel and Propane, Inc. responsible FOR ANY WORK on chimney, piping, ducts, radiators, boiler, furnace, boiler or furnace accessories, fan or for any portion of the heating system which is not part of the oil burner.
- Buyer agrees not to hold Russo Fuel and Propane, Inc. liable for any failure of the burner or equipment, nor for damages resulting from delays or inability to perform service or supply parts caused by or resulting from any cause not reasonably within its control.
- Russo Fuel and Propane, Inc. reserves the right to cancel this agreement and to reimburse buyer after inspection of the burner or burners involved, within 30 days after receipt of payment.
- Under agreement, Russo Fuel and Propane, Inc. shall not be responsible for replacing parts damaged by water, fire, an act of God, accident, tampering or abuse.
- Russo Fuel and Propane, Inc. will not be responsible for repairs, secondary damages, tank leakage or for supplying products if tampered with or caused by fire, wars, riots, Government acts or requests, acts of God, or any other situations beyond its control. If for any reason Russo Fuel and Propane, Inc. supplies commodities of the kind deliverable hereunder such period shall at its option be reduced as Russo Fuel and Propane, Inc. may determine to apportion fairly among its customers, the commodities of the kind deliverable hereunder then in storage, and such quantity as Russo Fuel and Propane, Inc. may receive from any other existing sources of supply, shall not be obligated to obtain or purchase other supplies of the commodities of the kind deliverable hereunder, Russo Fuel and Propane, Inc. shall not be required to make up deliveries omitted on account of any such case.
- Russo Fuel and Propane, Inc. is not held responsible for heat in unoccupied buildings. This agreement does not cover service resulting from lack of fuel due to deliveries withheld by the credit department or will call customers.
- All invoices must be paid within credit terms or this agreement will be cancelled without refund.
- Russo Fuel assumes no responsibility to notify any government agency including the EPA in the even of tank leakage causing contamination of the earth.
- Any person other than a Russo Fuel and Propane Inc employee rendering repairs or adjustments to the equipment may void this agreement.
- The agreement is not assignable without Russo Fuel's consent.
- Fuel issues related to outside storage of fuels is not covered under this contract.
- Russo Fuel reserves the right to determine eligibility or continuance of service by age or condition of equipment.
