• Violations of BOP Internet Usage Policy by using social media accounts daily (Facebook, Instagram, X/Twitter, TikTok)

• Violations of BOP Policy by conducting businesses, earning profits and soliciting donations from prison directly and by utilizing third parties (Tami Springer, Amy Fooladi, JT Barnett, and possibly others) to impersonate him on social media and to send fraudulent autographed signed photographs in exchange for money, for example.

• Violations of BOP Contraband Policy by possession of or access to contraband cell phone on a daily basis.

To Whom It May Concern: It should be brought to your attention the above referenced incarcerated individual is still in possession of or still has access to a contraband mobile phone in which he uses to access at least one or all of his social media accounts daily and conducts business daily, including but not limited to making money through selling products through his website, selling promotional/endorsements and interviews, asking for donations for various things including for food he says he's not receiving in prison, and various other business related schemes.

Further, he utilizes the email account he has access to at the prison to conduct business with his Power of Attorney, Tami Springer, and direct her on what to do with respect to his business affairs and what to post on his social media when she logs into and posts on his behalf.

Additionally, the main person in his business that he directs from prison, is Amy Fooladi. She is the main social media poster and logs

into all of his social media accounts and together with Tami Springer & JT Barnett. For the last two years, they have harassed the victims and witnesses that were involved in Joseph's case. They also harass anyone that questions the validity of what they are doing. They continue to post and attack the current and former President, Joe's former attorneys, sports stars, former boyfriends and husbands, former employees, family members, continued harassment of Carole Baskin (the very person he's convicted of "murder for hire" plot) and others.

He's using his social media accounts for absolutely nothing positive and to allow continued access to these accounts will only enable Joseph and his team to further promote hate and pain in the lives of so many people he's already caused so much pain to. In fact, he's harassing the State's main Confidential Informant James Garretson and others who helped put this man in jail. We have all put up with his harassment for long enough.

We know what he's doing by conducting a business from prison and directing others to log into his social media accounts and post on his behalf most of the time, using a contraband phone illegally, and harass people daily with no consequences is simply wrong. It's time he is stopped. Please hold him responsible. Please shut down all of his social media accounts immediately. Please take away his contraband mobile phone.
