Dear Mr. Kirkland:

I represent Francisco Hernandez. Mr. Hernandez is Board Certified in Criminal Law by the Texas Board of Legal Specialization (since 2003) and has practiced in Tarrant County for over 32 years. Mr. Hernandez served as Chairman of the Texas Ethics Commission, appointed by Governor Rick Perry in 2001 and was elected Chairman in 2005. Former-Mayor Mike Moncrief appointed Mr. Hernandez to the Fort Worth Ethics Review Commission in 2010 where he served until 2014. Mr. Hernandez also served on the DFW International Airport Board of Directors from 2006 through 2015, serving as Chairman in 2011. Besides the above appointments, Mr. Hernandez has received numerous awards and recognition for his community involvement.

The grievance against Mr. Hernandez appears to have been submitted on behalf of Joseph Maldonado-Passage, a.k.a. the "Tiger King" from the Netflix documentary of the same name, by his purported power-of-attorney, Tamara Springer. Mr. Maldonado-Passage is incarcerated in federal prison after being

convicted for a murder-for-hire attempt on a business rival, Carole Baskin, killing five tigers, selling tiger cubs, and falsifying wildlife records.

Mr. Hernandez was hired by Mr. Maldonado-Passage's former power-of-attorney, Anne Patrick,² in April 2020 to assist with a motion to set aside Mr. Maldonado-Passage's sentence and a pardon application to then-President Donald Trump. The grievance admits that *Mr. Hernandez received no money from Mr. Maldonado-Passage*. Mr. Hernandez ceased representing Mr. Maldonado-Passage in November 2021, shortly after Mr. Maldonado-Passage retained new counsel, John Phillips, to assist Brandon Sample, another attorney, with appealing Mr. Maldonado-Passage's conviction and civil lawsuits against various individuals. [*See* Exs. 13, 16].

The information sheet submitted along with the grievance contains numerous inaccuracies and falsities:

1. The grievance is purportedly filed by "Mr./Ms. Joseph Maldonado-Passage." As explained above, it appears that the grievance was submitted by Ms. Springer since Mr. Maldonado-Passage is currently incarcerated. And, there is no "Ms. Maldonado-Passage."—Mr. Maldonado-Passage is legally married to Mr. Dillon

Passage). N.C. Gen. Stat. §32C-1-105 (West 2021). The principal's signature is presumed to be genuine if the principal acknowledges the signature before a notary public. *Id.* Mr. Maldonado-Passage's signature on the power of attorney is not properly acknowledged and therefore fails to give any authority to Ms. Springer. Additionally, the power of attorney does not authorize Ms. Springer to file this grievance against Mr. Hernandez. *See id.*, at §32C-2-212 (list of "claims and litigation" under control of power-of-attorney does not include grievance proceedings).

² Ms. Patrick served as Mr. Maldonado-Passage's power-of-attorney from some time in 2020 through November 2021. Upon information and belief, Ms. Patrick was removed as power of attorney around the same time Mr. Hernandez ceased representing Mr. Maldonado-Passage. [See Ex. 2].

Passage. Ms. Springer does not purport to have power-of-attorney for Dillon Passage;³

- 2. The contact information listed for Mr. Maldonado-Passage, including address, phone number, and email address, is all for Ms. Springer; and
- 3. Mr. Hernandez was hired in April 2020, not March 2020, by Mr. Maldonado-Passage's former power-of-attorney, Anne Patrick, to work on Mr. Maldonado-Passage's post-conviction motion to set aside his sentence and his pardon application, not for the direct appeal of his conviction.⁴

The narrative grievance also contains false statements about Mr. Hernandez's representation of Mr. Maldonado-Passage, his interactions with Dillon Passage, and handling of Mr. Maldonado-Passage's IOLTA account, each of which are addressed below. Additionally, the grievance asks the Chief Disciplinary Counsel to return Mr. Maldonado-Passage's "car of \$33,000 to cover the lien and the \$10,000 in cash [Mr. Hernandez] hid in his law firm trust account." The grievance system cannot provide this requested relief.⁵

⁴ At Mr. Maldonado-Passage's request and insistence, Mr. Brandon Sample handled the direct appeal briefing and all decisions concerning any briefing issues. Mr. John Phillips later took over that role, although both attorneys remain counsel of record for the direct appeal for all purposes.

[or] substitute for civil or criminal remedies."). Additionally, Mr. Phillips has threatened litigation against Mr. Hernandez related to these same allegations.

While representing Mr. Maldonado-Passage, Mr. Hernandez did not engage in self-dealing or self-promotion or mishandle IOLTA funds. The underlying facts and Mr. Hernandez's responses to the specific complaints will show that Mr. Hernandez did not violate any Texas Disciplinary Rules of Professional Conduct, and Mr. Hernandez's actions do not support a determination of Just Cause as defined in the Texas Rules of Disciplinary Procedure.

I. Background

After Mr. Maldonado-Passage was convicted of murder-for-hire, killing and selling tigers, and falsifying wildlife records in January 2020, Mr. Maldonado-Passage's power-of-attorney, Anne Patrick worked to find an attorney to assist—for free—with Mr. Maldonado-Passage's motion to set aside his sentence and a pardon application to then-President Donald Trump. Mr. Maldonado-Passage first sent Ms. Patrick the name of Eric Love, a self-described "Texas philanthropist and private investigator," who first contacted Mr. Hernandez on behalf of Ms. Patrick. [Ex. 3, p. 1]. In April 2020, Mr. Hernandez agreed to help represent Mr. Maldonado-Passage *for free* related to the motion to set aside his sentence and pardon application. Shortly thereafter, Mr. Hernandez set up an IOLTA account to handle funds on behalf of Mr. Maldonado-Passage. Frequently, Mr. Maldonado-Passage or Ms. Patrick would direct Mr. Hernandez to transfer money from the IOLTA to Dillon Passage (Mr. Maldonado-Passage's current spouse) for living expenses, to Ms. Patrick to pay for bills and expenses, and other persons working on behalf of Mr. Maldonado-Passage.

Until January 2021, Mr. Hernandez worked tirelessly on Mr. Maldonado-Passage's campaign for a pardon, including writing the application itself, publicizing Mr. Maldonado-Passage's wrongful conviction to the public, and communicating with President Trump's advisors. Mr. Maldonado-Passage encouraged Mr. Hernandez and others working on the pardon to hold press conferences and increase the social media presence. On four occasions, Mr. Maldonado-Passage asked Mr. Hernandez to travel to Washington D.C. for press conferences, to deliver the pardon application, and attend pro-Trump rallies. [*E.g.*, Ex. 4 ("Press, Press, Press, get on

TV."); Ex. 5 ("[Y]ou must ride this wave in the press."); Ex. 6 ("[S]o if everyone is willing to fly to DC to put this on Thursday take my money to get the plane tickets... just a simple National Press Conference infront [sic] of the White House....")]. Tellingly, on January 6, 2021, Mr. Maldonado-Passage emailed Mr. Hernandez saying: "Let everyone know that went to DC I said thanks, and I saw the plane on channel 11 with ya all [sic] and rink...." [Ex. 7].

In 2020, Netflix and its production company, Goode Productions, began work on Tiger King 2, which focused, in part, on Mr. Maldonado-Passage's efforts to get out of jail. On several occasions, Netflix and Goode Productions asked for Mr. Hernandez to sign a release to appear in Tiger King 2. [Exs. 8, 9]. Mr. Hernandez refused to sign the requested release due to his on-going representation of and loyalty to Mr. Maldonado-Passage. The below email evidences Mr. Hernandez's refusal: "I wanted to let you know that I refused to sign the release...." [Ex. 10]. In response to Mr. Hernandez's email, Mr. Maldonado-Passage encouraged Mr. Hernandez to "get your butt on tv and make a name for yourself, and if Rebecca⁷ wants to pay you take it Fran, Please, if your to [sic] proud to take it, take it and give it to EZ [nickname of Mr. Hernandez's legal assistant] or donate it to the innocent [sic] project."

JOSEPH MALDONADO-PASSAGE on 10/12/2020 9:50:56 AM wrote man, get your butt on tv and make a name for yourself, and if Rebecca wants to pay you take it Fran, Please, if your to proud to take it, take it and give it to EZ or donate it to the innocent project or something but she has made so much money off of me,

Jeremy Gordon reached out to me, I gave him your numbers

——Hernandez, Fransico on 10/12/2020 7:41 AM wrote:

>

I want to let you know that I refused to sign the release they want me to sign and the members of the team. They have not offered nor do we want any compensation for it. But they keep insisting. I didn't ask to be on the show and I only agreed to film because Eric and Anne asked me to. None of my team wants to be a movie star. We're only working for you

[*Id.*]. Contrary to the complaint, Mr. Maldonado-Passage *wanted* Mr. Hernandez to appear in Tiger King 2 and wanted Mr. Hernandez to get paid for his appearance. Mr. Hernandez did not represent Mr. Maldonado-Passage to "make a name" for

⁷ "Rebecca" referenced in Mr. Maldonado-Passage's email is Rebecca Chaiklin, a producer on Tiger King 2.

himself on television or make money—Mr. Hernandez declined both because Mr. Hernandez prioritized representing his client. [Ex. 10].

In January 2021, after President Trump did not pardon Mr. Maldonado-Passage, Mr. Maldonado-Passage engaged John Phillips, an attorney based in Florida, to take over for attorney Brandon Sample, handling the appeal of his conviction, plus a variety of other matters. Unlike Mr. Hernandez, Mr. Phillips was compensated for his representation of Mr. Maldonado-Passage and contracted for half of the royalties from Mr. Maldonado-Passage's tell-all memoir, released in November 2021. [See Exs. 12, 16]. Admittedly, Mr. Hernandez and Mr. Phillips frequently butted heads related to the defense strategy and differences in approach to the media. For example, contrary to Mr. Hernandez, Mr. Phillips signed a release to appear in Tiger King 2.9 [Ex. 13]. Mr. Hernandez and Mr. Phillips also disagreed about Mr. Phillips's simultaneous representation of Mr. Maldonado-Passage and Jeff Lowe, 10 who actively conflicted with Mr. Maldonado-Passage over trademark issues. [Ex. 14]. Mr. Hernandez voiced his concerns about Mr. Phillips's conflicts of interest to Mr. Maldonado-Passage on several occasions, which soured Mr. Hernandez's relationship with Mr. Phillips and ultimately Mr. Maldonado-Passage. As stated above, Mr. Phillips still represents Mr. Maldonado-Passage.

During the first couple years of Mr. Maldonado-Passage's time in prison, Mr. Hernandez managed Mr. Maldonado-Passage's money through an IOLTA. Funds were deposited into the account from promotional deals, including for the Tiger King

¹⁰ Upon information and belief, Jeff Lowe helped the government convict Mr. Maldonado-Passage for murder-for-hire.

2 documentary, Mr. Maldonado-Passage's book deal, and music royalties, ¹¹ as well as donations from fans. Mr. Maldonado-Passage ¹² and his former power-of-attorney Anne Patrick directed withdrawals from the account, in part, to pay for living expenses for Dillon Passage and Anne Patrick and for expenses to maintain the "Tiger King" brand. Unbeknownst to Mr. Hernandez, some payments that Mr. Maldonado-Passage directed Mr. Hernandez to make were cloaked payments for drug transactions in the prison. Indeed, Mr. Maldonado-Passage would lie to Mr. Hernandez, referring to the payments as expenses for tiger food, among other descriptions:

JOSEPH MALDONADO-PASSAGE on 2/27/2021 2:20:48 PM wrote please let me know when you send Donna the money for food for my cats and whos name sent if please.

[Ex. 21]. Mr. Hernandez only learned of the true nature of these payments in September 2021, when Mr. Maldonado-Passage was caught in prison with a burner phone and admitted the practice to Mr. Hernandez. Of course, Mr. Hernandez told Mr. Maldonado-Passage to cease facilitating the drug payments and told the situation to Mr. Phillips, Mr. Maldonado-Passage's other attorney. Mr. Maldonado-Passage was angry with Mr. Hernandez over the confrontation and disclosure to Mr. Phillips, and Mr. Maldonado-Passage's relationship with Mr. Hernandez continued to sour until Mr. Hernandez ceased representing Mr. Maldonado-Passage in November 2021.

¹¹ Bradley Small, who represented Mr. Maldonado-Passage related to licensing deals, confirmed that Mr. Hernandez "did not make any entertainment/licensing deals, nor did he take any monies from [Mr. Maldonado-Passage] as payment." [Ex. 46].

¹² There are a substantial number of emails from Mr. Maldonado-Passage (from jail) to Mr. Hernandez directing Mr. Hernandez to use funds from the IOLTA account for various expenses. [*E.g.*, Exs. 17, 18, 19, 20].

¹³ Mr. Hernandez also advised Ms. Patrick and Ms. Springer to cease participating in any more cloaked transactions and to keep all proof of the financial activity. Mr. Maldonado-Passage was to be re-sentenced, and Mr. Hernandez feared this activity would enhance Mr. Maldonado-Passage's sentence.

In March 2022, Mr. Maldonado-Passage filed for divorce from Dillon Passage in Florida, which is still pending. ¹⁴ In the divorce proceeding, it is believed, based on the filings, that a main issue will be the amount of financial support Mr. Maldonado-Passage provided to Dillon Passage during the marriage and Mr. Maldonado-Passage's alleged personal property that Dillon Passage disposed of, including the Dodge Challenger¹⁵ and revolver. Many of the complaints involving Mr. Hernandez will be litigated in the divorce proceeding, likely over the next several years.

Mr. Hernandez will now respond to each complaint in detail to show he did not violate any Texas Disciplinary Rule of Professional Conduct.

II. Responses to Complaints

The complaint focuses on four issues: (A) alleged transactions with Dillon Passage, including the purchase of a Dodge Challenger and revolver; (B) promotion efforts; (C) funds in Mr. Hernandez's IOLTA account; and (D) outsourcing legal work to other attorneys. The complaint does not identify the Texas Disciplinary Rules of Professional Conduct that Mr. Hernandez allegedly violated. However, it seems like the complaint may attempt to allege violations under Disciplinary Rules of Professional Conduct 1.04, 1.08, and 1.14. Mr. Hernandez's responses show he did not violate any Disciplinary Rule, and his actions do not support a finding of Just Cause.

A. Dealings with Dillon Passage

The complaint alleges that Mr. Hernandez and "his friend Eric Love signed contracts with my ex-husband [Dillon Passage] making product deals, book deals, and hiding money in his law office trust account, sending my ex-husband thousands of dollars and loaning him \$13,000 more and repaying himself out of more product deals." The complaint also states that Mr. Hernandez purchased a car and a revolver from Dillon Passage. As shown below, (1) Jeff Hoover, another attorney representing Mr. Maldonado-Passage, *not* Mr. Hernandez purchased the revolver from Dillon Passage; (2) Mr. Hernandez purchased a car Dillon Passage owned and marketed for sale to others; (3) Mr. Hernandez did not sign any contracts with Dillon Passage; and (4) any payments made to Dillon Passage from Mr. Maldonado-Passage's IOLTA were authorized by Mr. Maldonado-Passage or his power-of-attorney. Any complaint about Mr. Hernandez relating to Dillon Passage is solely based on Mr. Maldonado-Passage's contempt for Dillon Passage, which is being litigated in their divorce proceedings.

Mr. Hernandez did not violate any Disciplinary Rule, and his actions do not support a finding of Just Cause related to Mr. Hernandez's dealings with Dillon Passage.


1. Mr. Maldonado-Passage's gun was sold to Jeff Hoover, not Mr. Hernandez.

The complaint alleges that Mr. Hernandez "bought [Mr. Maldonado-Passage's] S&W 357 revolver and custom holster from [Mr. Maldonado-Passage's] ex-husband [Dillon Passage] for \$1,500, when it was worth \$25,000." Mr. Hernandez did not purchase, and does not possess, the revolver and holster. [Ex. 22].

When Mr. Maldonado-Passage went to prison, Dillon Passage possessed Mr. Maldonado-Passage's personal property, including the revolver and the holster. In 2020, Mr. Maldonado-Passage sold the revolver and holster to a fan named Mike for \$700. Mike paid the \$700, but Dillon Passage refused to deliver the revolver and holster to Mike. Soon thereafter, Mike passed away and Dillon Passage maintained possession of the revolver and holster. [Ex. 23]. Prior to 2021, Dillon Passage held

an online auction of Mr. Maldonado-Passage's personal property, including the revolver. However, there were no bids on the revolver.

Because the revolver did not sell and as a "thank you" for all the work performed on his behalf, Mr. Maldonado-Passage and Mr. Maldonado-Passage's power-of-attorney, Anne Patrick, wanted to gift the revolver and holster to Jeff Hoover, another attorney representing Mr. Maldonado-Passage. [Ex. 24]. Mr. Hoover did not want a gift from Mr. Maldonado-Passage and insisted on paying \$1,500 for the revolver and an extra \$500 for the holster. [Id.]. Mr. Maldonado-Passage and Ms. Patrick knew that Mr. Hoover purchased the revolver and were pleased Dillon Passage was no longer in possession of it:



[Ex. 24); Ex. 26 ("[T]hank God you [sic] bought my gun or [Dillon Passage] would have sold it also.")].

Mr. Hernandez did not violate any Texas Disciplinary Rules of Professional Conduct related to the revolver and holster.

2. Mr. Maldonado-Passage gifted the car to Dillon Passage.

Mr. Hernandez did not violate any Texas Disciplinary Rule of Professional Conduct related to the used Dodge Challenger. The complaint alleges:

[Mr. Maldonado-Passage] had bought my husband at the time a Dodge Challenger for \$33,000 and had a lien on it for the full amount. In November of 2021, [Mr. Hernandez] came to the prison and had me sign the lien so he could put it in my name and scammed me out of my car, as he bought it for \$15,000, which is ½ of the lien I had. So he paid my ex-husband for the car... Then in November of 2021, right before Tiger King 2 came out, [Mr. Hernandez] wrapped the car with my trademark and took it around Dallas, Fort Worth to only benefit himself.

As the complaint admits, while in prison, Mr. Maldonado-Passage gifted Dillon Passage a used Dodge Challenger for his 25th birthday. [Ex. 27 ("[T]he car [Dillon] has now was paid in full for a birthday present last year.")]. Mr. Maldonado-Passage titled the car solely in Dillon's name. [Ex. 32]. Since Dillon Passage was irresponsible and had issues with driving while intoxicated, Mr. Hernandez suggested that Mr. Maldonado-Passage place a lien on the car, so, if necessary, Mr. Maldonado-Passage could get the car out of the auto pound without Dillon Passage's authorization (who held record title). [Exs. 28; 32]. The lien on the car proved useful on at least one occasion when the car was impounded after Dillon Passage was arrested for driving while intoxicated. [Ex. 29].

In fall 2021, Dillon Passage and Mr. Maldonado-Passage decided to get a divorce, and Dillon Passage planned to market the car to sell it to a third party. With Mr. Maldonado-Passage's knowledge and consent, Mr. Hernandez offered to give Dillon Passage a \$15,000 loan with the car as collateral—Dillon could pay Mr. Hernandez back by the end of 2021 to get the car back or keep the money. [Ex. 3]. Dillon Passage accepted this deal and delivered the car to Mr. Hernandez in September 2021. Mr. Maldonado-Passage knew about Mr. Hernandez's arrangement with Dillon Passage and did not object. [Ex. 30]. For example, Mr. Maldonado-Passage knew that Mr. Hernandez spent approximately \$3,000 of Mr. Hernandez's own money to wrap the car with the "Tiger King" logo to publicize Mr. Maldonado-Passage's upcoming book, Mr. Maldonado-Passage weighed in on the wrap design. [Ex. 34, pp. 2, 4; Ex. 35]. Anne Patrick, as Mr. Maldonado-Passage's power-of-attorney, also approved Mr. Hernandez's arrangement with Dillon Passage. [Ex. 3].

In October 2021, Dillon Passage decided that he wanted to keep the loaned money and transferred the car's title to Mr. Hernandez. And, Mr. Maldonado-Passage signed paperwork *releasing* the lien on the car, allowing Mr. Hernandez to own the car outright. [Ex. 33]. Later, Mr. Maldonado-Passage decided that he wanted to purchase the car back from Mr. Hernandez and allow his new boyfriend, Seth, or Ms. Patrick drive the car. [Ex. 30; Ex. 34, p. 2]. Mr. Hernandez told Mr. Maldonado-Passage he could purchase the car for what Mr. Hernandez had in the

¹⁶ Upon information and belief, Dillon Passage intended to forge Mr. Maldonado-Passage's signature to release the lien to sell the car to a third party.

¹⁷ By this time, Mr. Maldonado-Passage had spent the money in his IOLTA. Mr. Maldonado-Passage instructed his team, including Mr. Hernandez to market and support Mr. Maldonado-Passage's upcoming memoir, which was to be a source of future income for Mr. Maldonado-Passage. Mr. Maldonado-Passage indicated that the car was a good marketing opportunity for the book. [Ex. 3].

¹⁸ Both Mr. Maldonado-Passage *and Mr. Phillips* received advance payments from the book contract and financially benefitted from any publicity for the book. [Exs. 3, 12, 16]. Mr. Hernandez did not financially benefit from Mr. Maldonado-Passage's book. To the contrary, Mr. Hernandez, spent his own funds on the promotional materials and expenses for the book.

car, approximately \$30,000.¹⁹ Ultimately, Mr. Maldonado-Passage did not have enough money and did not purchase the car.

Contrary to the complaint, Mr. Maldonado-Passage only spent approximately \$25,000 to purchase the car. [Ex. 36]. In fall 2021, Mr. Maldonado-Passage acknowledged that the car was only worth between \$15,000 - \$18,000 and that Dillon Passage—the owner of the car—needed to be paid for it. [Ex. 30]. Mr. Maldonado-Passage's lien, which he willingly released, was not worth \$33,000.

Mr. Hernandez did not engage in a business transaction with Mr. Maldonado Passage. Mr. Maldonado-Passage gifted the car to Dillon Passage, making the car Dillon Passage's separate property. Texas Disciplinary Rule of Professional Conduct 1.08 prohibits *client* transactions and expressly does not apply to "commercial transactions...that the client generally markets to others." Tex. Disciplinary Rules Prof'l Conduct 1.08(a), (j). Mr. Hernandez did not represent Dillon Passage, and Dillon Passage generally marketed the car for sale to others before Mr. Hernandez bought it. Mr. Hernandez did not violate any Texas Disciplinary Rules of Professional Conduct related to the car.

3. Mr. Hernandez did not sign contracts with Dillon Passage.

The complaint alleges that Mr. Hernandez "and his friend Eric Love signed contracts with [Mr. Maldonado-Passage's] ex-husband making product deals, book deals, and hiding the money in his law office trust account." However, there are many falsities in that statement.

First, although Mr. Maldonado-Passage has filed for divorce, he is still legally married to Dillon Passage. As mentioned above, the on-going dispute between Mr.

Maldonado-Passage and Dillon Passage related to the financial support given to Dillon Passage during the marriage and the division of any community property is believed to be at the forefront of the divorce proceedings.

Second, Mr. Hernandez did not execute any contracts, product deals, or book deals with Dillon Passage. [See Ex. 46]. The complaint is confusing as Mr. Hernandez is a criminal defense attorney and is not a book publisher or a seller goods. Mr. Love did not execute any contracts with Dillon Passage either. And, in a text message to Mr. Hernandez, Mr. Maldonado-Passage admitted that "no contracts are in [Dillon Passage's] name and [Mr. Hernandez] have [sic] records of [Dillon's] payments." [Ex. 25].

Third, Mr. Hernandez did not hide any money in his IOLTA for Mr. Maldonado-Passage. Throughout Mr. Hernandez's representation of Mr. Maldonado-Passage, Mr. Hernandez provided information and updates about the money deposited into and withdrawn from the IOLTA. [*E.g.*, Ex. 37 (Mr. Maldonado-Passage: "hey, can you tell me what is in escrow" Mr. Hernandez: "about 50."); Ex. 24 ("there is about 4500 in the account)]. And, in January 2022, Mr. Hernandez provided Mr. Maldonado-Passage's attorney, John Phillips, with a detailed ledger of the money deposited into and withdrawn from the IOLTA, which is supported by approximately 500 pages of documentation. ²¹ [Ex. 38].

Mr. Hernandez did not violate any Texas Disciplinary Rules of Professional Conduct related to alleged contracts with Dillon Passage.

B. Mr. Maldonado-Passage routinely authorized support payments to Dillon Passage.

The complaint alleges that Mr. Hernandez "sen[t] my ex-husband thousands of dollars and loan[ed] him \$13,000 more and repaying himself out of more product deals." While Mr. Maldonado-Passage was in prison, he continued to financially support Dillon Passage. Mr. Maldonado-Passage and Ms. Patrick (former power-of-

attorney) frequently instructed Mr. Hernandez to send Dillon Passage money for rent, food, utilities, and miscellaneous expenses. [*E.g.*, Ex. 39 (rent payments); Ex. 40 (miscellaneous expenses); Ex. 18 ("Dillon is to always get 1500.00 on the 13th of each month....); Ex. 37 ("and don't forget Dillon on the 24th 3000.00 in case I am out of touch for any reason."); Ex. 19 ("Fran has been asked to take the money from escrow and get your car tags which is around 2600.00")]. Moreover, Mr. Hernandez never loaned Dillon Passage \$13,000.

Mr. Maldonado-Passage was frustrated with how reckless Dillon Passage was with Mr. Maldonado-Passage's money. For example, Mr. Maldonado-Passage complained to Mr. Hernandez and Ms. Patrick that Dillon Passage:

was supose [sic] to get 500 to get storage and gas money to go to Texas and 700.00 for insurance and money to live on at his sisters until we figure out something on this house deal. He is not paying rent right now and he is not paying a car payment, he goes and gets a 100.00 tattoo and buys his female friend a 200.00 make up mirror and then goes to atlanta [sic] for his manager and I have to pay that bill too.

[Ex. 41]. These issues will be properly addressed in Mr. Maldonado-Passage's divorce proceedings.

Any financial support provided to Dillon Passage out of Mr. Maldonado-Passage's IOLTA was requested and authorized by either Mr. Maldonado-Passage or Ms. Patrick. Mr. Hernandez did not violate any Texas Disciplinary Rule of Professional Conduct related to financial support payments for Dillon Passage.

B. Mr. Maldonado-Passage did not have \$10,000 remaining in his IOLTA account.

The complaint alleges that "[u]pon firing [Mr. Hernandez], there was over \$10,000 in the trust account as he told me there was in November and when I asked for it, he produced bills where he cooked the books...." Mr. Hernandez did not

inform Mr. Maldonado-Passage that there was \$10,000 left in the IOLTA in November 2021. Contrary to the complaint, at the end of Mr. Hernandez's representation, Mr. Maldonado-Passage's IOLTA was overdrawn by almost \$15,000, consisting of a payment to Mr. Phillips, Mr. Maldonado-Passage's new attorney, and payments to Ms. Patrick and Ms. Springer. [Ex. 38]. Mr. Hernandez paid for these expenses out of his own pocket and does not seek repayment by Mr. Maldonado-Passage. Tex. Disciplinary Rules Prof'l Conduct 1.08 (d)(1) ("a lawyer may advance or guarantee court costs, expenses of litigation or administrative proceedings, and reasonably necessary medical and living expenses, the repayment of which may be contingent on the outcome of the matter.").

Tamara Springer, Mr. Maldonado-Passage's alleged power-of-attorney and likely the person who submitted this complaint, emailed me (Roland Johnson) in February 2022 asking for the "status of the \$9,000 in his trust fund that [Mr. Hernandez] has not yet turned over to [Ms. Springer]." [Ex. 42]. As detailed above, Mr. Phillips was provided a ledger in January 2022, showing that there was no money left in the IOLTA. From February 2022 until the complaint in April 2022, the "amount remaining" in the IOLTA claimed by Ms. Springer inexplicably grew from \$9,000 to \$10,000 without any documentation whatsoever. Ms. Springer's inconsistencies show that she has no basis to claim there is money remaining in the IOLTA. Indeed, the complaint appears to be an effort to generate some much-needed cash.²²

Mr. Hernandez did not violate any Texas Disciplinary Rule of Professional Conduct related to the allegation that \$10,000 remain in Mr. Maldonado-Passage's IOLTA.

C. Mr. Hernandez did not engage in self-dealing or self-promotion.

The complaint claims Mr. Hernandez:

took it upon himself to rent a large bus and wrap it with my image and take it to Washington, D.C. to make a movie

for Tiger King 2 without my knowledge, then big limos, private jets, all to film with Tiger King 2. ... Then in November 2021, [Mr. Hernandez] wrapped the car with my trademark and took it around Dallas, Fort Worth to only benefit himself.

As seen above, on numerous occasions Mr. Maldonado-Passage instructed Mr. Hernandez and others to create publicity for Mr. Maldonado-Passage's pardon application and efforts to get out of jail. *Supra*, at 4-5. Mr. Maldonado-Passage knew about, and approved, the trips to Washington D.C. and the car wrap. [*E.g.*, Exs. 3, 6, 7, 34]. Mr. Maldonado-Passage did not pay for the large bus, limos, private jets, or the car wrap.

Specifically, Mr. Hernandez and other representatives of Mr. Maldonado-Passage, including Eric Love and Jeff Hoover, went to Washington D.C. on a few occasions to generate support and publicity for Mr. Maldonado-Passage's pardon application. For the first trip, Eric Love—using his own money—obtained the use of a large bus to drive to Washington D.C. with some of Mr. Maldonado-Passage's supporters. [Ex. 3]. Mr. Maldonado-Passage also authorized using his money in the IOLTA for plane tickets for Anne Patrick to join Mr. Love in Washington D.C. [Ex. 6]. Mr. Hernandez, at Mr. Maldonado-Passage's insistence, also traveled to Washington D.C. with Anne Patrick and Dillon Passage for a press conference:

[*Id*.].

Mr. Hernandez also traveled to Washington D.C. on January 6, 2021, to attend (what they thought) was simply a pro-Trump rally, to encourage President Trump to sign the pardon for Mr. Maldonado-Passage. Mr. Hernandez's friend offered to loan Mr. Maldonado-Passage's team his private jet to fly to Washington D.C., if Mr. Hernandez would cover the cost of gas and landing fees, which Mr. Hernandez and Mr. Hoover did. [Ex. 31]. Again, Mr. Maldonado-Passage knew about this trip and helped organize it:

this gives over a week to get going.

Treasa/Jim what you think?

[Ex. 43].

Regarding Mr. Hernandez's participation in Tiger King 2, Mr. Maldonado-Passage knows that Mr. Hernandez refused, repeatedly, to sign a release with the production company to appear in Tiger King 2. [Ex. 10 ("I want to let you know that I refused to sign the release they want me to sign and the members of the team. They have not offered nor do we want any compensation for it. But they keep insisting.")]. Mr. Maldonado-Passage acknowledged to the documentary producers that Mr. Hernandez and Mr. Hoover have "not nor will they sign anything giving you permission to use what you filmed with them." [Ex. 13]. However, Mr. Maldonado-Passage also encouraged Mr. Hernandez to "get [his] butt on tv and make a name for [himself]." [Ex. 10].

Ultimately, in March 2021, Mr. Maldonado-Passage needed money for a house payment and instructed Mr. Hernandez to authorize the production company to use footage of Mr. Hernandez related to the pardon application in exchange for depositing \$15,500 into *Mr. Maldonado-Passage's IOLTA*.²³ [Ex. 11]. Mr. Hernandez was not paid to appear in Tiger King 2:

Thanks

[Ex. 11]. Mr. Maldonado-Passage wanted Mr. Hernandez to appear in Tiger King 2 exclusively for Mr. Maldonado-Passage's financial benefit.

As previously stated, Mr. Hernandez did not use any of Mr. Maldonado-Passage's money to wrap Dillon Passage's car with the Tiger King book logo. *Supra*, at 12-13. Again, Mr. Maldonado-Passage knew about the car wrap and weighed in on the design. [*Id.*]. Mr. Hernandez spent his own money to wrap the car to publicize Mr. Maldonado-Passage's upcoming book, which Mr. Maldonado-Passage hoped to generate much-needed money. [*Id.*]. Mr. Hernandez had no financial interest in the book and did not benefit from wrapping the car.

Mr. Hernandez did not engage in self-dealing or self-promotion related to the trips to Washington D.C., appearing in Tiger King 2, or wrapping the car. Mr. Hernandez did not violate any Texas Disciplinary Rules of Professional Conduct.

D. Mr. Maldonado-Passage knew about and authorized outsourcing of legal work.

Contrary to the complaint, Mr. Maldonado-Passage knew about and authorized Mr. Hernandez to engage other lawyers to assist with the motion to set aside Mr. Maldonado-Passage's sentence, a mandamus, and other motions and research. In July 2020, Mr. Hernandez recounted to Mr. Maldonado-Passage some of the attorneys who were working on Mr. Maldonado-Passage's behalf:

Elliot Crawford in Oklahoma, Jim Zadeh, Sophia Maas, all worked on [a Motion and Petition in Intervention] and did a great job.... William Taylor is the Federal Court super lawyer. He ONLY works for lawyers. He is a good friend and is absolutely brilliant. I'm just letting you know some of the names of the folks working for you.... Phillip Hall, my associate, working on the Pardon with Victoria at Brandon's office. Jeff Hoover, my best friend since 1984, co counsel and keeps track of your file. Jeff paid all the expenses for the Bus and Trump Hotel for the Washington DC trip.

[Ex. 44]. To which Mr. Maldonado-Passage replied:

I cannot thank you enough and you really don't know me yet but you will see I am a guy that will never forget what you have done for me, you get me out of here and life will be great for all of you, I will make sure that happens....

[*Id*.].

Another time, Mr. Hernandez told Mr. Maldonado-Passage to review legal research performed by William Taylor:

if you still have the research that my friend William Taylor did, take a look at it again and tell me what you think. He put a lot of work into that. if you no longer have it, I will send again.

[Ex. 45]. In response, Mr. Maldonado-Passage acknowledged that other attorneys were performing work on his behalf, writing: "I sent that paperwork back to you I think that your friend did." [Id.].

Mr. Maldonado-Passage knew, and approved, that Mr. Hernandez outsourced legal research and writing to other attorneys. Mr. Hernandez did not violate any Texas Disciplinary Rules of Professional Conduct related to the outsourcing of legal work to other attorneys.

III. Conclusion

Mr. Hernandez acted in the best interests of his client, Mr. Maldonado-Passage. Mr. Hernandez did not self-deal or self-publicize and did not engage in improper transactions with Mr. Maldonado-Passage. Mr. Hernandez did not purchase Mr. Maldonado-Passage's revolver, and Mr. Hernandez purchased the car from Dillon Passage, Mr. Maldonado-Passage's husband, who owned the car. Any dispute about the proper owner of the revolver and the car should occur in Mr. Maldonado-Passage and Dillon Passage's divorce proceeding. Additionally, Mr. Maldonado-Passage or his former power-of-attorney, Anne Patrick, authorized withdrawals from Mr. Maldonado-Passage's IOLTA. No money remains in the IOLTA to distribute.

Mr. Hernandez requests that you find there is no Just Cause to believe professional misconduct occurred. Mr. Hernandez requests that you refer this complaint to the Summary Disposition Panel in Tarrant County for dismissal. If this matter proceeds, Mr. Hernandez requests that any proceedings occur in Tarrant County.

To comply with Rule 2.10 of the Texas Rules of Disciplinary Procedure, which requires a copy of Mr. Hernandez's response to be sent directly to the Complainant, I have sent a copy of this response to the email address provided in the Complaint (joeexoticusa@yahoo.com). However, upon information and belief, Mr. Maldonado-Passage may not have access to that email address. Please let me know if I need to forward Mr. Hernandez's response to Mr. Maldonado-Passage in another manner.

Thank you for reading Mr. Hernandez's response and your service to our citizens and the Bar. Mr. Hernandez respectfully reserves the right to provide additional information in the resolution of this Complaint. Please let me know if you have specific questions.

This power of attorney authorizes another person (your agent) to make decisions concerning your property for you (the principal). Your agent will be able to make decisions and act with respect to your property (including your money) whether or not you are able to act for yourself. The meaning of authority over subjects listed on this form is explained in the North Carolina Uniform Power of Attorney Act.

This power of attorney does not authorize the agent to make health care decisions for you.

You should select someone you trust to serve as your agent. Unless you specify otherwise, generally the agent's authority will continue until you die or revoke the power of attorney or the agent resigns or is unable to act for you.

Your agent is entitled to reasonable compensation unless you state otherwise in the Additional Provisions and Exclusions.



My name is Anne Patrick and this is my statement in response to Joseph's complaint. So let's start with the beginning of his crock pot complaint. Francisco was hired in April 2020, not March of 2020.

First, let's be clear, I was not a "friend" as he states. I was his Power of Attorney.

Joseph specifically asked me to look for and hire an attorney during his 89-day lockdown in jail.

Joseph sent me Eric Love's name and told me to call him. Eric Love is the one who contacted Francisco, for me. Francisco was the only one that I could find that would take the case without a huge retainer. In fact, Francisco and Eric put together a team of volunteer lawyers and fans who wanted to help.

Francisco even got Mike Ware and Allison Clayton, Founder and Executive Director of the Texas Innocence Project, respectively, to come on the team (in their individual capacities) and handle the Direct Appeal, the Presidential Pardon Application, a Rule 33 Motion for New Trial and a 2255 if necessary.

However, Joseph insisted that Francisco bring Brandon Sample onto Team Tiger instead of following Francisco's recommendation. Brandon is a lawyer who served Federal Prison Time and was married to a man. But, during the time for briefing Joseph's appeal, Brandon had an affair with his 20 year old assistant, his husband divorced him and during this drama, Brandon went AWOL. In the end, Brandon filed a brief with two sentencing issues. He did not brief the issue of whether the Judge should

have severed the counts in a superseding indictment. That issue was perfectly preserved by the Public Defenders and was never brought up by Brandon or even John Phillips, Joseph's current attorney. Francisco even wrote letter briefs for Joseph to send on the issue so it would not be automatically waived.

Brandon also asked Joseph to let him handle the Pardon Application because of his connections at the Office of Presidential Pardons. Once Brandon went AWOL, Francisco and his team had to start from scratch.

To be clear, Francisco had the two leading lawyers for the Texas Innocence Project ready and committed to handle the Direct Appeal, the Pardon Application, Rule 33 Motion for New Trial and even a 2255 Post Conviction Writ. All three times, Joseph went against Francisco's advice.

After the Direct Appeal Oral Argument, Joseph asked Francisco to bring John Phillips onto the team. This was the third time that Joseph declined Francisco's advice to bring on Mike Ware and Allison Clayton.

We now know that it was Rebecca Chalkin, an executive producer for the Netflix documentary "Tiger King," that urged Joseph to bring on John Phillips because Francisco and all of the members of Team Tiger refused to participate in the filming and promotion of Tiger King 2.

John Phillips later told Francisco that he had a contractual agreement with Goode Productions, the production company for Tiger King 1 and Tiger King 2, and was

obligated to cooperate with them. Francisco was concerned about the potential conflict of interest for John Phillips to also have a contractual agreement, in exchange for consideration, with the producers of Tiger King 2.

This is where the relationship went south. John Phillips began poisoning Joseph telling him that Team Tiger had spent all of his money and were only pursuing fame.

Francisco never took it upon himself to rent a giant bus, private jet, or anything else. Eric Love did that. Plus, use of the bus and jet were donated by friends. All this was done because Joseph told me, as his power of attorney, to keep him front and center in the media. I was to make sure that he stayed in the news at all times after Tiger King 1 so he could make money and get a pardon from Donald Trump the President at the time. Francisco and I continually told Joseph that we were not participating in Tiger King 2.

Joseph, at his insistence, kept speaking to Rebecca Chaklin and Eric Goode, the producers of Tiger King 1 and Tiger King 2, making sure they showed up everywhere Francisco was, at Joseph's insistence.

At no time did any of us want to deal with Goode Productions or participate in Tiger King 2. We were doing as Joseph Maldonado-Passage insisted we do with big limos and jet stuff. Again, this was all at Joseph's insistence, and cost him nothing. Not one penny did Joseph spend on any of this. This all came out of the pockets of Eric Love, Francisco Hernandez, and anybody else who was putting in money and volunteering.

As far as this signing contracts, Joseph says then Francisco and his friend Eric Love signed contracts with Joseph's ex-husband Dillon Passage. Francisco has never in any way shape or form signed any contracts for product deals, book deals, hidden money, any of this stuff. Every single penny was approved through me, Anne Patrick, which also was approved through Joseph; including the birthday present of the \$33,000 car that Joseph insisted I approve for Dillon's 25th birthday. Francisco never loaned Dillon \$13,000, and Dillon had no participation in any product deals. I have no idea what Joseph is talking about. Dillon had no participation in any deals whatsoever. Neither did Francisco Hernandez. Neither did Anne Patrick. Not one of us received one penny from any deals Joseph had. Every single penny went to Joseph

The car, the \$33,000 Dodge Challenger that Joseph is referring to was a birthday present to Dillon. Later when they were trying to get divorced, Dillon's only request was that he got the Challenger, which was his birthday present. So Joseph took the lien off so that he could have the car in the divorce. But then Joseph kept changing his mind and saying no, he wasn't going to sign the divorce papers.

Francisco never bought the car for \$15,000. With my approval as power of attorney for Joseph, Francisco loaned \$15,000 to Dillon Passage, saying that if Dillon did not pay back the \$15,000 by December 31, 2021 that Francisco was to keep the car. Dillon did not want the car. He wanted to be away from Joseph and didn't want to have anything to do with Joseph anymore.

Francisco Hernandez wrapped that Challenger after he got it from Dillon Passage. Joseph told myself, Anne Patrick, and Francisco Hernandez, that we had to, "play nice" with John Phillips, his new attorney. Since John Phillips was being paid through the profits from Joseph's book, the car was wrapped as a promotion to help promote the book and get more money out of it. Because again, Joseph told us to play nice, and that was what we were all trying to do, So, Francisco Hernandez never benefited one penny, from wrapping of that car. Again, I don't know where Joseph Maldonado-Passage was getting all of this nonsense.

As far as the custom gun and holster, those were already sold at one point for \$700 to a guy named Mike from the Tiger King truck stop. Mike has passed away since then. Dillon never got a chance to drop off the gun to Mike, but Joseph received \$700 for the gun. The gun belonged to Dillon as it was in Dillon's possession. Dillon was giving the gun to Jeff Hoover as a gift for all the help and work that he did for Joseph. Dillon needed rent money, so Jeff gave him \$1,500 to pay his rent, out of the goodness of his heart. Dillon was giving him the gun that belong to Dillon because Joseph had already sold it and got the \$700. It was never worth \$25,000, I have no idea where Joseph's getting that number. We could not even get one bid on it when we previously put it up for auction on the NFT. Zero bids on the NFT for the gun. So where he's getting \$25,000, again is an imaginary number that he's making up.

Regarding the money in the IOLTA, there was not \$10,000 remaining. In fact, there was barely enough money. Joseph was supporting a new boyfriend names Seth, sending him rent and car money, sending Tamara Springer money, and sending thousands of dollars at a time to John Graham, another prisoner who Joseph had a relationship with. So there was not money in the account. Joseph got every penny of the money and actually, more money, than was in the account.

As far as Francisco producing bills, and this nasty allegation about cooking the books, we have every single penny accounted for. I have every email, every voice recording, every screenshot of every penny that was sent to Joseph, sent to people for Joseph that Joseph approved.

Joseph Maldonado-Passage approved every single transaction of funds. And I made sure that he wrote it all in emails and messages. And Francisco Hernandez never paid anyone without my approval, through text message or email. Again, my name is Anne Patrick, I was at the time Power of Attorney for Joseph Maldonado Passage. Francisco Hernandez never did business with Joseph's ex-husband, Dillon Passage. If Dillon sold, Joseph Maldonado-Passage's belongings, that had nothing to do with Francisco Hernandez, that is between Joseph Maldonado and Dillon Passage. Regarding the lien on the Challenger, Francisco was to take the lien off, so that Dillon would give Joseph a divorce because Joseph was already in a relationship with another inmate. The

\$10,000 in cash that Joseph's alleging was hidden, was never hidden. He spent all of his own money. And he spent my money that he never paid back.

Joseph Maldonado approved every single transaction. But as power of attorney, I was responsible. I approved all of the transactions through Joseph, and I approved them all with Francisco.



To whom it may concern:

I'm a partner in the Los Angeles office of the national law firm Fox Rothschild LLP. I was engaged by Joseph Maldonado-Passage ("Client") to work with Client as entertainment counsel, and and watch over, negotiate, and review intellectual property and entertainment property opportunities commencing early-September, 2020.

My law firm and me terminated our representation of Client by letter in early-February, 2022. Initially, I was hired while at my prior law firm to handle all of the entertainment and licensing property transactions for Client. In my experience, we must have negotiated 20 or so contracts licensing his name and likeness in the costume, gaming, cannabis, book, and television spaces. Some produced income and some did not.

Mr. Francisco Hernandez predated my representation was local counsel in Texas and handled many matters for Client, primarily pardon related, but did not make any entertainment/licensing deals, nor did he take any monies from Client as payment.

In my experience, Client never looked inward, but always looked outward, and blamed others for all circumstances. The most salient unethical and wrongful act I saw Client do was in not paying the ghostwriter of his book when Client had the money to do so and simply wanted to keep the money for himself - the collaborator/ghostwriter Tom Flannery was and is owed \$20,000.

After I finished a cryptocurrency deal in which coin makers developed a Tiger King coin (TKING), Client used another attorney to force the coin developers, demand them, for \$250,000 with threats

of bad publicity and other threats, to pay that money in cash or in other consideration. Although our our law firm is and was due 15% (\$37,500 in this deal) from deals we negotiated for Client, we were not paid or compensated our legal fee whatsoever in that transaction.

Over the course of several years, I found in working and then observing Mr. Hernandez that he was always professional, ethical, and I have nothing but positive things to say about him and his law firm.

My review of the grievance filed by Mr. Maldonado-Passage is that it is without merit.
