PRESIDENT'S REPORT: The Bobcat and the Ford Truck have been repaired and ready for use. Pool motors have been purchased and installed.

CFO's REPORT: Approval by Board of Directors was required for three delinquent accounts to move forward with recording Liens on the properties. Vote was unanimous.

MAINTENANCE REPORT: As discussed in our previous meetings, the reserve studies for our water system, paving, water lines and vehicles indicate that we are only 3.2 % funded. The Browning Reserve Study recommends that we immediately increase our reserve in order to ensure a safe community now and in the future. Several suggestions have been proposed, but no immediate changes are planned. Copies of the reports conducted by the Cranmer Engineering Services should be available in the MM website soon.

Information is being collected to apply for grants or other assistance.

Pedro also mentioned that the water board is compiling a requirement regarding anti- siphon valves to prevent water back flow. More information about certification is coming soon.

Tree removal problems were discussed. PG&E has been felling large trees but have failed to remove them causing safety issues.
