

ARTICLES OF INCORPORATION OF
MERRY MOUNTAIN OWNERS' ASSOCIATION, INC.
A California Corporation

I. The name of this corporation shall be MERRY MOUNTAIN OWNERS' ASSOCIATION, INC.

II. (a) The purposes for which this corporation is formed are:

1. To acquire, own, hold and deal with any and all kinds of property for recreational purposes for the members of this corporation.
2. To acquire by gift, purchase or otherwise, and to own, hold, construct, develop, maintain and deal with in any way, roads, streets, trails, paths, walkways, and the like throughout Merry Mountain Village Sub-division and other adjacent, contiguous or nearby lands.

(b) The general purposes and powers are:

1. To carry on any other business or activity necessarily or impliedly incidental to or in any way connected with the foregoing purposes.
2. To have and to exercise all the powers conferred by the laws of California upon corporations formed under the laws pursuant to and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended.

The foregoing statement of purposes shall be construed as a statement of both purposes and powers, and the purposes and powers stated in each clause shall, except where otherwise expressed, be in nowise limited or restricted by reference to or inference from the terms or provisions of any other clause, but shall be regarded as independent purposes and powers.

III. The County in the State of California where the principal office for the transaction of business of this corporation is to be located in the County of Butte.

IV. This corporation is organized pursuant to Part 1 of Division 2 of Title 1 of the Corporations Code of the State of California.

The By-laws to be adopted by the corporation shall provide for the authorized number and qualifications of the members of the corporation, the classes thereof, the voting and other rights and privileges of such members of classes thereof, and the liability of such members to dues and assessments and the methods of collection thereof.
