Pet Sitter is also authorized by Client to seek emergency veterinary services with a release from liabilities related to transportation, treatment, and expense. Should specified veterinarian be unavailable.

3. Pet Sitter is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse Pet Sitter/Company for expenses incurred, plus any additional fee for attending to this need for any expenses incurred for any other home/food/supplies needed.

Payment for Services

We accept Checks, Cash, Venmo, or Pay Pal for our service fees. While we prefer payment in full upfront, we can accept ½ down with the remaining due at the end of services rendered, as long as it is secured with a post-dated Check or Credit Card. If the final payment is not received within 7 days after the completion of the job, your Card or Check will be used as payment in full. In addition, a \$25.00 processing fee will also be charged.
