Executive Summary

The Texas Department of Public Safety (DPS) is responsible for collecting crime statistics from local law enforcement agencies and submitting the information to the Federal Bureau of Investigation (FBI) for inclusion in the national Uniform Crime Reporting (UCR) program. DPS publishes this annual crime report and provides the data in a searchable format on its public website. Participation in the FBI UCR program is voluntary, and as of December 31, 2021, 1,248 Texas law enforcement agencies submit crime data to the program.

The Summary Reporting System (SRS) methodology in the FBI's UCR Program was the primary means to collect and report national crime statistics for almost a century. SRS collected data on eight crime types, called index crimes, divided into two categories: violent crime (murder, rape, robbery, and aggravated assault) and property crime (burglary, larceny-theft, motor vehicle theft, and arson).

The new methodology – National Incident-based Reporting System (NIBRS) – provides more comprehensive reporting of incidents. Additional data for each incident can be included in NIBRS and for many more offenses per incident.

This 2021 report highlights the more robust data sets available in NIBRS reporting for 2021 while providing two- and five-year comparisons at a summary level. Summary comparisons will eventually be eliminated as more years of NIBRS data becomes available.

The number of agencies reporting NIBRS data increased significantly each year during the transition from Summary to NIBRS. For example, 790 agencies submitted NIBRS data in 2020; in 2021, that number climbed to 1,014 participating agencies, an increase of 224 agencies. Increases in volume or rates may not result from more crime but rather more agencies adopting the NIBRS reporting methodology over time.

This Crime in Texas Report uses definitions of terms adopted by the FBI or promulgated in Texas statute. The FBI also provides jurisdictional population estimates based on census data or projections. These totals are for general reference and may not match other population data or may inadvertently show slight variances based on estimates. DPS consistently uses the FBI estimates so that comparisons use the same methodology.

The 2021 NIBRS data represents about 98% of the jurisdictional population of this state. Jurisdictional population refers to law enforcement agencies with full-time residents within their boundaries. Entities such as schools and utility districts with their own law enforcement agencies do not have a jurisdictional population, but they report incidents.

Finally, data provided in this report are generally rounded to the nearest tenth, and every percentage below .01% is displayed as 0.0% for consistency. By rounding data, some tables may reflect slightly greater or less than 100% percent when totaled.

2021 Crime Summary

Detailed, accurate, and timely crime data helps to identify patterns and trends within and across jurisdictions and is essential in developing, implementing, and assessing evidence-based policing strategies. This data is also vital to policymakers at all levels in the performance of their public safety responsibilities, and it provides Texas citizens with meaningful information about crime in their communities and state.

The annual crime index for Texas is reported by rate and by volume. The index crime rate is the number of the identified offenses committed per 100,000 population. Doing so allows for consistent comparisons between years without the impact of population changes and allows comparison between agencies of varying sizes. The FBI provides yearly population totals based on Census Bureau estimations to calculate the index crime rate in local and state jurisdictions. Crime volume is the aggregate sum of the offenses.

Previous editions of the Crime in Texas report did not include the crime rates for state-mandated reporting offenses but beginning with this 2021 report; those figures will be included.

The tables below display the two-year comparisons of Texas crime by rate – a calculation of the number of offenses per 100,000 people in the state – and by crime volume.

As with the crime rate figures above, the volume of index crimes decreased in 2021. Robbery had the highest decrease between 2020 and 2021, with burglary also decreasing significantly.

4 Most Populous Cities

The four largest city police departments in Texas - Houston Police Department (PD), Dallas PD, San Antonio PD, and Austin PD – account for 36% of the state’s crime volume. The metropolitan areas around those four cities report more than 60% of the crime volume in Texas.

Clearances

An offense is cleared only when a law enforcement agency arrests an offender for the offense. The arrest of one person can clear several crimes or several persons may be arrested in the process of clearing one offense. Law enforcement agencies may also clear a crime by exceptional means when all four of the following criteria are met: (1) The agency has established the identity of the offender, (2) enough evidence exists to support an arrest, charge, and turning over to the court for prosecution, (3) the exact location of the offender is known so that the subject could be taken into custody now, and (4) some element beyond law enforcement control that precludes arresting, charging, and prosecuting the offender.

Clearances are reflected in the same year the incident was reported regardless of when the offense was cleared. For example, if a case is cleared in 2021 for a 2019 incident, the clearance will be reported against the original 2019 incident.

Rape

Definition

Rape is defined in the national UCR program as “penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.” The nature of Rape breaks down the total number of Rape into completed and attempted offenses. Statistics reported in this crime category include assaults to commit Rape; however, statutory Rape is excluded.

The statistics reported in this NIBRS Index Crime category relate to the offense of Rape as defined under UCR guidelines, not the Sexual Assault offense data collected according to Texas Gov’t Code §411.042. The two data sets should not be compared as the definitions and offenses for Rape, and Sexual Assault do not fully align. The number of Rape offenses reported in 2021 is 14,972, while the number that qualifies as Sexual Assault for state reporting under Texas statute is 18,429.

The following highlights statistics derived from the Rape offense data collection for NIBRS Crime Index purposes.

Almost 83% of Rape reported used a part of a person’s body as a weapon. 1.8% of Rape incidents were committed with a firearm, handgun, other firearm, rifle, or shotgun. Unknown and other weapons account for 11.9% of Rapes.

Sexual Assault Data (Texas-mandated)

Texas Gov't Code §411.042 requires DPS to establish guidelines and collect data about incidents that involve specific sexual assault offenses. This state-mandated collection gathers Texas Penal Code sex offenses. The data collected and the specific offenses that comprise Sexual Assault do not match the NIBRS offense of Rape, so users should not expect comparisons between the two data categories to align.

Property Crimes

Robbery and Burglary volumes decreased (-16.6% and -11.3% respectively) over the past year. Overall property crime in Texas declined between 2020 and 2021, despite increases in motor vehicle theft year after year.

The total value of stolen property in 2021 was \$1,529,548,089 with \$673,474,193 (44%) of that recovered. Automobiles were the highest value category of stolen property at \$1,043,025,836 stolen. Of that amount, \$634,014,380 in automobiles was recovered, the highest value of the recovered property. \$24 million worth of firearms were stolen, with less than \$1.5 million recovered. That comes to 6.2% recovered. Currency worth \$644.9 million was stolen in 2021, and less than \$9 million was recovered (1.4%).

Arson

The FBI's UCR Program defines arson as any willful or malicious burning or attempting to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

The highest *volume* of Arsons reported was for the "Over 100,000 Population," but the "Under 2,500 Population" jurisdictions combined for the highest *rate*.

Involuntary Servitude is defined as the obtaining of a person(s) through recruitment, harboring, transportation, or provision, and subjecting such persons by force, fraud, or coercion into involuntary servitude, peonage, debt bondage, or slavery (not to include commercial sex acts).

Human smuggling generally refers to the importation of persons into the United States involving deliberate evasion of immigration laws. However, human smugglers are known to hold people against their will, extort them and their families, and sexually assault young females being smuggled. Human smuggling data is not captured within Human Trafficking statistical reports.

Drugs Seized

The State of Texas mandates reporting of drugs seized. Drug seizure information is presented in compliance with Health and Safety Code, Sec. 481.185. It requires that “(a)ll law enforcement agencies in this state shall file monthly with the [DPS] Director a report of all arrests for drug offenses made and quantities of controlled substances seized by them during the preceding month.” Two high-profile drugs fall into general NIBRS drug categories. Fentanyl falls within the category of “Synthetic Drugs,” while Tetrahydrocannabinol (THC) falls within “Marijuana.”

Crime trends indicate that many illegal drugs can be seized in any measurement unit. The current drug seized reports were developed years ago and are therefore limited to certain Drug Measurement types. Future reporting system will expand the reports to address this and include all measurement types: solids, liquids, dose units, and items (which indicates number of plants and is only for marijuana, opium, and peyote).




Sexual Assault

Texas Gov't Code §411.042 requires DPS to establish guidelines and collect, as part of the UCR program, data about incidents that involve specific sexual assault offenses. Sexual Assault crime data collection began in the calendar year 2008. Special consideration had to be taken to disseminate the data collection guidelines for Sexual Assault reporting due to the difference between UCR offense and Texas Penal Code definitions. In the Texas UCR program, rape is the only offense collected under the crime index. Since there is greater variance in the offenses collected in the compilation of Sexual Assault data, this data collection should in no way be compared to the statistics maintained in the national UCR program.

Robbery is defined as the taking or attempting to take anything of value from the care, custody, or control of a person or persons by force, threat of force, or violence, or by putting the victim in fear.

Larceny-Theft

Larceny-Theft is the unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. Larceny-Theft includes shoplifting, pocket-picking, purse-snatching, thefts from motor vehicles, thefts of motor vehicle parts and accessories, bicycle thefts, and other things of value in which no use of force, violence, or fraud occurs.

In the FBI guidelines for NIBRS data, this crime classification does not include embezzlement, confidence/swindle games, forgery, and the passing of counterfeited/bad checks. Those offenses have their own NIBRS crime category and are considered Part II offenses for which only arrest data is converted for SRS methodology.

Motor vehicle theft is not included in the larceny-theft category as it is a separate index crime offense.

Cargo Theft

Cargo Theft is “the criminal taking of any cargo including, but not limited to, goods, chattels, money, or baggage that constitutes, in whole or in part, a commercial shipment of freight moving in commerce, from any pipeline system, railroad car, motor truck, or other vehicles, or from any tank or storage facility, station house, platform, or depot, or from any vessel or pier, or from any aircraft, air terminal, airport, aircraft terminal or air navigation facility, or from any intermodal container, intermodal chassis, trailer, container freight station, warehouse, freight distribution facility, or freight consolidation facility. For purposes of this definition, cargo shall be deemed as moving in commerce at all points between the point of origin and the final destination, regardless of any temporary stop while awaiting transshipment or otherwise.”

Arson is defined as any willful or malicious burning or attempt to burn, with or without intent to defraud, a house, public building, motor vehicle or aircraft, personal property of another, etc.

Only fires determined through investigation to have been willfully or maliciously set are classified as arson. Fires of suspicious or unknown origins are excluded from data collection.

Family Violence

The Texas Family Code, Chapter 71.004, defines Family Violence as “an act by a member of a family or household against another member of the family or household that is intended to result in physical harm, bodily injury, assault, or sexual assault or that is a threat that reasonably places the member in fear of imminent physical harm, bodily injury, assault, or sexual assault, but does not include defensive measures to protect oneself.” The law includes abuse, defined as physical injury that results in substantial harm or genuine threat; sexual contact, intercourse, or conduct; or compelling or encouraging the child to engage in sexual conduct. The law excludes the reasonable discipline of a child. For Family Violence Reporting, the law defines “family” to include individuals related by consanguinity (blood) or affinity, marriage or former marriage, biological parents of the same child, foster children, foster parents, and members or former members of the same household (including roommates regardless of gender).

This definition includes “Dating Violence” in the family violence reporting. The law defines a “Dating Relationship” as a relationship between individuals who have or have had a continuing relationship of a romantic or intimate nature.

Appendices

Aggravated Sexual Assault (Section 22.021, Texas Penal Code)

Two groups classify Sexual Assault offenses:

Group One

(A) Intentionally or knowingly:

- (i) causes the penetration of the anus or sexual organ of another person by any means, without that person's consent.
- (ii) causes the penetration of the mouth of another person by the sexual organ of the actor, without that person's consent.
- (iii) causes the sexual organ of another person, without that person's consent, to contact or penetrate the mouth, anus, or sexual organ of another person, including the actor.

(B) Intentionally or knowingly:

- (i) causes the penetration of the anus or sexual organ of a child by any means.
- (ii) causes the penetration of the mouth of a child by the sexual organ of the actor.
- (iii) causes the sexual organ of a child to contact or penetrate the mouth, anus, or sexual organ of another person, including the actor.
- (iv) causes the anus of a child to contact the mouth, anus, or sexual organ of another person, including the actor.
- (v) causes the mouth of a child to contact the anus or sexual organ of another person, including the actor.

Group Two

(A) The person:

- (i) causes serious bodily injury or attempts to cause the death of the victim or another person in the course of the same criminal episode.
- (ii) by acts or words places the victim in fear that death, serious bodily injury, or kidnapping will be imminently inflicted on any person.
- (iii) by acts or words occurring in the presence of the victim threatens to cause the death, serious bodily injury, or kidnapping of any person.
- (iv) uses or exhibits a deadly weapon in the course of the same criminal episode.
- (v) acts in concert with another who engages in conduct described by Subdivision (1) directed toward the same victim and occurring during the course of the same criminal episode.
- (vi) administers or provides flunitrazepam, otherwise known as Rohypnol, gamma hydroxybutyrate, or ketamine to the victim of the offense with the intent of facilitating the commission of the offense.

(B) The victim is younger than 14 years of age.

(C) The victim is an elderly individual or a disabled individual.

Continuous Sexual Abuse of Young Child or Children (Section 21.02, Texas Penal Code)

In this section, "child" has the meaning assigned by Section 22.011(c), Texas Penal Code. "Act of Sexual Abuse" has the meaning assigned by Section 21.02(c), Texas Penal Code.

(b) A person commits an offense if:

(1) During a period that is 30 or more days in duration, the person commits two or more acts of sexual abuse, regardless of whether the acts of sexual abuse are committed against one or more victims; and

(2) At the time of the commission of each of the acts of sexual abuse, the actor is 17 years of age or older and the victim is a child younger than 14 years of age.

Indecency with a Child (Section 22.11, Texas Penal Code)

A person commits an offense if, with a child younger than 17 years of age, whether the child is of the same or opposite sex and regardless of whether the person knows the age of the child at the time of the offense, the person:

- (1) engages in sexual contact with the child or causes the child to engage in sexual contact; or
- (2) with intent to arouse or gratify the sexual desire of any person:
 - (A) Exposes the person's anus or any part of the person's genitals, knowing the child is present.
 - (B) Causes the child to expose the child's anus or any part of the child's genitals.

Sexual Assault (Section 22.011, Texas Penal Code)

A person commits an offense if the person:

- (1) Intentionally or knowingly:
 - (A) Causes the penetration of the anus or sexual organ of another person by any means, without that person's consent;
 - (B) Causes the penetration of the mouth of another person by the sexual organ of the actor, without that person's consent; or
 - (C) Causes the sexual organ of another person, without that person's consent, to contact or penetrate the mouth, anus, or sexual organ of another person, including the actor; or
- (2) Intentionally or knowingly:
 - (A) Causes the penetration of the anus or sexual organ of a child by any means;
 - (B) Causes the penetration of the mouth of a child by the sexual organ of the actor;
 - (C) Causes the sexual organ of a child to contact or penetrate the mouth, anus, or sexual organ of another person, including the actor;
 - (D) Causes the anus of a child to contact the mouth, anus, or sexual organ of another person, including the actor; or
 - (E) Causes the mouth of a child to contact the anus or sexual organ of another person, including the actor.

Sexual Performance by a Child (Section 43.25, Texas Penal Code)

(a) In this section:

(1) "Sexual performance" means any performance or part thereof that includes sexual conduct by a child younger than 18 years of age.

(2) "Sexual conduct" means sexual contact, actual or simulated sexual intercourse, deviate sexual intercourse, sexual bestiality, masturbation, sado-masochistic abuse, or lewd exhibition of the genitals, the anus, or any portion of the female breast below the top of the areola.

(3) "Performance" means any play, motion picture, photograph, dance, or other visual representation that can be exhibited before an audience of one or more persons.

(4) "Produce" with respect to a sexual performance includes any conduct that directly contributes to the creation or manufacture of sexual performance.

(5) "Promote" means to procure, manufacture, issue, sell, give, provide, lend, mail, deliver, transfer, transmit, publish, distribute, circulate, disseminate, present, exhibit, or advertise or to offer or agree to do any of the above.

(6) "Simulated" means the explicit depiction of sexual conduct that creates the appearance of actual sexual conduct and during which a person engaging in the conduct exhibits any uncovered portion of the breasts, genitals, or buttocks.

(7) "Deviate sexual intercourse" and "sexual contact" have the meanings assigned by Section 43.01.

(b) A person commits an offense if, knowing the character and content thereof, he employs, authorizes, or induces a child younger than 18 years of age to engage in sexual conduct or a sexual performance. A parent or legal guardian or custodian of a child younger than 18 years of age commits an offense if he consents to the participation by the child in a sexual performance.

(d) A person commits an offense if, knowing the character and content of the material, he produces, directs, or promotes a performance that includes sexual conduct by a child younger than 18 years of age.

Glossary of Terms

The following is a collection of terms and definitions as they relate to Texas criminal offenses, federal National Incident Based Reporting System (NIBRS) guidelines/offenses and the Uniform Crime Reporting (UCR) Program.

Adult

In Texas, an adult is a person 17 years of age or older. Federal law provides that an adult is a person 18 years of age or older. Unless otherwise indicated, this publication follows the state definition for adult.

Affinity

The connection existing, as a consequence of marriage, between married persons and the kindred of the other.

Aggravated Assault

An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness. This also includes assault with disease (as in cases when the offender is aware that he/she is infected with a deadly disease and deliberately attempts to inflict the disease by biting, spitting, etc.).

All Other Offenses

All violations of state and/or local laws, except crimes that fall under another UCR offense category and traffic offenses. This is a Group B offense and only arrest information is reported.

Arson

To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire or incendiary device, with or without intent to defraud.

Bribery

The offering, giving, receiving, or soliciting of anything of value (i.e., a bribe, gratuity, or kickback) to sway the judgment or action of a person in a position of trust or influence.

Burglary/Breaking and Entering

The unlawful entry into a building or other structure with the intent to commit a felony or a theft.

Cargo Theft

Cargo theft in UCR refers to taking possession illegally of any cargo shipment including but not limited to the following categories: cargo shipment of goods, chattels, money, baggage that constitutes, in whole, in part, a commercial shipment of freight moving in commerce, from any pipeline system, railroad car, motor truck, other vehicle, from any tank, storage facility, station house, platform, depot, from any vessel, wharf, from any aircraft, air terminal, airport, aircraft terminal, air navigation facility, from any intermodal container, intermodal chassis, trailer, container freight station, warehouse, freight distribution facility, freight consolidation facility. For purposes of this definition, cargo shall be deemed as moving in commerce at all points between the point of origin and the final destination, regardless of any temporary stop while awaiting transshipment or otherwise.

Consanguinity

Kinship or blood relationship; the relationship of persons who are descended from a common ancestor.

Crime Factors

Conditions that affect the amount and type of crime that occurs in a geographical area.

Crime Index

The sum of seven index offenses used to measure the extent, fluctuation, and distribution of crime in a given geographical area. Crime classifications used in the Crime Index are the following: murder, rape, robbery, aggravated assault, burglary, larceny-theft and motor vehicle theft. Arson and human trafficking are also classified as index offenses but are not part of the Crime Index.

Crime Rate

The number of offenses per 100,000 inhabitants. To calculate the crime rate, divide the number of offenses by the population and then multiply by 100,000. The crime rate is useful in determining the relative frequency of crime without regard to fluctuations in population.

Crime Volume

Crime volume is the aggregate sum of the offenses within the crime index.

Curfew/Loitering/Vagrancy Violations

The violation of a court order, regulation, ordinance, or law requiring the withdrawal of persons from the streets or other specified areas; prohibiting persons from remaining in an area or place in an idle or aimless manner; or prohibiting persons from going from place to place without visible means of support. These are Group B offenses and only arrest information is reported.

Disorderly Conduct

Any behavior that tends to disturb the public or decorum, scandalize the community, or shock the public sense of morality. This is a Group B offense and only arrest information is reported, unless this is related to one of the Texas Penal Code sex offenses.

Driving Under the Influence (DUI)

Driving or operating any motor vehicle or common carrier while mentally or physically impaired as the result of consuming an alcoholic beverage or using a drug or narcotic. This is a Group B offense and only arrest information is reported.

Drug Abuse Violations

All arrests for violation of state and/or local laws, specifically those relating to the unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation and/or importation of any controlled drug or narcotic substance.

Drunkenness (Intoxication)

To drink alcoholic beverages to the extent that one's mental faculties and physical coordination are substantially impaired. Excludes Driving under the influence (DUI). This is a Group B offense and only arrest information is reported.

Ethnicity (Ethnic Origin)

In UCR, race and ethnic origin are counted as two separate designations. The ethnic origin categories were adopted from the U.S. Department of Commerce and are Hispanic and not Hispanic. Included as Hispanic are all persons of Mexican, Puerto Rican, Cuban, Central or South American, or other Spanish culture or origin, regardless of race.

Extortion/Blackmail

To unlawfully obtain money, property, or any other thing of value, either tangible or intangible, through the use or threat of force, misuse of authority, threat of criminal prosecution, threat of destruction of reputation or social standing, or through other coercive means.

Family

For UCR purposes, is defined as individuals related by blood, affinity, marriage, former marriage, biological parents of the same child, foster children, foster parents, members of the same household or former members of the same household.

Family Violence

An act by a member of a family or household (as defined by the Texas Family Code) against another member that is intended to result in physical harm, bodily injury, assault or a threat that reasonably places the member in fear of imminent physical harm.

Forgery and Counterfeiting

The altering, copying, or imitation of something, without authority or right, with the intent to deceive or defraud by passing the copy or thing altered or imitated as that which is original or genuine; or the selling, buying, or possession of an altered, copied, or imitated thing with the intent to deceive or defraud. Includes attempts.

Fraud

The intentional perversion of the truth for the purpose of inducing another person, or other entity, in reliance upon it to part with something of value or to surrender a legal right. This excludes Forgery and Counterfeiting, as the FBI assigned those their own offense.

Gambling

Promoting, permitting, or engaging in illegal gambling.

Embezzlement

The unlawful misappropriation by an offender to his/her own use or purpose of money, property, or some other thing of value entrusted to his/her care, custody, or control. Includes attempts. In general, an employer/employee or legal agent relationship must exist for Embezzlement to occur.

Hate Crime Bias Motivation

Hate crime bias motivation, relates to crimes where the offender(s) are motivated by prejudice, hatred, or advocacy of violence. The offender's bias motivation must be against one of the protected classes, as defined by the FBI, regardless of whether the victim was part of that or any protected class.

Hierarchy Rule

For SRS submissions, when several offenses are committed simultaneously by one person or group of persons, the hierarchy rule in UCR mandates that only the most serious offense is recorded for statistical purposes. Arson is an exception to this rule.

Human Trafficking

Human Trafficking includes both Commercial Sex Acts and Involuntary Servitude.

1. Commercial Sex Acts

Inducing a person by force, fraud, or coercion to participate in commercial sex acts, or in which the person induced to perform such act(s) has not attained 18 years of age.

2. Involuntary Servitude

The obtaining of a person(s) through recruitment, harboring, transportation, or provision, and subjecting such persons by force, fraud, or coercion into involuntary servitude, peonage, debt bondage, or slavery (not to include commercial sex acts).

Index Crime

A crime for which reports of offenses committed are collected. Index crimes are murder, rape, robbery, aggravated assault, burglary, larceny-theft, motor vehicle theft, arson, and human trafficking.

Intimidation

To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

Justifiable Homicide (Not a Crime)

The killing of a perpetrator of a serious criminal offense by a peace officer in the line of duty, or the killing, during the commission of a serious criminal offense, of the perpetrator by a private individual.

Juvenile

In Texas, a juvenile is a person under 17 years of age (i.e., 16 years and under). At the federal level, Juvenile is a person under 18 years of age (i.e., 17 years and under). Unless otherwise indicated, this publication follows the state definition for juvenile.

Kidnapping/Abduction

The unlawful seizure, transportation, and/or detention of a person against his/her will, or of a minor without the consent of his/her custodial parent(s) or legal guardian.

Larceny-Theft

The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. This includes pocket-picking, purse-snatching, shoplifting, theft from motor vehicles, theft of motor vehicle parts and accessories, theft of bicycles, theft from buildings and theft from coin-operated machines.

Liquor Laws

State and/or local liquor law violations, except drunkenness and driving under the influence. Federal violations are excluded. This is a Group B offense and only arrest information is reported.

Manslaughter by Negligence (Negligent Manslaughter)

The killing of another person through gross negligence. This offense includes killings resulting from hunting accidents, gun cleaning, children playing with guns, etc. It does not include deaths of persons due to their own negligence, accidental deaths not resulting from gross negligence, and accidental traffic fatalities. This offense does not include Vehicular Manslaughter, which are reported as Murder and Non-Negligent Manslaughter if not accidental or All Other Offenses if accidental.

Motor Vehicle Theft

The theft or attempted theft of a motor vehicle, which is defined as a self-propelled vehicle that runs on land surface and not on rails.

Murder and Non-Negligent Manslaughter

The willful (non-negligent) killing of one human being by another. This includes any death due to injuries received in a fight, argument, quarrel, assault, or commission of a crime. Suicides, accidental deaths, assaults not resulting in death, traffic fatalities, and attempted murders are not included.

NIBRS

National Incident-Based Reporting System (NIBRS) is an incident-based reporting system or methodology used by law enforcement agencies in the United States for collecting and reporting data on crimes to the Federal UCR program. The FBI maintains the reporting guidelines.

Non-Violent Crime

Non-violent crimes include property crimes which is broken down into burglary, larceny-theft, and motor vehicle theft offenses.

Offenses against the Family and Children

Nonsupport, neglect, desertion, or abuse of family and children. Includes attempts.

Other Assault (Simple)

An unlawful physical attack by one person upon another where neither the offender displays a weapon (other than personal weapon), nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

Part One Offenses

The first of two categories of offenses (within the Crime Index) established for crime reporting purposes. Part one offenses are by their nature more serious and/or occur most frequently. The reports of these offenses committed are collected without regard to whether an arrest was made.

Personal Weapon

The use of hands, feet, fists, and teeth as a weapon to commit a crime; also termed "strong-arm weapon."

Pornography/Obscene Material

The violation of laws or ordinances prohibiting the manufacture, publishing, sale, purchase, or possession of sexually explicit material, e.g., literature, photographs, etc.

Prejudice

An unreasonable and unjustifiable negative attitude toward a group and its individual members.

Prostitution and commercialized

Sex offenses of a commercialized nature, such as prostitution, keeping a bawdy house, procuring, transporting women for immoral purposes, etc. Includes attempts.

Race

In UCR, race and ethnic origin are counted as two separate designations. The racial categories were adopted from the U.S. Department of Commerce and are as follows: White, Black, American Indian, or Alaskan Native, Asian, Native Hawaiian or Other Pacific Islander.

1. White

A person having origins in any of the original peoples of Europe, North Africa, or the Middle East.

2. Black

A person having origins in any of the Black racial groups of Africa.

3. American Indian or Alaskan Native

A person having origins in any of the original peoples of North and South America (including Central America), and who maintains tribal affiliation or community attachment.

4. Asian

A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.

5. Native Hawaiian or Other Pacific Islander

A person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.

Rape

The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental or physical incapacity.

Robbery

The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and/or by putting the victim in fear of immediate harm.

Sex Offenses (Except Rape, Prostitution and Commercialized Vice)

Any sexual act directed against another person, without the consent of the victim, including instances where the victim is incapable of giving consent.

Summary Reporting (SRS)

SRS and its methodology had been a national method of collecting UCR statistics for the FBI since 1929. SRS collected basic statistical data and general just tallies of offenses. The FBI elected to sunset SRS at the end of 2020, migrating to the more detailed NIBRS methodology.

SRS Conversion

This CIT report contains both NIBRS and SRS data. To allow for comparison across this mixed data set, the hierarchy rule is applied to NIBRS data to convert it to SRS methodology, so that all data is presented in the common least common denominator.

Part Two Offenses

The second of two categories of offenses (within the Crime Index) established for crime reporting purposes. Part two offenses are generally less serious in nature and/or occur less frequently than part one offenses. Monthly tabulations of part two offenses are limited to arrest information only.

Stolen Property

Receiving, buying, selling, possessing, concealing, or transporting any property with the knowledge that it has been unlawfully taken, as by Burglary, Embezzlement, Fraud, Larceny, Robbery, etc. This includes attempts.

Vandalism/Destruction/Damage of Property

Willful or malicious destruction, injury, disfigurement, or defacement of any public or private property without the consent of the owner or person having custody or control of it. This excludes Arson.

Weapons Law Violations

The violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment, or use of firearms, cutting instruments, explosives, incendiary devices, or other deadly weapons.

NIBRS Firearm Weapons and Definitions

There are 5 firearm weapon types: Firearm, Handgun, Rifle, Shotgun, and Other Firearm. Each of these utilizes an explosive mechanism to project its round and meet the NIBRS firearm criteria, which is based on the Bureau of Alcohol, Tobacco, Firearms, and Explosives' definition of firearms. All 5 weapon types can be single-fire, semi-automatic, or fully automatic.

For NIBRS, firearms there is no distinction for single-fire versus semi-automatic in weapon totals. However, each of these Weapon Types can be reported with an "automatic-weapon indicator" and can be totaled separate from non-fully automatic firearms.

1. Summary Comparison - Automatic vs Semi-Automatic weapons:

Both these firing operations load the next round and cock the weapon automatically. However, a semi-automatic weapon fires one shot every time the trigger is pulled, while an automatic weapon fires more than one shot with one trigger pull without manually reloading.

a. Automatic

This type of weapon's firing operation is typically reserved for military use and/or machineguns. The firing mechanism is designed to self-reload rounds fully automatically into the chamber at a high speed; consisting of a 4-step firing process cycle; 1) Expels a bullet from the firing mechanism through the barrel, 2) Ejects the empty casing from the chamber, 3) Loads another bullet into the chamber, and 4) Automatically repositions the hammer to strike the firing pin, hit the shell casing, and expel another round. This type of firing operation is designed to fire multiple shots with one trigger pull and automatically reload.

b. Semi-automatic

This type of weapon's firing operation consists of a single trigger pull that expels one round from the weapon's barrel. The firing mechanism is designed to automatically load another round into the chamber and cock the weapon for the next trigger pull.

5 NIBRS Firearm Weapon Types:

1. Firearm:

Weapon Type = Firearm includes weapons meeting the basic NIBRS firearm criteria (a trigger mechanism and explosive-projected round) used at the time of the incident but the details of type of 'gun' are not provided or possibly even known by the reporting party or agency.

- a. **For U.S. Code Section 5845** purposes, "antique firearms" must not be reported as firearm although its main origin was for firing use, however, its manufacture, value, design, and other characteristics is primarily now a collector's item and is not likely to discharge a lethal projectile. An antique firearm (and guns in general) can be used in multiple ways. Per NIBRS guidelines, the Weapon Type reported should match how the weapon is used. An antique rifle with bayonet could be used (1) as a blunt weapon object to hit someone, (2) as a knife/cutting instrument to stab or cut, (3) as a firearm to shoot someone, etc.

2. Handgun:

Weapon Type = Handgun includes any manufactured firearm designed to be handheld, in either one or both hands with its primary characteristic of a short barrel that can fire/projectile a single round by pulling a trigger. The following are considered handguns commonly reported: Revolvers and Semi-automatic pistols.

3. Rifle:

Weapon Type = Rifle includes any weapon that has the characteristics of a shoulder stock (also known as buttstock), a rifled long barrel with approximately 16 – 26 inches, a fore end/forward grip and use a metal-casing ammo that fires a single projectile or bullet. A rifle is intended to be fired utilizing both hands, from a shouldered position either prone, kneeling, standing, or from a rest. Rifles are mainly used for military and sporting purposes.

4. Shotgun:

Weapon Type = Shotgun is a long-barreled firearm, similar to a Rifle, but designed to shoot a straight-walled cartridge known as a shotgun shell, which usually discharges numerous small pellets (ball or buck shot) or a single projectile (slug) for each pull of the trigger.

5. Other Firearm:

Weapon Type = Other Firearm includes weapons that meet the general firearm criteria but that do NOT fall into one of the other NIBRS firearms Weapon Types (i.e., Firearm, Handgun, Rifle, or Shotgun).

Other Firearms include weapons or devices capable of being concealed and fixed to fire a shot through the energy of an explosive trigger mechanism.

Additional Gun Related Information

Certain types of weapons are commonly recognized but are not specifically identified in the NIBRS firearms data and may be included with other similar weapons in one of the general Weapon Types. DPS has provided this information to clarify how these are handled in the UCR collection.

1. Assault Rifle:

“Assault rifle” is not a specific Weapon Type for the UCR data collection but is a general term for a rifle with certain traits. These weapons would fall under the NIBRS Weapon Type = Rifles and can be semi-automatic or have the automatic indicator.

The general “Assault rifle” classification refers to rifles with certain traits:

- a. **Selective-fire** where it can be switched from single-fire, burst-fire, or fully automatic.
 - i. Note: Federal gun laws have prohibited civilians from owning fully automatic weapons since 1968.
- b. **Intermediate cartridge** which are less powerful than a high-powered rifle round, and slightly more powerful than a sub-machinegun.
- c. **Detachable magazine** that is easily insertable and removable, allowing for quicker reloads.

2. Ghost guns

The UCR data collection does not have a Weapon Type for this specifically. The term “Ghost gun” refers to a gun that lacks a commercially-applied serial number by which it can be identified and require no background checks to acquire. These are typically assembled by the user with various parts or homemade components, often purchased or made separately. These weapons could fall under any of the 5 NIBRS Weapon Types (Firearm, Handgun, Rifle, Shotgun, or Other Firearm) and be any of the firing actions (single-fire, semi-automatic, or automatic) depending on the weapons traits.

3. Weapons that look like, but are NOT classified as a Firearm

The Weapon Type = “Other” includes BB guns, pellet guns, tasers, pepper spray and stun guns. These less-lethal handheld weapons that can include a trigger, lever, or button mechanism. While they may appear similar to a firearm, they lack the explosive-propelled projectile to meet the NIBRS criteria to be considered one of the firearms weapon types (i.e., Firearm, Handgun, Rifle, Shotgun, or Other Firearm).
