This General Price List is provided in accordance with California law and must be offered to you upon inquiring in person about funeral goods, services, or prices.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

PROFESSIONAL SERVICES

Basic Professional Services of Funeral Director and Staff and Overhead.....\$1,055

This is the basic charge to each family we serve for our professional expertise. Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Embalming.....\$775

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.

Cleaning deposit.....\$500

The FTC Funeral Rule gives you the right to buy only the funeral arrangements you want. You have the right to buy separate goods (such as caskets) and services (such as embalming or a memorial service). You do not have to accept a package that may include items you do not want.

Traditional Burial Funeral or Memorial Service.....\$4,325

Includes the Basic Services of the Funeral Director and Staff, a proportionate share of overhead costs, local transfer of decedent from local hospital, Coroner/M.E office, convalescent/nursing home*, processing of death certificate and disposition permit, sheltering of remains up to 7 days, embalming, dressing, cosmetology, casketing, 3-hr chapel service, banquet room, funeral coach and transfer to local cemetery and the graveside service. (Does not include cost of casket or flowers.)

Graveside Service.....\$2,990

Includes the Basic Services of the Funeral Director and Staff, local transfer of decedent from local hospital, Coroner/M.E office, convalescent/nursing home*, processing of death certificate and disposition permit, sheltering of remains up to 3 days, funeral coach and transfer to local cemetery and the graveside service. (Does not include cost of casket or flowers.)

Immediate Burial.....\$2,165

Includes the Basic Services of the Funeral Director and Staff, a proportionate share of overhead costs, local transfer of decedent from local hospital, Coroner/M.E office, convalescent/nursing home*, processing of death certificate and disposition permit, sheltering of remains up to 3 days, delivery to local cemetery in utility vehicle, no services, no family present.

Immediate Burial with Purchaser-Provided Container\$2,165

The casket must meet all cemetery regulations. To determine the regulations of a particular cemetery, please contact the cemetery directly.

Receiving Remains from Another Funeral Home.....\$1,775

Includes the Basic Services of the Funeral Director and Staff, a proportionate share of overhead costs, local transfer from San Jose International Airport (SJC), processing of disposition permit, sheltering of remains up to 3 days, delivery to local crematory or cemetery in utility vehicle, no services, no family present.

Forwarding Remains to Another Funeral Home.....\$2,440

Includes the Basic Services of the Funeral Director and Staff, a proportionate share of overhead costs, processing of disposition permit, preparation of remains (including embalming), sheltering of remains up to 3 days, delivery to San Jose International Airport (SJC).

***Home Removal requires a second attendant..... add \$200**

Direct Cremation.....\$1,610 to \$1,710

Includes the Basic Services of the Funeral Director and Staff, local transfer of decedent from local hospital, Coroner/M.E office, convalescent/nursing home*, processing of death certificate and disposition permit, sheltering of remains up to 7 days, transport to crematory, DCA Cremation Fee, return of cremated remains in a plastic utility urn with a cremation disposition permit. No services, no family present.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The alternative containers we provide are constructed of hardwoods, composite materials, fiberboard container, or heavy corrugated cardboard.

Direct Cremation with basic cardboard container\$1,710

You may provide your own cremation container; however, all such merchandise must meet any and all applicable California State or Crematory requirements.

Witness Cremation.....\$2,800 to \$2,900

Includes the Basic Services of the Funeral Director and Staff, local transfer of decedent from local hospital, Coroner/M.E office, convalescent/nursing home*, processing of death certificate and disposition permit, sheltering of remains up to 7 days, wash, feature and dressing of the decedent, basic cardboard alternative container for cremation, 20 minute viewing of deceased either at the mortuary or crematory, transport to crematory, witness cremation charge, DCA Cremation Fee, return of cremated remains in a plastic utility urn with a cremation disposition permit.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The alternative containers we provide are a fiberboard container, or an unfinished wood box.

You may provide your own cremation container; however, all such merchandise must meet any and all applicable California State or Crematory requirements.

Oversized Cremation (300 lbs +).....\$2,250 to \$2,350

Includes the Basic Services of the Funeral Director and Staff, local transfer of decedent from local hospital, Coroner/M.E office, convalescent/nursing home*, processing of death certificate and disposition permit, sheltering of remains up to 7 days, reinforced alternative container for cremation, transport to crematory, oversized cremation fees, DCA Cremation Fee, return of cremated remains in a plastic utility urn with a cremation disposition permit. No services, no family present.

If you want to arrange an oversized direct cremation, you can use an oversized alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The oversized alternative containers we provide are plywood with a corrugated cardboard cover.

You may provide your own cremation container; however, all such merchandise must meet any and all applicable California State or Crematory requirements for Oversized Cremation.

Includes the Basic Services of the Funeral Director and Staff, local transfer of decedent from local hospital, Coroner/M.E office, convalescent/nursing home*, processing of death certificate and disposition permit, sheltering of remains up to 7 days, embalming, dressing, cosmetology, casketing, 3-hr Chapel Service, Banquet Room, funeral coach, transport to crematory, witness cremation charge, DCA Cremation Fee, witness cremation service at crematory, return of cremated remains in a plastic utility urn with a cremation disposition permit. (Does not include casket).

OUTER BURIAL CONTAINERS

In most areas of the country, state or local law does not require that you buy a container to surround the casket in a grave. However, many cemeteries require that you have such a container so that the grave will not sink in. Either a grave liner or a burial vault will satisfy these requirements.

The California Department of Consumer Affairs (DCA) charges a fee that is applied to every cremation in the State of California. The DCA has determined that this fee is necessary to provide regulatory oversight of California crematories.
