Rules for Wisconsin Trail Lake Runners Club Inc

1. Respect the landowners, if you see them, wave, or stop and say hello.
2. Make sure to stay updated on our Facebook page for any changes around our immediate area on the lake and surrounding towns/counties.
3. Stay between the trail signs and know where you are going.
4. On County Road routes, ride to the far-right side of the road (on the black top or gravel) not in the ditches.
5. Un-posted Speed limit for Club Trails or public roads is 35 mph maximum. Please observe the posted speed – whichever is less.
 - a. Obey all posted traffic signs
6. All ATV/UTV's must comply with the 96-decibel noise level.
7. Headlight and taillights must be displayed when riding on the Club Trail or public roads.
8. Club Trail access is limited to ATV and UTV traffic as defined by WI ATV & UTV Laws. a. Specifically, an ATV is “an engine driven device designed by the manufacturer to travel on 3 or more low pressure tires”.
9. Specifically, an UTV is “a motor driven device that does not meet federal motor vehicle safety standards and has 4 or more low pressure tires”.
10. Any person under 18 years of age operating and riding on an ATV must wear a helmet.
11. Guest are required to buy a full membership and fill out appropriate paperwork.
12. All laws of Section 23.33 will apply, unless rules are stricter by the Club.
13. Disciplinary actions will be determined by Club officers, up to and including removal from Club and forfeiture of dues.
14. Members will be liable and billed for damages resulting from willful destruction of the trails or crops.
15. Report all violations to a Club officer.
16. Landowners allowing the Club to cross their land will receive free membership. Landowners are also required to sign a Membership form and Rules form.
