American Legion supports these bills in congress

ON POINT THE AMERICAN LEGION IN WASHINGTON

"Our veterans do not ask for special treatment. They ask only for the care and benefits they earned, delivered with competence, integrity and compassion."

American Legion Veterans Affairs & Rehabilitation Division Director Cole Lyle, testifying June 11 before the House Committee on Veterans' Affairs Oversight & Investigations Subcommittee

In a busy week on Capitol Hill, American Legion policy experts testified twice on June 11 and again on June 12 before congressional subcommittees, weighing in on a variety of bills affecting VA health care, benefits, education,

homelessness and the VA Home Loan program.

June 11: American Legion Veterans Affairs & Rehabilitation Division Director Cole Lyle expressed the organization's support to the House Committee on Veterans' Affairs Oversight & Investigation Subcommittee for:

H.R. 984, to amend Title 38 to provide timely, equitable relief for individuals who suffer losses due to human mistakes, a growing concern due to increased claims applications since the PACT Act

H.R. 1663, in support of the Veterans Scam and Fraud Evasion Act of 2025 to protect veterans from scams

H.R. 3185, the Personnel Integrity in Veterans Affairs Act of 2025, which aims to maintain trust in the VA workforce

H.R. 3482, the Veterans Community Care Scheduling Improvement Act

H.R. 3494, the VA Hospital Inventory Management System Authorization Act

June 11: American Legion Senior Policy Associate Andrew Petrie testified in support of two bills already introduced, along with two in draft, before the House Committee on Veterans' Affairs Subcommittee on Economic Opportunity:

H.R. 1965, the Veteran Education Assistance Adjustment Act, which would increase the yearly Post-9/11 GI Bill books and supplies stipend from \$1,000 to \$1,400

H.R. 2791, to amend Title 38 to increase the maximum VA Home Loan Guaranty entitlement to 25% of the Freddie Mac loan limit by 1.5 times

Expanding Access for Online Veteran Students Act, in draft, which would increase the monthly

housing stipend for Post-9/11 GI Bill users for students pursuing education through distance learning on more than a half-time basis to that of the national average

· Expanding eligibility for homelessness benefits for veterans

discharged under other-than-honorable conditions

June 12: Lyle testified for the second consecutive day, this time before the House Committee on Veterans' Affairs Subcommittee on Health, including American Legion support for:

H.R. 2605, the Service Dogs Assisting Veterans (SAVES) Act, expanding the VA grant program to train more service dogs to assist veterans

H.R. 785, the Representing Our Seniors Act, to include a representative of the National Association of State Veterans Homes on VA's Geriatrics and Gerontology Advisory Committee

H.R. 3400, the Territorial Response and Access to Veterans' Essential Lifecare (TRAVEL) Act, to improve health-care access in U.S. territories and underserved areas

H.R. 3643, the VA Data Transparency and Trust Act, to improve VA reporting on health care and benefits to enable evidence-based improvements in care delivery

H.R. 2148, the Veteran Caregiver Reeducation, Reemployment and Retirement Act, expanding VA benefits for family caregivers

Draft, to direct the VA secretary to conduct a study to determine if RNA sequencing can be used effectively to diagnose post-traumatic stress disorder among veterans

VA offers yearlong community care authorizations for 30 services

August 4, 2025

WASHINGTON — The Department of Veterans Affairs today announced it will improve Veterans' access to health care by extending the length of new VA community care authorizations to one year for 30 standardized types of care.

The change means Veterans referred by VA to community care for eligible standardized types of care will receive 12 full months of uninterrupted treatment at VA expense before having to obtain a VA reauthorization.

Veterans will benefit from uninterrupted access to essential specialty services, allowing them to focus more on their health and less on navigating administrative requirements. Community providers will be empowered to manage care with fewer administrative barriers and greater flexibility.

Prior to the change announced today, some VA community care specialty referrals were reevaluated every 90 to 180 days, increasing the likelihood of interrupted or delayed care.

"No Veteran should have their health care disrupted by red tape," said **VA Secretary Doug Collins.** "This change means better continuity of care, which leads to better health outcomes. It also improves convenience for Veterans and cuts administrative work for VA staff and community care partners."

With today's announcement, VA is now offering year-long community care authorizations for the following standardized types of care:

- Neuro-Ophthalmology
