8. The breeding season begins February 1, and ends July .1 Stallion agent guarantees live foal from the breeding contract herein. Live foal is defined as a foal that stands and nurses without assistance. a) It is agreed that if the mare owner does not get a live foal from this breeding, Stallion Agent shall give mare owner rebreed, for the following year only, to the same horse, for the mare originally booked (unless a substitute mare is mutually agreed upon). At the end of that breeding season, the right to rebreed is canceled and the Stallion Agent is released from any further obligation whatsoever. Any and all fees paid shall not be refunded. An additional booking fee in the amount set forth in paragraph, 1 above, must be paid for each re-breed conducted after the year of initial service. The mare owner is still responsible f o r collection, container, and shipping fees. b) If the mare proves to be barren, has a still born foal, aborts, or dies before foaling, the mare owner will contact the Stallion Agent within one week. Mare owner agrees to provide a statement from a licensed veterinarian. 10. In order for the live foal guarantee to remain in force and effect, the mare must receive Rhino vaccinations in a timely fashion according to recommendations of the mare owner's veterinarian. A "Breeders Certificate" shall be issued upon notification of the birth of the foal, providing all accounts have been paid in full by the mare owner. No Breeding Certificate will be issued until all fees have been paid. a) I agree that registration of the foal that comes from this breeding is my responsibility. 12. The owner of the mare hereby agrees to, and does, waive and release any and all claims against Rudd Quarter Horses, their agents, and employees arising from the breeding of mares pursuant to this agreement. 13.
