THAT'S WHY TAMKO PROVIDES A LIMITED WARRANTY FOR MANY PRODUCTS, THAT INCLUDES A BINDING ARBITRATION CLAUSE AND OTHER TERMS AND CONDITIONS WHICH ARE INCORPORATED HEREIN BY REFERENCE. The Mastercraft Limited Warranty Enhancement

for your Shingles: If all of the Eligibility Requirements set forth below are met, this Mastercraft Limited Warranty Enhancement is a supplement to TAMKO's Fiberglass/Asphalt Shingle Limited Warranty (the "Standard Limited Warranty"), the terms of which are incorporated herein. There is no charge to the building Owner for this enhancement. The versions of the Standard Limited Warranty and of the Mastercraft Limited Warranty Enhancement for shingles you purchase are the versions in effect on the date of retail purchase of the shingles. Information included in this version of the Mastercraft Limited Warranty Enhancement was current at the time of printing. Some words used in this Mastercraft Limited Warranty Enhancement have specific meanings which are defined in the Standard Limited Warranty. See the Standard Limited Warranty for definitions.

The Mastercraft Limited Warranty Enhancement enhances TAMKO's Standard Limited Warranty for eligible Shingles by:

Extending the Full Start™ Period during which both labor and materials are covered to 30 years;

Including the reasonable cost of tear-off, removal and disposal; and

Extending the time during which your Standard Limited Warranty with this Mastercraft Limited Warranty Enhancement may be transferred to a new owner to 10 years.

Full Start™ Period: The Full Start Period is the initial period of the Term during which TAMKO's obligation is not prorated and includes the reasonable cost of labor. If all of the Eligibility Requirements set forth below are met, the Full Start Period for Heritage Vintage, Heritage Premium and Heritage Woodgate Shingles is increased to 30 years. (In the Standard Limited Warranty, the Full Start Period is 10 years for Heritage Vintage, Heritage Premium, and Heritage Woodgate shingles.)

During the Full Start Period, TAMKO will provide a Material Certificate for replacement shingles to repair or replace Shingles with manufacturing defects which have directly caused leaks and a Labor Payment Certificate that may be used to pay the reasonable cost of installing replacement Shingles. In addition, during the Full Start Period, TAMKO will include in the Labor Payment Certificate the reasonable cost of tear-off, removal and disposal of Shingles with manufacturing defects which have directly caused leaks. The Standard Limited Warranty does not cover the cost of these items.

After the Full Start Period, TAMKO's obligation is limited to providing a prorated Material Certificate for replacement Shingles. Proration will be based on the remaining months in the Term of the Standard Limited Warranty. See the Standard Limited Warranty for complete details.

Transferability: The Owner of Heritage Vintage, Heritage Premium and Heritage Woodgate Shingles, meeting all of the Eligibility Requirements set forth below, may transfer the Standard Limited Warranty with this Mastercraft Limited Warranty Enhancement one time during the first ten years of the Term to a Purchaser. No other transfers are permitted. Only transfers following the procedures in the Standard Limited Warranty are permitted.

Except the extension of the Full Start Period, the addition of certain covered expenses during the Full Start Period and the extension of the period during which the Standard Limited Warranty may be transferred; all terms, contained in the Standard Limited Warranty applicable to Heritage Vintage, Heritage Premium and Heritage Woodgate Shingles shall remain the same. This Mastercraft Limited Warranty Enhancement does not modify or extend the terms of the Limited Wind Warranty or the Algae Cleaning Limited Warranty.

Eligibility Requirements: To be eligible for this Mastercraft Limited Warranty Enhancement, all of the following requirements must be met:

- (1) Heritage Vintage, Heritage Premium or Heritage Woodgate Shingles must be properly installed on a single or multifamily dwelling, building for religious services, condominium, school, office building, or multi-use structure. Buildings containing swimming pools or used for manufacturing, industrial, or agricultural activities are not eligible for this Mastercraft Limited Warranty Enhancement.
- (2) All roof components above the roof deck must be properly installed by a TAMKO® Pro Certified Roofing Contractor of the Owner's choice. However, TAMKO does not warrant the workmanship of TAMKO Pro Certified Roofing Contractors and is not liable for improperly installed roofs or Shingles.
- (3) Heritage Vintage, Heritage Premium and Heritage Woodgate Shingles must not be installed over existing shingles. Complete tear-off of previously installed shingles, underlayments and other roof components above the roof deck is required. Re-covers or roof-overs do not qualify.
- (4) Heritage Vintage, Heritage Premium or Heritage Woodgate Shingles must be properly installed over all roof planes of the building. Partial installations do not qualify.

(5) Your TAMKO Pro Certified Roofing Contractor MUST register the Mastercraft Limited Warranty Enhancement within 45 days after commencing the installation of the roof. It is the responsibility of the Owner and not TAMKO to ensure proper and timely registration.

THIS LIMITED WARRANTY ENHANCEMENT APPLIES ONLY TO SHINGLES INSTALLED IN THE FORTY-EIGHT CONTIGUOUS UNITED STATES AND CANADA (EXCLUDING QUEBEC AND NEW BRUNSWICK).

This form is not to be copied or reproduced in any manner. This Mastercraft Limited Warranty Enhancement is only available for Heritage Vintage, Heritage Premium and Heritage Woodgate Shingles sold on or after February 1, 2019.

Important note to property owners:

There is no additional cost for your Mastercraft Limited Warranty Enhancement. Your shingle installer is responsible for registering your Mastercraft Limited Warranty Enhancement within 45 days after installation. Upon receipt of the registration, TAMKO will notify you by letter to confirm that your Mastercraft Limited Warranty Enhancement has been registered and is in effect.

If your installer has submitted the paperwork, please call TAMKO at 1-866-982-3549 for official confirmation of its receipt. This is extremely important, as your Mastercraft Limited Warranty Enhancement will not go into effect until you receive written confirmation from TAMKO.

Note: If you are purchasing a new property, check with your installer to confirm if a Mastercraft Limited Warranty Enhancement has already been registered. In such a case, you must notify TAMKO in writing within 30 days after taking title to the property in order for the coverage to be transferred to you.
