## **Heading to the Pool – Summer is Coming Soon**

As the temperatures heat up and summer takes over, it's important to remember the <u>rules and regulations</u> of our community pool and spa. Here are some important highlights:

- Pool hours are 7 a.m. to 10 p.m. Sunday-Thursday; 7 a.m. to 11 a.m. Friday-Saturday.
- Residents visit and use the pool area at their own risk; owners and management are not responsible for accidents or injuries.
- The pool entry gate must remain locked before and after leaving.
- No glass containers can be used in the pool area.
- No pets are allowed.
- Children under 14 must be accompanied by an adult (over 18 years old) at all times.

In a related matter, the Jacuzzi was not heating properly and needed to be replaced. The cost of a new heater plus labor was approximately \$5,000.

## **Taking Care of Adobe Ranch Villas**

After residents' input at the annual board meeting, the landscape company was directed to clean up the common ground area on the south end of the community along 114<sup>th</sup> Street.

Residents also wanted the open area common ground near 114<sup>th</sup> Street back to a greener lawn area. The board had followed the Scottsdale City Council's recommendation that urged HOAs to forgo overseeding during the winter months, which would provide lower water bills, less lawn maintenance and increased water conservation. The board will review the situation to see how much it would cost to reinstate overseeding.

# **Budgetary Issues**

At the annual meeting, the board approved the Financial Report.

The Adobe Ranch HOA Balance Sheet as of 3/31/2025 is as follows:

- Total Assets \$49,724.14
- Total Liabilities \$6,526.00
- Total Equity \$43,198.14

The board is waiting on the reserve study which provides information on the upcoming costs of maintaining our assets such as pool and street repairs and unit painting. It allows a community to knowledgeably fund future repairs on a monthly basis so that monies are available when major repairs are needed.
