Street Repair Coming to Adobe Ranch Villas

We will be undergoing repairs to our streets sometime in early 2026. The board and our HOA management company are reviewing bids from three paving contractors to clean and seal all major cracks, clean the entire asphalt surface, and apply a seal coat over the entire street.

Once a decision has been reached on the particular contractor, we will work out the traffic details regarding street closure during the repair process. We then will communicate the final date and all the details concerning the project.

Budgetary Issues

The board received the reserve study for the HOA's budget, which was prepared by Advanced Reserve Solutions Inc. The results will be discussed at our next board meeting.

A reserve study provides information on the upcoming costs of maintaining our assets such as pool and street repairs and unit painting. It allows a community to knowledgeably plan future major repairs.
