## Section 3: Terms and Conditions

All invoices and statements will be sent by email. No paper copy will be mailed.

All charges are due upon receipt. A finance charge of  $1\,1/2\,\%$  will be assessed if charges are not paid within thirty (30) days.

The following charges will apply when applicable (current rates available to customer upon request):

- \* A non-taxable winter service rate will be charged from November 1st through March 31st each year.
- \* A short load fee for less than six-yard deliveries will be charged.
- \* Customer shall be allowed 1 hour maximum to unload a truck, an additional fee shall be assessed if customer exceeds the unload time.
- \* Delivery after 4:00 p.m. and on Saturday shall have an additional charge assessed.
- \* Fuel surcharge may be assessed if the price of diesel fuel exceeds \$3.00 per gallon.

The materials supplied become the property of the purchaser once they have been loaded into the mixer truck at the plant. Purchaser has the option to perform any product testing at the plant on or before the day of delivery. Once the product is delivered to the curb line Purchaser is responsible for placement, curing, and protection of the concrete. The Seller is not responsible for any product performance after placed by the Buyer.

Purchase is for delivery to a curb line. If the point of delivery takes the truck off the roadway, Purchaser agrees to assume responsibility for any damage to the property, sidewalks, driveway, landscaping, as well as any personal liability that may result for delivery beyond the curb line. Purchaser specifically agrees to hold Seller harmless against any liability incurred as the result of the delivery request, including, but not limited to: damages and expenses incurred by the property owner as well as reasonable attorney fees and costs incurred by Seller in defense of any such claim.
