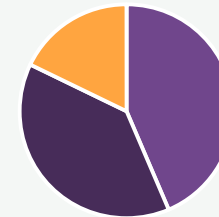

Americans Are Concerned About How Much Personal Information Online Advertisers Know About Them

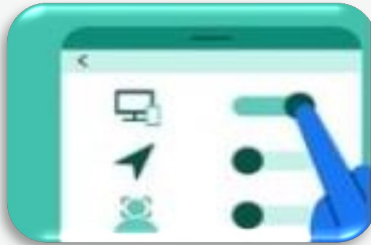

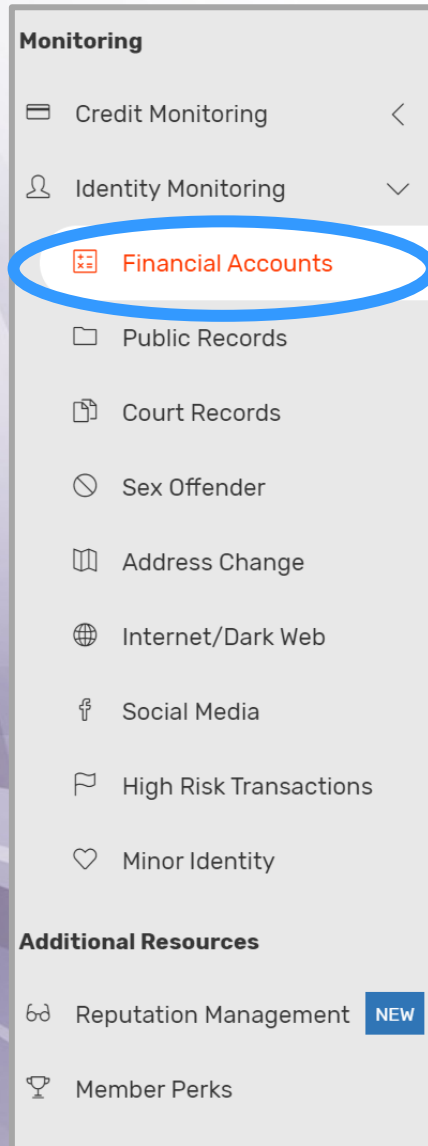
Reputation Management:

- Searches your **social media accounts** for existing content that could be damaging to your online reputation. We can even help locate your old accounts that you may have forgotten and identify high risk posts, giving you the chance to review and remove the content.: **Facebook, LinkedIn, Twitter, Instagram and more.**
 - Posts, comments, and some images that contain harmful language and images are flagged for review.

Reputation Score:

- Ranks a user's online **reputation risk by calculating a score** based on content and images found in their social media accounts.
- Posts that negatively impact the score are flagged for review.

Financial Account Monitoring

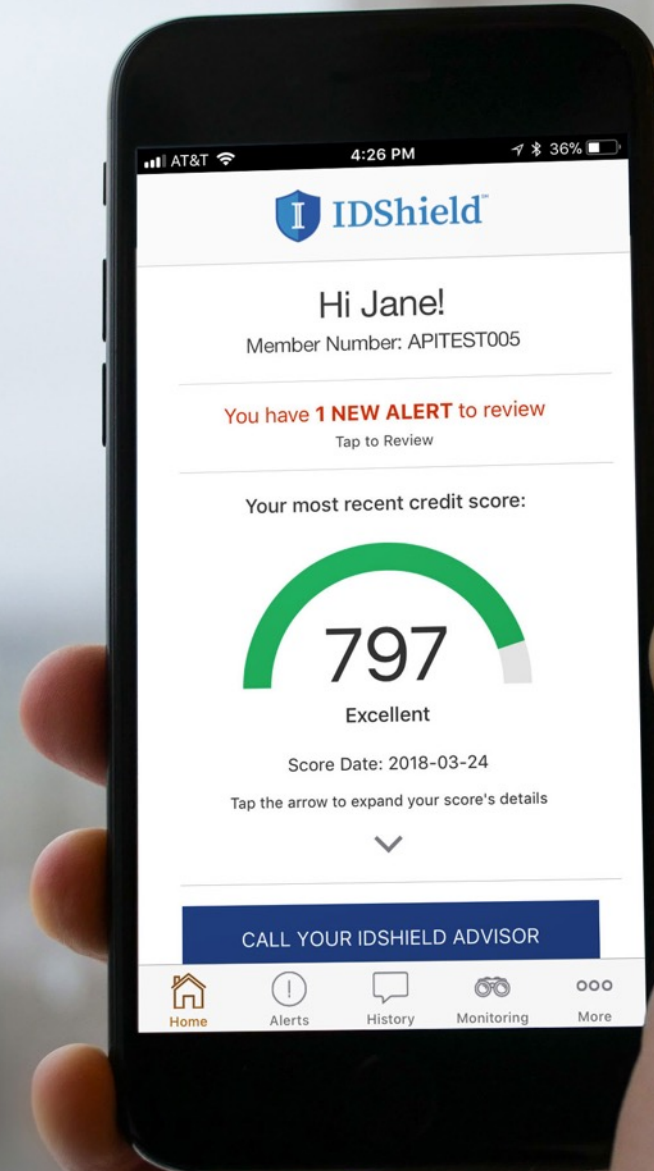

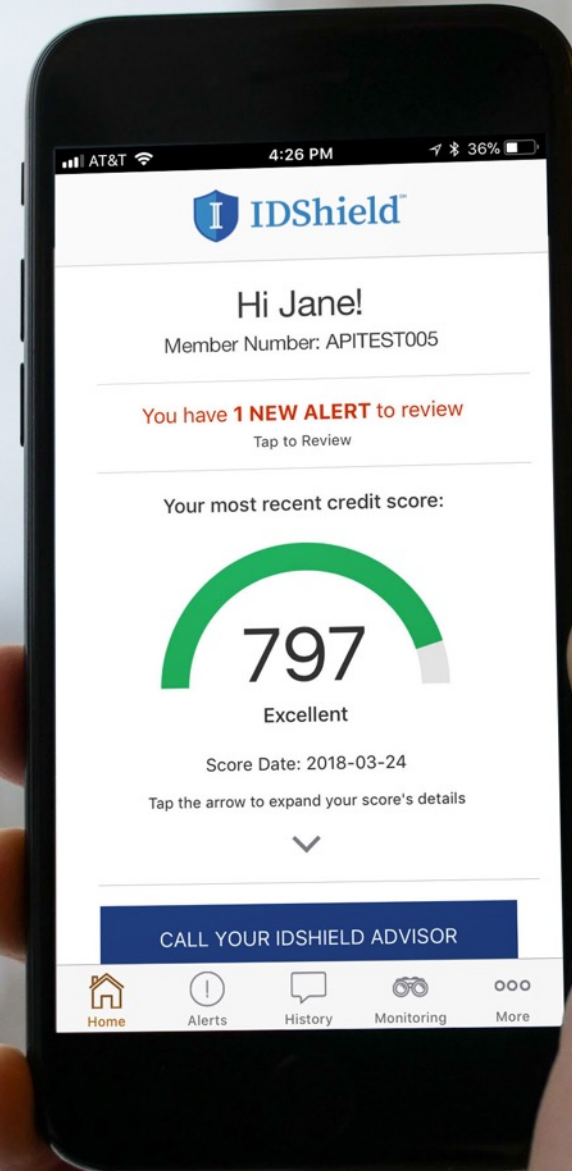

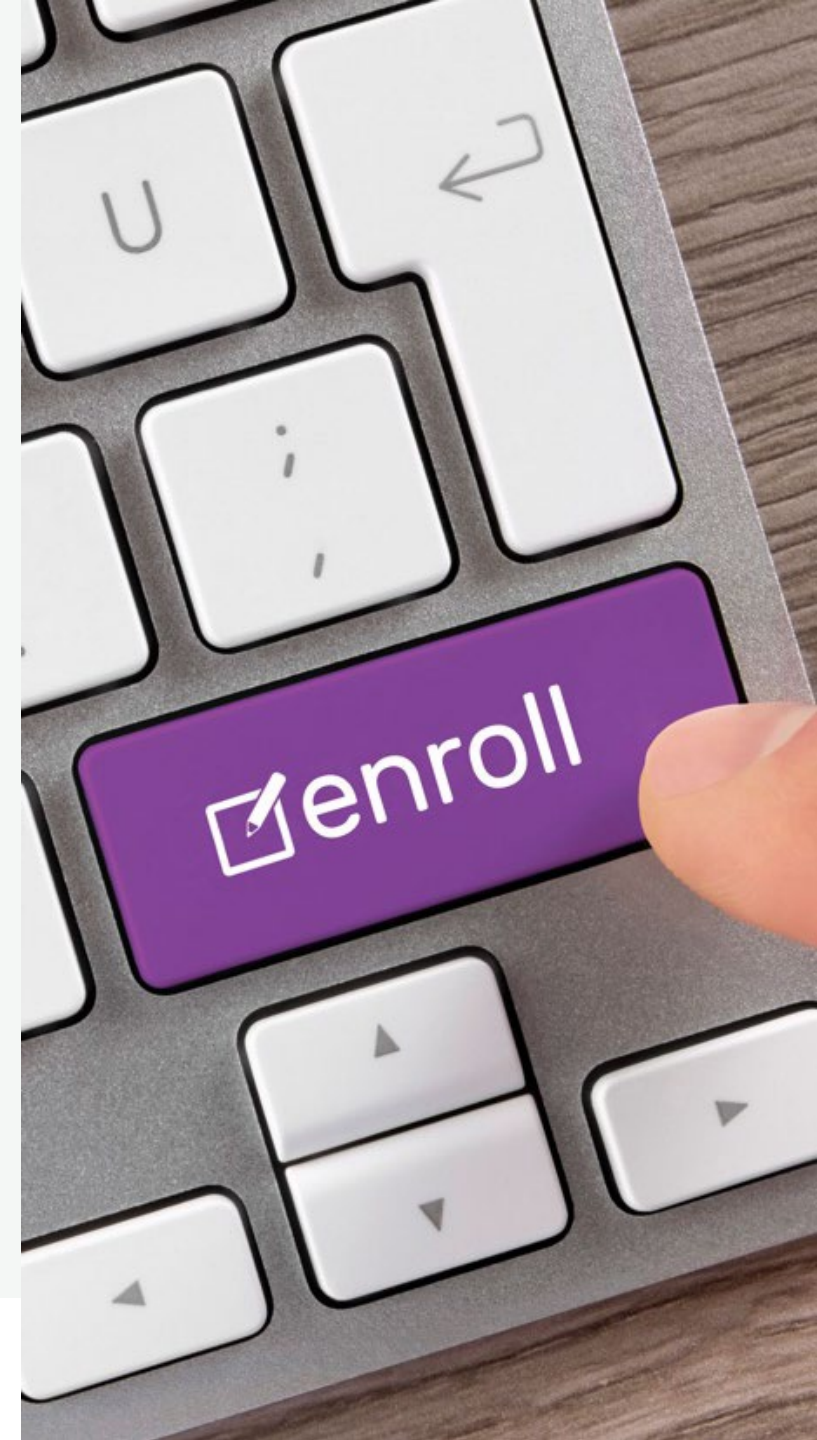
