## **Tournament System: -**

- i. The tournament will be played under the Swiss System of league governed by latest FIDE rules for chess.
- ii. Each session will be of 15 minutes + 10 seconds increment from the first move.
- iii. FIDE Tie break Rule should be applied
- iv. Protest if any, can be made within 15 minutes from the completion of the games along with a protest fee of Rs.2000/ which is refundable if protest is upheld.
- v. The decision of Appeals committee will be final and binding to all.
