# The FEMA Fast-Track Program

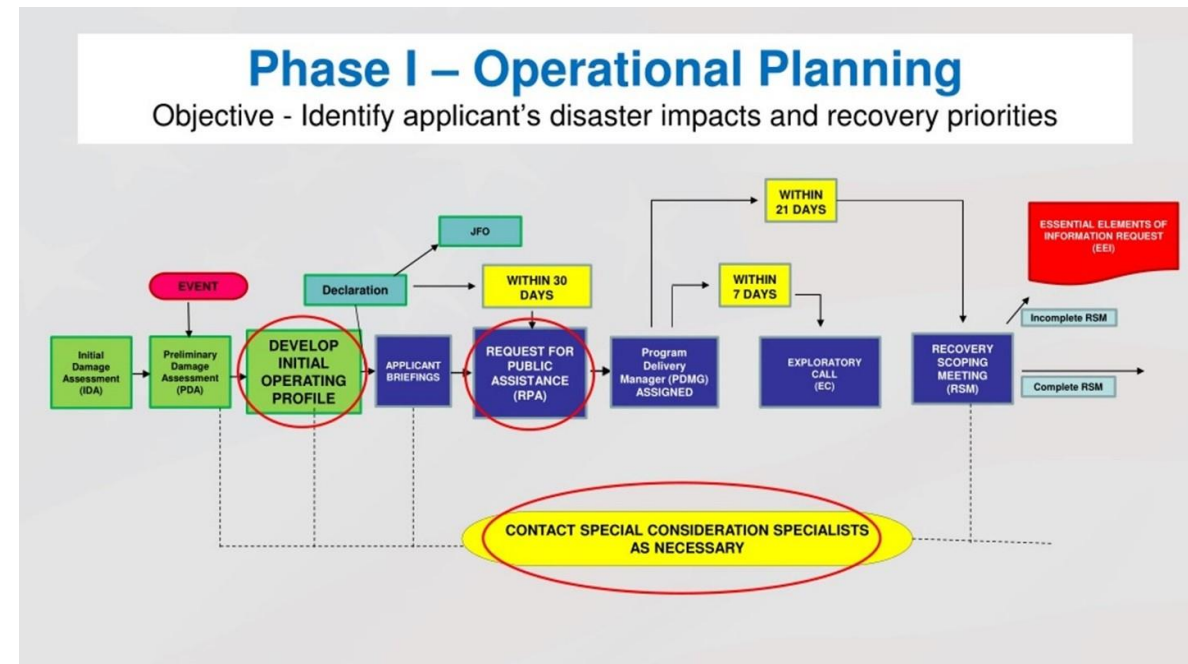

# Phase I: Operational Planning

We assist you with initial FEMA contact through a Request for Public Assistance and will accompany you to the initial FEMA interview at the Recovery Scoping Meeting.

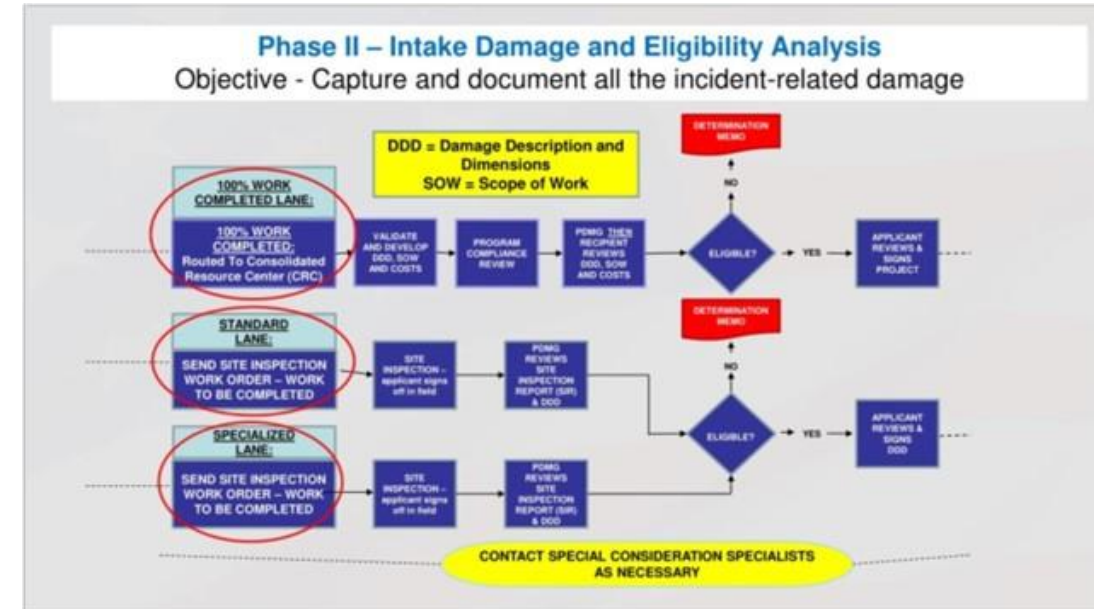
Throughout Phase 1, we help you identify disaster damage, gather necessary documentation, walk you through the FEMA Grants Portal, and determine project priority.



# Phase II: Intake Damage and Eligibility Analysis

Phase II reviews determinations and documentation to ascertain projects in 3 lanes:

- Completed Lane, 100% work completed
- Standard Lane, core majority of projects
- Specialized Lane, typically Alternative or Improved projects

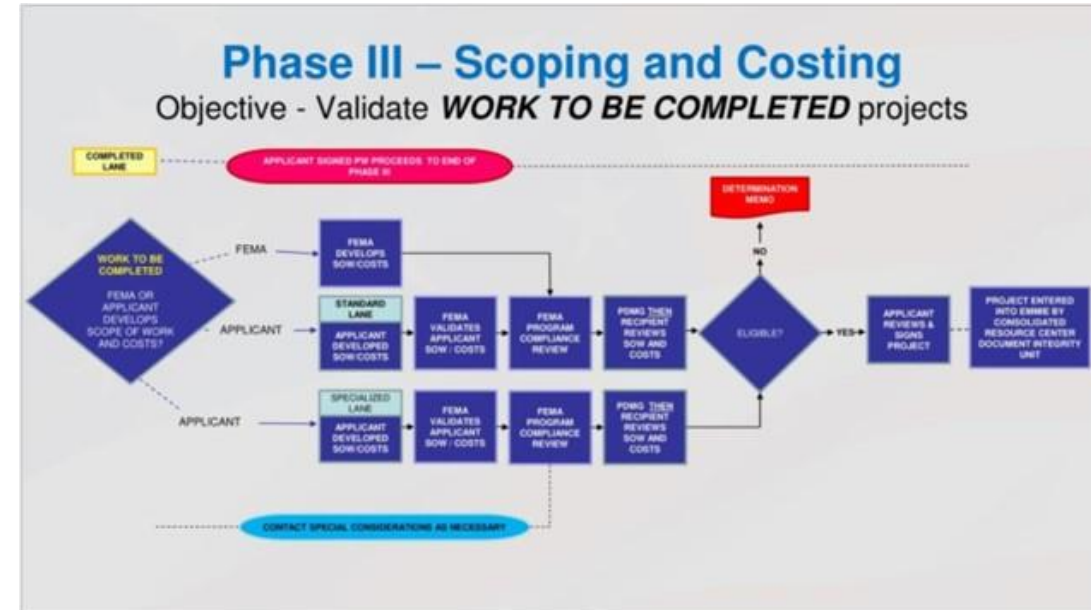




# Phase III: Scoping and Costing

Phase III's intention is to validate work to be completed on each Project Worksheet (PW) at the Consolidated Resource Center (CRC). This phase will:

- Determine Small and Large Projects
- Estimate Project Cost
- Develop Damage Description and Dimensions (DDD)
- Develop Scope of Work (SOW) to include Ancillary work, etc.

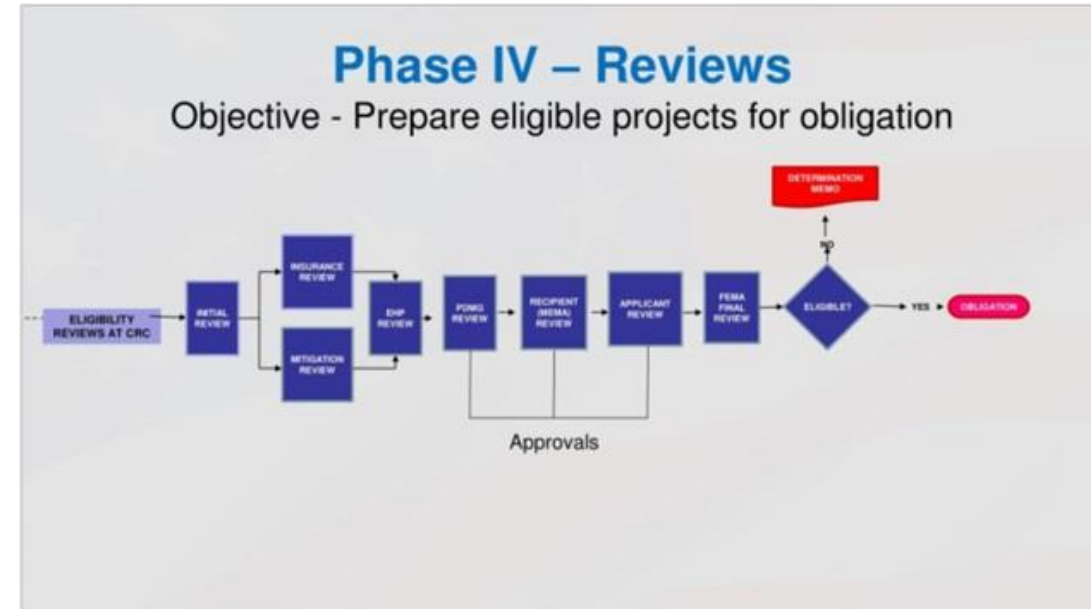




# Phase IV: Reviews

Phase IV prepares projects for the obligation of funds. We work proactively to address any potential questions with the FEMA PDMGs to ascertain and expedite final eligibility, to include insurance, maintenance records, and any other pertinent documentation.

Processes in Phases II through IV also include amendments to add scope and funding to projects.



# Mitigation Planning

Mitigation planning often involves navigating complex regulatory requirements and accessing federal funding. Our team of experts possesses in-depth knowledge of FEMA policies, guidelines, and grant programs.
