Other lies & red flags:

- 1- AM told LE only 2 tire tracks were his. New story: MM drove through there when she got home, he & Paul rode the property using 2 different trucks earlier, AND he drove the golf cart up there.
- 2- Towel in the driver's seat
- 3- The timeline for the next morning DOES NOT add up
- 4- Shelly said she saw AM up later, said he was looking for his glasses bc he couldn't sleep.
- 5- John Marvin got a ride there from Greg Alexander, a police chief that Alex has paid money to over time, including \$5000 shortly after the murders.
- 6- A whole group of lawyers KNOW BETTER than to be messing up a crime scene and destroying potential evidence
- 7- Alex has lied about everything, but now wants us to believe him instead of Jeanne, Shelly, Blanca, Mark Tinsley, and pretty much everyone else who testified.
- 8- Why did his key card open PMPED door the next morning at 9 am
- 9- Said he didn't remember his last talk with MM, but then when Creighton mentioned that again in testimony he changed his story and said he does remember.
