HVMH operates 8 adult outpatient behavioral health clinics in the Hudson Valley region and has a staff of dedicated professionals offering care and support to those who need it.

HVMH staff includes licensed therapists, nurse practitioners, registered nurses, and psychiatrists.

HVMH provides a full array of outpatient clinical treatment including individual and group psychotherapy as well as medication management.

All HVMH clinics are licensed by the New York State Office of Mental Health and are partially funded through contracts with the Dutchess County Department of Behavioral & Community Health and the Ulster County Department of Mental Health.

By offering quality behavioral health care services, we help people make positive changes in their lives.

HVMH provides quality behavioral health services

Person-centered & evidence-based treatments proven to be effective including Cognitive Behavioral Therapy & Dialectical Behavior Therapy.

HVMH provides clinical support to the Re-Entry Supportive Transition and Reintegration Track (RESTART) in the Dutchess County Jail, which is an innovative program targeting high recidivism rates for incarceration. RESTART is a partnership with the Dutchess County Department of Behavioral & Community Health and Project M.O.R.F.

HVMH is also developing Home & Community Based Services (HCBS) such as:

- Community Psychiatric Support & Treatment
- Psychosocial Rehabilitation
- Empowerment Services & Peer Supports
- Family Support & Training
