



Gaia's Library Book Club

Terms & Conditions

1. You are committing to an ongoing 4-monthly agreement with Gaia's Library. You will receive a book box for the 1st of each month after you start your initial payment. Every 4 months your subscription will be renewed in the same method you signed up in, unless you cancel your renewal in advance. To cancel your subscription, you must give a minimum of 45 days notice, as we buy the goods in advance based on subscribers.
2. You can change your delivery details or payment details. Simply email us at team@gaiaslibrary.co.uk. After your initial payment, from the following payment your Direct Debit will be taken between the 8th-10th of the month (unless otherwise agreed).
3. The Gaia's Library Beautiful Book Club box can only be delivered to valid Mainland UK addresses.
4. By signing up to Gaia's Library Book Club you are agreeing that you are aged 18 or over and agree to receive information about the book club and your subscription via email.
5. The Gaia's Library Beautiful Book Club has been designed for you to enjoy and engage with like-minded individuals. However, you can enjoy reading your book at your own leisure or however you like. The Book Box cannot be exchanged or refunded, even if you have already read or have a copy of the book.
6. You agree not to reproduce, duplicate, copy, sell, resell or exploit any portion of the books, Book Club, use of the Book Club, or access to the Book Club or any contact on the website through which the Book Club is provided, without express written permission by us.

7. Prices for The Gaia's Library Beautiful Book Club are subject to change. We will give a minimum of 30 days' notice before making any changes to your Direct Debit.
8. The Gaia's Library Beautiful Book Club payments are taken via Stripe and can be paid in two ways. (1) 4-month full payment upfront at a discount. (2) 4-month agreement with payment taken each month.
9. You may cancel your original subscription by notifying us at team@gaiaslibrary.co.uk within 14 days of signing up. A full refund will be provided as long as no products have already been shipped. If any have been, then a pro-rata refund will be provided.
10. We reserve the right at any time to modify or discontinue the Book Club (or any part or content thereof).
11. We shall not be liable to you or to any third-party for any modification, price change, suspension or discontinuance of the Book Club.
12. You agree to provide current, complete and accurate account information for all Direct Debits and payments set up. You agree to promptly update your account and other information, including your email address, postal address and bank details, so that we can complete your payments, delivery and contact you as needed.
13. If, at our request, you send certain specific submissions (for example contest entries) or, without a request from us, you send creative ideas, suggestions, proposals, plans, or other materials, whether online, by email, by postal mail, or otherwise (collectively, 'comments'), you agree that we may, at any time, without restriction, edit, copy, publish, distribute, translate and otherwise use in any medium any comments that you forward to us. We are and shall be under no obligation (1) to maintain any comments in confidence; (2) to pay compensation for any comments; or (3) to respond to any comments.
14. You agree that your comments will not violate any right of any third-party, including copyright, trademark, privacy, personality or other personal or proprietary right. You further agree that your comments will not contain libelous or otherwise unlawful, abusive or obscene material, or contain any computer virus or other malware that could in any way affect the operation of the Book Club or any related website. You may not use a false email address, pretend to be someone other than yourself, or otherwise mislead us or third-parties as to the origin of any comments. You are solely responsible for any comments you make and their accuracy. We take no responsibility and assume no liability for any comments posted by you or any third-party.

We may, but have no obligation to, monitor, edit or remove content that we determine in our sole discretion may be unlawful, offensive, threatening, libelous, defamatory, pornographic, obscene or otherwise objectionable or violates any party's intellectual property or these terms and conditions.

16. We reserve the right, at our sole discretion, to update, change or replace any part of these Terms and Conditions by posting updates and changes to our website.
