



## Vancouver Island RV Rentals – Rental Agreement

This Rental Agreement (“Agreement”) is made between **Vancouver Island RV Rentals** (“Company”) and the undersigned renter (“Renter”). By signing this Agreement, the Renter acknowledges, accepts, and agrees to all terms and conditions set forth below.

---

### 1. Eligibility and Authorized Users

- Only individuals **25 years of age or older** may rent the RV.
  - The Renter affirms possession of a valid driver’s license.
  - No person(s) other than the Renter and any additional approved occupants may occupy the RV. (immediate family automatically approved)
  - Pets allowed
- 

### 2. Rental Period, Return Time, and Condition

- The RV must be vacated **no later than 11:00 AM** on the scheduled return date.
  - Late vacancies may result in additional charges.
  - The RV must be returned in the same condition in which it was received, subject only to normal wear.
- 

### 3. Fees and Mandatory Charges

- **\$250.00 Setup and Fuel Surcharge** apply to every rental.
  - **\$250.00 Cleaning Fee** will be charged if the RV is returned in a condition other than the condition in which it was received. **Tidy, Dishes Cleaned and Swept out is acceptable.**
  - Vancouver Island RV Rentals assume cleaning to our standards will be necessary and performed by our staff)
  - The Renter is responsible for the **full replacement cost of any accessories, equipment, or components** damaged, lost, or destroyed during the rental period, including but not limited to hoses, cords, leveling blocks, kitchenware, linens, and outdoor accessories.

#### 4. Liability, Damage, and Indemnification

- The Renter assumes **full financial responsibility** for all damage to the RV, its components, or any third-party property occurring during the rental period, regardless of fault.
  - **The Company is not liable for injuries, accidents, loss of personal property, or damages arising from the Renter's use, operation, or occupancy of the RV.**
  - The Renter agrees to **indemnify, defend, and hold harmless** Vancouver Island RV Rentals, its owners, employees, and agents from any claims, demands, losses, liabilities, injuries or expenses arising from:
    - Operation or use of the RV
    - Violations of law
    - Accidents or collisions
    - Improper or unsafe use of equipment
    - Personal injury or property damage

#### 5. Prohibited Uses

The RV may not be used for:

- **Subleases**
- **Storage of illegal substances**
- **Towing without written authorization**
- **Smoking or Vaping inside the RV**
- **Outdoor footwear inside RV**
- **Any use outside of normal camping activities**

Violation of these restrictions may result in immediate termination of the rental and additional charges.

---

#### 6. Mechanical Issues and Repairs

- The Renter must notify the Company immediately of any mechanical issues.
- Unauthorized repairs are prohibited unless expressly approved by the Company.
- The Company is not responsible for loss of vacation time, inconvenience, or incidental expenses resulting from mechanical failure.

---

## 7. Security Deposit\Cancellation Policy

- A security deposit of **\$500.00** is required and may be applied toward damages, cleaning fees, late fees, or any other charges incurred under this Agreement.
- Any remaining balance will be returned after inspection.
- Reservations can be cancelled 30 days prior to your check-in date. All deposits and fees will be returned to the (renter) on cancellation of the agreement.

## 8. Governing Law

This Agreement is governed by the laws of the Province of British Columbia. Any disputes shall be resolved exclusively within the courts of British Columbia.
