1. <u>Introductions</u>

2. Secretary's Report

The minutes from the April meeting were reviewed and accepted with one correction to the chair for the Grounds and Maintenance Committee.

3. Treasurer's Report

- All appropriate records.have been received by Cookie Burget.
- Report provided for Cookie.
 - Checking account balance of \$3,314.30.
 - Savings account balance of \$39,410.49.
- Two bills were paid this time (Bonding of officers and Delmarva Power lighting bill).

4. Grounds and Maintenance Committee

- Open item Trees for Lexington Parkway
 - Norm Spector has information on State Tree Grants not available at the meeting
 - Determine if Clean Cutt would maintain them (trim and water) still open
 - Any trees would need to have roots that grow down and not out (damage to street)
 - Norm will get someone to speak at the next meeting still open
- Open item Rose Hill sign
 - Can this be moved closer to Rose Hill (some confusion) DelDOT must make any change in location.
 - Dave or Norm to speak with our representative (Vince Lofink) to see if he can help. Norm committed to speak with someone on Vince Lofink's staff.
- Open item Cracks in street asphalt
 - In several places there are cracks running parallel to the grass line J. Kilpatrick is the contact for specs
 - Concern about a potential sinkhole along Lexington Parkway.
 - Need to contact DelDot. Open item, need to discuss street re-pavement.
- Closed Question concerning mapping of sewer system to see if anyone has a sump pump hooked into the sanitary sewer system. — It is illegal to attached sumps to sanitary sewer.
- Open item Need to follow up with Vince Lofink about potential walking path. Open item for Dave.
- Open item Traffic remediation
 - Rose Hill traffic circles are now marked in some areas
 - Clairborne has turned down proposals from DelDot for remediation on Lexington Parkway. Suggestion that we request four-way stops at the two intersections on the road.

5. Architectural Committee

- No architectural or deed restriction issues were raised.
- A set of plans was submitted to the PO Box. These were forwarded to Mike Hudson for approval.
- Reminder that contact information for this committee is published here and on the web page.

6. New Business

- Concern was raised about parking at the corner of Airdrie Drive and Lexington Parkway in the morning while dropping off students for busses. Numerous schools use this intersection as a drop point. Everyone should take caution to make sure we are not impeding traffic or creating a hazard at this intersection.
- Those in attendance supported regular treatment of the open space (weed and feed) to avoid the spread of weeds to other properties in the neighborhood. The Grounds and Maintenance committee to schedule as needed.
- A question was raised concerning noise complaints. These should be called into the Count Complaints Office. All should be aware that fines have gone up for violations of animal control and noise. Citations for excessive animal noise start at \$250.
- It was reported that a break-in occurred in the neighborhood earlier this year. Some discussion was held about creating a neighborhood watch and contact with the New Castle County Police Department.
