3. Treasurer's Report


- Reports provided by Cookie.
 - Checking account balance of \$2,426.92 as of 03/07/2006.
 - Savings account balance of \$43,478.43 as of 02/28/2006.
 - No bills due for payment.
- Banking options discussed. Our accounts are held at Wilmington Trust and the money market account is not accruing a great deal of interest. This would increase if we opened an Internet banking account. Item to be discussed further once more background information is gathered.
- As of the April 10, 205 households paid the 2005-06 assessments with 10 remaining. The Due date was October 15. Four (4) households are in arrears from 2004-05 (and before). Third notices sent by certified mail. Reminder:

Per our by laws <u>YOU</u> are personally liable for the payment of assessments together with interest and costs of collection and they remain a continuing lien on <u>YOU</u> until the assessment payment is made.

4. Grounds and Maintenance Committee


- Open item Trees for Lexington Parkway Faith Devitt will move forward with this issue.

- Open item Rose Hill sign
 - It is confusing as to where their sign is located.

- Street lights repairs and replacement of lenses

- The Maintenance Corporation must coordinate replacement of lenses; Delmarva will not accept requests from residents.
- Open item Walkways
 - This may be funded through street fund allotment. Discussion needed with Vince Lofink's staff.
- Open item Traffic remediation
 - Board to determine WHO has the background on four-way stop signs and further action.
- Damage to aprons was raised again. Aprons are a DelDOT issue, not covered by Maintenance Corporation funding. **POST MEETING NOTE**: Residents are again encourage to take special caution when parking at Lexington Parkway and Airdrie Drive, both to ensure the safety of students being dropped off and to minimize property damage due to cars pulled to the side of the road.

5. Architectural Committee


- Request to repaved driveway with pavers denied.
