#### 3. Treasurer's Report

Board discussed the following: to allow the procedure in the by-laws regarding applying interest and other appropriate fees (postage and handling) to the accounts of homeowners in arrears. It was agreed that a yearly fee of 8.0% (Federal Discount rate of 3.0% plus 5.0%) be charged and a miscellaneous fee up to a maximum of \$100. #### 4. Elections

Of 215 houses, 160 responded with 158 "Yes" votes for the budget and 2 "No" votes Four homeowners nominated a person for the vacant seat (with one vote each for Briscoe, Moore, Quickle, & Wright). The board voted unanimously to select Bev Wright to join the board. Board voted the following officers for the 2019-2020 year:

#### 5. Old/New Business

Cookie noted that the signs for the Rt. 896 road construction had been removed by the contractor, Mumford & Miller, but the holes not properly filled in, leaving holes which were a safety hazard. Cookie called M&M office to complain. They will come back to fill the holes within the next two weeks.

Rich Boyer filed complaint with NCC Complaints department, regarding some deed restrictions in our community. Inspectors came out and verified the issues. Homeowners were contacted and the violations were resolved.

There remain several deed restriction issues including a work trailer in someone's driveway along Eaton Place.

It was requested that a "No Soliciting" sign be added to the entrance sign. This will be evaluated by Rich and Jim in the coming months.

The wooded area along the walkway on Lexington Parkway past the open space needs attention, Work to be determined in early spring by the Grounds & Maintenance Committee. It will likely be necessary to use an arborist to help properly cut back the trees and undergrowth.

The main swale along Denny Road needs attention due to some collapse of the ground. Rich or Cookie to first contact DENREC to help determine the extent of the work that will be needed. Bids will then be sent to several contactors to determine the cost to repair.

The edging around the entrance sign is coming up and needs to be repaired or replaced.

The meeting adjourned at 7:40 p.m.
