5. Grounds and Maintenance Committee

- Estimate from Sacco Lawn Care: Lawn mowing will cost \$8,265.00 this year providing service every seven days in the springtime and every 10 days at the height of summer for \$345 a cut.
- The trees will be trimmed near the sidewalk long Lexington.
- There are beaver dams along near Airdrie Drive and Route 896.
- Clairborne sign maintenance will be accomplished with some polish to the gold lettering as has been done in the past.
- The DeLoozes have volunteered to tend the center island near the entrance. A motion was made and seconded for funds of \$100 for mulch and plants, however no vote was taken. Phone vote?
- Possible neighborhood clean-up on April 22nd, Earth Day, was suggested.
