Rich called the meeting to order, held at St. Margaret of Scotland, at 7:08 p.m.

#### 1. Introductions

There were 12 attendees: four board members, seven neighbors and one senator.

#### 2. Legislative Update

Senator Hansen gave an account of legislation recently considered and/or passed and her work on it.

- Bill passed to make public dangerous intersections and crash results. DelDot is building a portal for the public to view the data.
- Noise reduction study by RK &K consultants concluded that the noise levels on Airdrie Drive are not cause for action. Sixty-six decibels is the figure above which action is taken. Measurements of 59 and 58 were the highest recorded. [Note: Loudness increases logarithmically, so 66 is considerably louder than 59.] Noise can be decreased using different pavement and with the reduction of speed of traffic on 896. Have other communities complained or taken action about the noise?
- Further discussion of drag racing on route 896 and what can be done about it. Senator Hansen will discuss speed monitoring with the State Police.
- Speed limit has been reduced on Old 896, with discussions on two new traffic circles to better enforce the reduction.
- Speed hump study and ballot within Clairborne: Balloting shows that the neighborhood does not want the speed humps. Was there a figure for average speed along Lexington parkway? Is the

proposed traffic circle at the corner of Airdrie and Lexington coming to fruition? Could it be moved to the corner of Pegasus and Lexington? Senator Hansen will check.

- A preserved natural wetland area is in the works. Studies will be done to determine plant and animal life in these areas. Only a small portion of Clairborne impinges on this area.

On October 26<sup>th</sup> there will be a Town Hall meeting in regard to improvements on Old County Road.

Hearings on re-districting will be online on the following days:

October 18<sup>th</sup> Representative maps

October 19th Senatorial maps

This will allow redistricting a full year before the next elections.

A lien was placed against the property, with NCC Recorder of Deeds. Additional liens will be place against the property as warranted. The owner is now 4 years in arrears.
